This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.	None
Contracts	
Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest <sup>4</sup> ) and the Council —  (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.	None
Land

**<sup>5</sup>** "land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

Corporate tenancies	
Any tenancy where (to your knowledge)— (a) the landlord is the Council; and (b) the tenant is a body in which you or your partner has a beneficial interest.	None
<u>Securities</u>	
Any beneficial interest in securities <sup>6</sup> of a body where—  (a) that body (to your knowledge) has a place of business or land in the area of the Council; and  (b) either—	None
(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or	None
