Summary End Of Year Progress Update**

<b>Develop policy and strategy for the area through the AONB Management Plan, and influence the policies and strategies of others</b>	
<b>AONB Management Plan</b>	The <a href="#">Plan</a> was approved by Telford & Wrekin Council on 11 May 2009. Printed Plans distributed in June (c270 copies mailed), with good feedback. Formal notifications to Defra, etc have been completed. The final <a href="#">Sustainability Appraisal Statement</a> was completed and published. This has resulted in a constructive response from the Countryside Council for Wales on ongoing cross-border working, and a meeting is planned.
<b>Planning</b>	<a href="#">Comments</a> made on the West Midlands Regional Spatial Strategy Phase 3 options and Shropshire Core Strategy Policy Directions. <a href="#">Comments</a> have been made on 10 planning applications (7 objections). Renewal of the AONB <a href="#">Planning Protocol</a> in progress with the local authorities.
<b>Other strategies</b>	<a href="#">Input</a> provided to Commission for Rural Communities Uplands Enquiry, Severn River Basin Management Plan, Shropshire Cultural Strategy, Shropshire Sustainable Community Strategy and Natural England draft Protected Landscapes policy.
<b>Local authorities and local strategic partnerships</b>	Good links established with new hosting department (Shropshire Council Development Services Directorate) - meeting with Portfolio Holder, links especially with Environment, Planning Policy and Economic Development. Input to training for new Community Regeneration Officers. Continued close links with Biodiversity Partnership and with Transport. Links with Telford & Wrekin Council through Management Plan and planning. Active input to Southern Shropshire Partnership and its Delivery Groups for Environment, Economy & Learning, Health & Wellbeing.
<b>Guidance &amp; strategy</b>	Input to <a href="#">Natural England-led climate change adaptation work</a> and Shropshire Council Climate Change Adaptation Action Plan.
<b>Take and co-ordinate action to conserve and enhance natural beauty, promote enjoyment, understanding and wellbeing and further sustainable development</b>	
<b>Support / advise projects</b>	An active role has been played in 51 project steering groups, working groups, partnerships or research initiatives. Support also given to a further 44 groups or projects led by others, including on landscape, conservation, farming, access, tourism and interpretation.
<b>Sustainable Development Fund</b>	Support and grants totalling £65,429 awarded to 23 <a href="#">projects</a> .
<b>LEADER</b>	<a href="#">Local Development Strategy and Business Plan</a> approved 7 May 09. Formal contract with Advantage West Midlands signed 17 Sept 09. Grants to 11 projects approved, totalling £425,589 (£40,132 paid to 4 projects). Strong input has been made to the West Midlands LEADER and RDPE networks, including development of W Mids LEADER Operating Handbook.
<b>'Buy Local'</b>	Shropshire Hills Sustainable Business Scheme now at 78 members. Sustainability Toolkit and 'Sense of Place' material distributed to members. <a href="#">Commercial waste recycling study</a> completed with Keele University. Graduate work placement working on contact for membership renewal. Member champions active and 5 marketing training events held, plus 3 networking/ social events. <a href="http://www.shropshirehillsbuylocal">www.shropshirehillsbuylocal</a> website updated – features 159 businesses.
<b>Rivers Project</b>	60 farm visits undertaken for river management advice. Practical works undertaken at 9 sites and preparation further 10 sites. All landowners at River Clun SAC pearl mussel site will soon be in an environmental agreement. Led or contributed to 6 events, attended by total of over 125 people. Close involvement with national summit group on freshwater pearl mussel. Teme <a href="#">Rivers 'Water Friendly Farming' leaflet</a> published and distributed.

<b>Farmer engagement</b>	Report and <a href="#">case study</a> published on Spring 2009 pilot project. Phase 2 completed, with 21 further visits in Clee Hill area, and follow up contact with 35 from Phase 1.
<b>Offa's Country</b>	' <a href="#">English-Welsh Border Regeneration Strategy</a> ' produced by consultants, funded by AWM, Natural England and the Welsh Assembly Government and managed by the AONB Partnership on behalf of a wider group. The project was a major focus of the West Midlands Regional Assembly/ Welsh Assembly Government Cross-Border Working event held at Newtown on 2 April 09. Funding bids made for Offa's Country Sustainable Tourism project, jointly with Wye Valley & Clwydian Range AONBs and Brecon Beacons National Park.
<b>Woodlands Project</b>	Brian Barker appointed to Project Officer post, started 21 September. 20 woodland advice visits and 4 Management Plans completed (total 63 ha). 20 businesses visited and advice reports prepared through the Woodland Enterprise Grant scheme.
<b>Shropshire Hills Shuttles</b>	Overall 2009 passenger numbers were 8,123 (up 19% on 2008), but income was reduced due to changes on concessionary fares. 2010 service procured and publicised with new leaflet and updates to <a href="#">website</a> . 2 familiarisation events held for VIC staff and tourism businesses.
<b>Promotion</b>	The 2009 Shropshire Hills Events programme and visitor guide was reprinted due to demand, and widely distributed. The <a href="#">2010 Events &amp; Visitor Guide</a> was published in March (40,000 print run). 'Car-free walks' category added to <a href="#">Shropshire Walking website</a> . <a href="#">Blue Remembered Hills Bridleway</a> route fully publicised. 22 AONB-led events have been attended by a total of 445 people, and a further 11 AONB-supported events attended by 350 people. 26 <a href="#">press releases</a> and 2 <a href="#">E-bulletins</a> have been issued. <a href="#">2008-9 Annual Review</a> published, with increased distribution.
<b>New project development</b>	Proposal for a <a href="#">Stiperstones – Corndon HLF Landscape Partnership Scheme</a> . Steering group formed with further consultation events planned for 2010. Bid made for 'Natural Assets' funding for Sustainable Tourism Strategy. Proposed 'Discover Local' project based on wild and foraged foods.
<b>Business Advice clinics</b>	7 clinics hosted and organised at AONB Office for Business Link, Natural England and RDPE Rural Enterprise Grant advisers. 49 businesses seen (20 farm businesses and 29 other businesses)
<b>Support the operation of the AONB Partnership as an inclusive and effective organisation</b>	
<b>Partnership and sub-groups</b>	43 meetings have been held of 16 groups within the Partnership structure. 4 new Shropshire Council member representatives appointed. New <a href="#">Terms of Reference</a> refined and expected for Council approval May 2010. Membership review completed with 3 new Individual and 2 new organisation members, new Chair and 2 new Vice Chairs. Strong links maintained with the <a href="#">Wrekin Forest Partnership</a> (Chairing role), and core funding arranged for ongoing support.
<b>AONB Team</b>	Monthly Team meetings, annual team training day and staff appraisals held.
<b>Wider networks</b>	The Manager acts as Chair of the West Midlands Protected Landscapes Forum. Active exchange of best practice through National Association for AONBs.
<b>Support the involvement of the community in the management of the AONB (also a cross-cutting theme in some items above)</b>	
<b>Support for groups</b>	63 community projects or groups have been supported in total, of which 24 would not have happened without AONB support. 2 parish plan groups have been supported, with plan development or actions.
<b>Support for volunteering</b>	281 volunteers involved through AONB-led and supported activities. <a href="#">'Friends of the Shropshire Hills'</a> has 67 members (plus some renewals pending).
