## NOTICE OF CONFIRMATION AND COMING INTO OPERATION OF PUBLIC PATH ORDER AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER

## HIGHWAYS ACT 1980 WILDLIFE AND COUNTRYSIDE ACT 1981

## THE SHROPSHIRE COUNCIL (FOOTPATH 40 (PART), PARISH OF CONDOVER) PUBLIC PATH DIVERSION ORDER 2017

On 23rd August 2018, The Shropshire Council (the "Council") confirmed the above named order made under section 119 of the Highways Act 1980 and section 53A(2) of the Wildlife and Countryside Act 1981. The effect of the order as confirmed is to **divert** 

the full width of that part of Footpath 40 Condover from point A on the order map (SJ 4790 0270) where it leaves Falkland Road running in a general easterly direction and enters the property known as Falkland Manor, passing through a wall and landscaped garden for approximately 50 metres and then crossing a fenced boundary into the development field where the route continues in a general south easterly direction for approximately 28 metres to point B (SJ 4796 0268) on the order map; a total distance of approximately 78 metres **onto a line** from point A (SJ 4790 0270) on the order map where it leaves Falkland Road, running in a general south easterly direction along a surfaced access for approximately 11 metres and then joining the pavement to the estate road continuing in a general south easterly direction for a further 31 metres approximately and then turning east-north-easterly for approximately 43 metres following the pavement of the estate road to point B (SJ 4796 0268) on the order map; a total distance of approximately 85 metres with a width of 2 metres throughout.

The order comes into force on 23rd August 2018; but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 23<sup>rd</sup> August 2018 make an application to the High Court
