WHEREAS

- (A) The Council wishes to receive a nursing care service and a nursing with dementia care service for older people
- (B) The Service Provider has the skills, background and experience in providing the Services required by the Council.
- (C) The Service Provider is willing to provide the Services as defined below and the Council is willing to appoint the Service Provider to provide the Services in accordance with the provisions of this Agreement.

1 AGREEMENT AND TERM

- 1(a) In consideration of the Payments the Service Provider will provide to the Service User(s) the Service set out in the Specification and this Agreement must be read in association with the Assessment of Needs/FFA and where there is a conflict this Agreement takes precedence
- 1(b) This Agreement shall commence on the Commencement Date and shall continue until the Expiry Date subject to Clauses 10 (Breach), 11 (Prevention of Bribery) and 16 (Termination, Extension & Suspension) in accordance with the terms of this Contract.
- In consideration of the Payment the Service Provider will allocate to the Service Users referred by the Council, for their exclusive use 5 general nursing Recovery Nursing Beds and 2 Recovery Nursing Beds with dementia care in single rooms at the Home. All 7 beds will be available from the Commencement Date.
- 1(d) The Council may seek to review the numbers and types of beds within the Agreement, including overall bed numbers, to reflect bed utilisation and bed demand. Any permanent amendments will be made in accordance with Clause 4 (Variation).
- 1(e) The Service Provider shall immediately (no later than the next day) notify the Council once the

- Service Provider becomes aware that a bed in the Service is to become vacant.
- 1(f) The Service Provider shall immediately (no later than the next day) notify the Council once a bed within the Service becomes vacant at short notice.
- When beds within the Service are available the Service Provider will arrange for planned transfer of 1(g) the identified Service User within a maximum of 24 hours of receiving the referral If the Service.
- If the Service Provider fails to admit an agreed referral within 24 hours or rejects an appropriate 1(h) referral from the Council and as a result beds in the Service are not occupied the Council may reduce the amount payable for that bed under this Agreement
- 1(i) If the Service Provider advises that the Service is temporarily unavailable and vacant beds in the Service cannot be accessed the Council may seek to reduce the amount payable under this Agreement for any vacant beds in the Service.
- 1(j) On expiry of this Agreement the Service Provider will allow all Service Users occupying a bed with the Service on the Expiry Date to remain at the Home and an IPC will be put in place to cover the Service Users period of occupancy at the home.

PAYMENT

- 2 2(a) From the Commencement Date of the Agreement to the Expiry Date the Council will pay to the Service Provider [£XXX per week per bed in respect of the 7 beds] **OR** [£XXX per week for 5 x general nursing Recovery Nursing Beds and £XXX per week for 2 x Recovery Nursing Beds with dementia care] (unless reduced in accordance with Clauses 1(d), 1(h) or 1(i).
- 2(b) Payment will be made two weeks in advance and two weeks in arrears.
- 2(c) Payments to the Service Provider will be made through the BACS.
- The Service Provider shall not make a charge to the Service User or any third party for the Service 2(d) provided.
- 2(e) The Council reserves the right to set off against the price of the goods or services any sums owed or becoming due to the Council from the Service Provider.
- 2(f) If either Party fails to make any Payment to the other Party under this Agreement within 30 days of receipt of the payment being due then the Party who should make payment shall pay interest on the overdue amount at the statutory rate above the Bank of England base rate from time to time further to the Late Payment of Commercial Debts (Interest) Act 1998. Such interest shall accrue on a daily basis from the due date until actual payment of the overdue amount, whether before or after Judgment.
- 2(g) The Council will determine any Service Users' Contribution to the cost of their residential or nursing care if a contribution is appropriate. The Council will carry out financial assessments with relevant Service Users using appropriate local and national guidance and will invoice each Service User in accordance with their assessed contribution. Under no circumstances should the Service Provider attempt to collect the Service Users Contribution from the Service User. The Service Users Contribution is collected by the Council.
- For the avoidance of doubt the Council will not: 2(h)
 - 2(h)(i) make Payments for any Service User residing in the Home who has not been referred by the Council.

- 2(h)(ii) make Payments for FNC. FNC is not payable on Recovery Nursing Beds. FNC cannot be claimed directly from the NHS.
- 2(i) The Service Provider shall not be entitled to vary the Payment during the existence of this Agreement unless with the prior written consent of the Council.
- 2(j) The Service Provider shall not charge, and the Council shall not be liable, for any expenses, charges, costs, fees except the Payments as set out in this Agreement
- 2(k) Unless otherwise agreed in writing by the Council, the Service Provider will pay any of its appointed subcontractors within the time period specified in the Sub-Contract but in any event no later than 30 days from receipt of an undisputed invoice.
- 2(I) The Council and the Service Provider have agreed that they will make placements into the service until and including the Expiry Date of the Agreement. If a Service User occupies a bed at the end of the Agreement a new IPC will be put in place in accordance with Clause 1(d). Any IPC's in place shall be paid at the rate relevant to the bed type in accordance with Clause 1(a) /£999 per bed week, any increases in this rate will be determined by the provisions under the fee review clause within the pre placement contract under which the IPC's are placed.

3 COMPLIANCE

- 3(a) The Council undertakes to:
 - 3(a)(i) make the Payments to the Service Provider in accordance with Clause 2 (Payment)
 - 3(a)(ii) liaise with the Service Provider regarding the provision of the Service where appropriate.
 - 3(a)(iii) Save as provided in this Agreement, give or assume no representations, warranties or conditions in respect of any information which is provided to the Service Provider by the Council and any such representations, warranties or conditions are excluded, save to the extent that such exclusion is prohibited by law.
- 3(b) The Service Provider undertakes to comply with the following in the provision of the Service:
 - 3(b)(i) provide the Service in accordance with the Specification and with all due diligence care and skill expected of a suitable and experienced provider of such services
 - 3(b)(ii) ensure that no aspect of the Service funded by the Payment is or appears to be party political in intention use or presentation
 - 3(b)(iii) in performing his obligations under this Agreement, the Service Provider shall and shall ensure that each of its Sub-Contractors shall comply with all applicable anti-slavery and human trafficking laws, statutes, regulations and codes from time to time in force including but not limited to the Modern Slavery Act 2015.
 - 3(b)(iv) the Safeguarding Adults Multi Agency Policy and Procedures for the West Midlands
 - 3(b)(v) all standards required by the Health and Social Care Act 2008 in order to maintain registration thereunder
 - 3(b)(vi) all equal opportunities legislation and anti-discriminatory practices including those identified in Clause 30 (Equalities)
 - 3(b)(vii) ensure that Staff and Subcontractors are made aware of the Council's policy "Speaking Up About Wrongdoing" and that the details of this policy are fully explained to them and shall provide the Council with evidence of doing so upon request

- 3(b)(viii) the Data Protection Act 1998
- 3(b)(ix) the standard required of a local authority under the Human Rights Act 1998. The Service Provider shall protect and shall not do anything in breach of Service Users' rights under the Act.
- 3(b)(x) the principles of Best Value
- 3(b)(xi) the Health and Safety at Work Act 1974 and any relevant health and safety regulations approved codes of practice and HSE guidance
- 3(b)(xii) The Services shall only be performed/delivered by the Service Provider unless otherwise agreed in writing between the Parties
- 3(b)(xiii) The Service Provider shall provide the Services in accordance with all current and relevant statutory provisions, regulations or other legislation from time to time in force relating to the provision of the Services
- 3(b)(xiv) The Service Provider shall during the Term ensure that every person employed by the Service Provider in the provision of the Services is properly trained and instructed with regard to his/her tasks in relation to the Services
- 3(b)(xv) before the Service Provider engages or employs any person in the provision of the Services, or in any activity related to, or connected with, the provision of the Services, the Service Provider must without limitation, complete the Employment Checks and any other checks required by the Disclosure and Barring Service.
- 3(b)(xvi) The Service Provider shall carry out its own risk assessments relevant to the Services
- 3(b)(xvii)The Service Provider shall have a written procedure for dealing with complaints about the Service in accordance with Clause 37 (Complaints Procedure) hereof
- 3(b)(xviii)The Service Provider agrees that where requested in writing during the term of this Agreement it will ensure that an appropriately authorised representative of the Service Provider shall attend a Committee meeting of the Council upon being invited to do so by the Council
- 3(b)(xix) To support the national agenda of Public Health England the Service Provider will engage with future public health initiatives on the promotion of physical activity for adults and older adults.
- 3(c) Prior to the engagement by the Service Provider of any staff or Sub-Contractor engaged to provide any part of the Services where such individuals will have contact with children up to the age of eighteen years old or where the performance of the Services may involve contact with vulnerable adults (as defined in the Safeguarding Vulnerable Groups Act 2006) the Service Provider shall procure in respect of all staff or potential staff or other persons intended to perform any part of the Services:
 - 3(c)(i) that each person being considered for engagement be questioned as to whether he/she has any convictions; and
 - 3(c)(ii) that the results of a Disclosure and Barring Service (DBS) check of the most extensive available kind is obtained in accordance with Part V of the Police Act 1997 (as amended) and that each DBS check should include a search of the list held pursuant to the Protection of Children Act 1999 where the performance of the Service may involve contact with children and/or Safeguarding Vulnerable Groups Act 2006 where the performance of the Service may involve contact with vulnerable adults.

- 3(d) The Council reserves the right to request, on dates to be agreed, regular informal reviews of the delivery of the Services between the Service Provider and the Council to ensure that the Outcomes/Performance Indicators are being achieved.
- 3(e) In the event that an informal review reveals that Outcomes/Performance Indicators are not being met, a formal Review meeting may take place between the Parties upon 14 days written notice being given to the Service Provider by the Council
- 3(f) The Review meeting shall record in writing any amendments to the Outcomes/Performance Indicator agreed between the Council and the Service Provider.
- 3(g) Where following a Review, the Council acting reasonably determines that the Service Provider has not met the Outcomes/Performance Indicators the Council may:
 - 3(g)(i) serve the Service Provider with a written notice ("Notice") within one month of the Review meeting specifying which of the Outcomes/Performance Indicators it considers that the Service Provider has not met or failed to achieve and giving the Service Provider one calendar month from the date of the Notice to remedy the failure
 - 3(g)(ii) if after one calendar month from the date of the Notice the Service Provider has failed to remedy the failure specified in the Notice then this will be considered to be a breach of the terms of this Agreement and the Agreement may be terminated in accordance with the provisions contained in Clause 16 (Termination, Extension & Suspension) herein
 - 3(g)(iii) The Council shall take into account any verbal or written representations made by the Service Provider before proceeding to take any action to terminate this Agreement pursuant to this Clause.
- 3(h) Within twenty six weeks of the last date of delivery of the Service and prior to the Expiry Date, the Council reserves the right to request the Service Provider to prepare and deliver to the Council a satisfactory Report recording the Outcomes/Performance together with its recommendations following the delivery of the Service.
- 3(i) Should the Service Provider provide the Service to Service Users who lack the mental capacity to make particular decisions it must familiarise itself with and adhere to the Council's Mental Capacity Act Deprivation of Liberty Safeguards Multi-Agency Guidance and Procedure.
- 3(j) If for any reason the Service Provider is unable to comply with any of its obligations under this Agreement it shall notify the Council's Contracts Manager and ICS Team Manager forthwith in Writing of its failure and the reasons. Compliance with this clause shall not prejudice the Council's rights under Clauses 10 (Breach) and 16 (Termination, Extension & Suspension).
- 3(k) The Service Provider warrants that the signing [execution] of this on its behalf has been validly authorised and the obligations expressed as being assumed by the Service Provider under this Agreement constitute valid legal and binding obligations of the Service Provider enforceable against the Service Provider in accordance with their terms.
- 3(I) The Service Provider warrants that:
 - 3(I)(i) it has full capacity and authority to enter into this Agreement
 - 3(I)(ii) it has obtained all necessary and required licences, consents and permits to provide the Services 3(I)(iii) it shall be responsible for all costs, fees, expenses and charges for training necessary or required for the Staff to perform the Services

3(I)(iv) that none of its current Directors have been involved in liquidation or receivership or have any criminal convictions

3(m) The Service Provider acknowledges and confirms that:

- 3(m)(i) it has had an opportunity to carry out a thorough due diligence exercise in relation to the Services and has asked the Council all the questions it considers to be relevant for the purpose of establishing whether it is able to provide the Services in accordance with the terms of this Agreement;
- 3(m)(ii) it has received all information requested by it from the Council pursuant to sub-clause 3(m)(i) to enable it to determine whether it is able to provide the Services in accordance with the terms of this Agreement;
- 3(m)(iii) it has made and shall make its own enquiries to satisfy itself as to the accuracy and adequacy of any information supplied to it by or on behalf of the Council pursuant to subclause 3(m)(ii);
- 3(m)(iv) it has raised all relevant due diligence questions with the Council before the Commencement Date; and
- 3(m)(v) it has entered into this Agreement in reliance on its own diligence
- 3(m)(vi) as at the Commencement Date, the Service Provider warrants and represents that all information contained in the Tender remain true, accurate and not misleading, save as may have been specifically disclosed in writing to the Council prior to execution of the Agreement AND shall promptly notify the Council in writing if it becomes aware during the performance of this Agreement of any inaccuracies in any information provided to it by the Council during such due diligence which materially and adversely affects its ability to perform the Services
- 3(m)(vii) The Service Provider shall not be entitled to recover any additional costs from the Council which arise from, or be relieved from any of its obligations as a result of, any matters or inaccuracies notified to the Council by the Service Provider in accordance with sub-clause 3(m)(vi) save where such additional costs or adverse effect on performance have been caused by the Service Provider having been provided with fundamentally misleading information by or on behalf of the Council and the Service Provider could not reasonably have known that the information incorrect or misleading at the time such information was provided.

4 VARIATION

- 4(a) This Agreement may only be varied by consent of both of the Parties and any such variation must be in writing and signed by an authorised officer from the Service Provider and an appropriately authorised officer of the Council authorised under the Council's Constitution and it must be annexed to this Agreement and shall record the date from which the agreed variation shall have effect.
- 4(b) The Service Provider will not enter into any negotiations either directly or indirectly with any Service User or Third Party the effect of which would be to vary or amend the terms of this Agreement without the prior written agreement of the Council.

5 PAYMENT REVIEW

- 5(a) If applicable, reference the provisions of Clause 16 Termination, Extension and Suspension the Council will review the Payment under this Agreement from 1 April 2020 and annually on 1 April from this date and may increase the Payments to the Service Provider accordingly.
- 5(b) The review shall be linked to the annual inflationary provision to the Council as determined by the Council's Chief Finance Officer or Officer of equal standing and reflective of any inflationary increase for Care Homes as agreed with Shropshire Partners in Care
- 5(c) Any increase in the Payment in relation to Clause 5(a) and Clause 5(b) shall be applied on the 1st of April and will relate to the Financial Year that commences on this date.
- 5(d) Should any payment review not be concluded by the 1st of April then the Payment for the preceding Financial Year shall remain in full force until such time as any revised Payment is agreed.
- 5(e) Any agreed revised Payment submitted in accordance with 5(c) above shall be back-dated to that date.
- 5(f) The Council's decision after the completion of the payment review shall be final.

6 VAT

The Payment does not include VAT and if VAT is payable then the Council will pay this in addition to the Payment provided that the Service Provider supplies the Council with an appropriate VAT notice.

7 AGENCY

- 7(a) The Service Provider is an independent contractor and nothing in this Agreement shall render it an agent of the Council and the Service Provider shall not hold itself out as the Council's agent nor shall it have the power or the right to bind the Council to any obligation.
- 7(b) Under the terms of this Agreement the Service Provider shall not have and shall in no way represent itself as having the power to make vary discharge or waive any by-law or regulation of any kind.

8 ACCOUNTING

- 8(a) The Service Provider shall ensure that all necessary accounting arrangements exist to distinguish between the Payment and any funds held on behalf of the Service User or any other funds held by the Service Provider.
- 8(b) All bank building society post office or other account statements together with all other supporting documentation pertaining to any Service Users monies held by the Service Provider shall be retained by the Service Provider and made available for inspection by the Council.
- 8(c) The Service Provider will (upon the Council's request) produce records of any funding held on behalf of Service Users which shall clearly identify the balance held and the date funds are paid in and withdrawn.
- 8(d) The Service Provider will facilitate the inspection of all financial records held in connection with the Service and shall produce a copy of its annual audited accounts as soon as is reasonably practicable if requested to do so by the Council.
- 8(e) The Service Provider shall provide such financial information as the Council may reasonably require from time to time to assess the financial viability and monitor the performance of the Service Provider.
- 8(f) The Service Provider shall compile maintain and keep the information and records as required in the Specification and such information as the Council may from time to time reasonably require to enable the Council to submit any information or data required for the purposes of the Performance Indicators..
- 8(g) The Council may by Notice in Writing to the Service Provider authorise the statutory auditors of the Council or any regulatory body to which the Council is subject including but without limitation the

Commissioner for Local Administration to exercise any of the rights exercisable under this clause by the Council. For these purposes the "statutory auditors of the Council" shall include any body appointed by the Council

9 NOTICES

- 9(a) The Service Provider shall comply with and give any Notices required under the Agreement or required by any Act of Parliament any instrument rule or order made under any Act of Parliament or any regulation or by-law of any local authority which may have jurisdiction in respect of the Service Provider.
- 9(b) Any Notice under this Agreement must be in Writing and can only be sent by:9(b)(i) recorded delivery post or9(b)(ii) personal delivery
- 9(c) The Service Provider's address for the purpose of delivery of a Notice is as set out above and all Notices sent to the Service Provider under this Agreement must be sent to the Service Provider's Directors.
- 9(d) The Council's address for the purpose of delivery of a Notice is Contracts Manager, Commissioning, Development & Procurement, Finance Governance & Assurance, Shropshire Council, Shirehall, Third Floor Room 3S36, Abbey Foregate, Shrewsbury SY2 6ND and a separate copy must also be sent to the Council's Procurement Manager, Commissioning, Development and Procurement, Finance Governance & Assurance, Shropshire Council, Shirehall Abbey Foregate Shrewsbury SY2 6ND.
- 9(e) All such Notices if delivered by hand shall be deemed to be served immediately and if posted shall be deemed to have been served two days after the date when posted unless the party upon whom the Notice was purported to be served has informed the serving party within 24 hours of partial receipt that the Notice was not received in full.

10 BREACH

- 10(a) In the event that the Service Provider is in breach of his obligations under this Agreement then the Council shall serve a Notice requiring the Service Provider to take such action as the Council deems necessary to remedy the breach upon the terms and within the time stipulated in the Notice.
- 10(b) The following obligations are conditions of this Agreement and any breach of them shall be deemed a fundamental breach which shall determine this Agreement immediately by the giving of a written Notice: 10(b)(i) Failure to comply with a Notice to remedy a breach pursuant to Clause 10(a)
 - 10(b)(ii) Assignment by the Service Provider of any of his obligations under this Agreement without the
 - prior written consent of the Council

 10(b)(iii) If the Service Provider was convicted of any offence the effect of which under the provisions of
 - 10(b)(iii) If the Service Provider was convicted of any offence the effect of which under the provisions of any legislation would prevent the Council from contracting with him or maintaining any existing contractual relationship
 - 10(b)(iv) If the Service Provider is issued with a Notice from the Health and Safety Executive or Registration Body prohibiting it from operating.

11 PREVENTION OF BRIBERY

- 11(a) The Service Provider:
 - 11(a)(i) shall not, and shall procure that all Service Provider Staff shall not, in connection with this Agreement commit a Prohibited Act;

- 11(a)(ii) warrants, represents and undertakes that it is not aware of any financial or other advantage being given to any person working for or engaged by the Council, or that an agreement has been reached to that effect, in connection with the execution of this Agreement, excluding any arrangement of which full details have been disclosed in writing to the Council before execution of this Agreement.
- 11(b) The Service Provider shall:
 - 11(b)(i) if requested, provide the Council with any reasonable assistance, at the Council's reasonable cost, to enable the Council to perform any activity required by any relevant government or agency in any relevant jurisdiction for the purpose of compliance with the Bribery Act;
 - 11(b)(ii) the Service Provider shall, within 10 Working Days of a request from the Council, certify to the Council in writing (such certification to be signed by an officer of the Service Provider) the Service Provider's compliance with this Clause 11 and provide such supporting evidence of compliance with this Clause 11 by the Service Provider as the Council may reasonably request.
- 11(c) If any breach of Clause 11 is suspected or known, the Service Provider must notify the Council immediately.
- 11(d) If the Service Provider notifies the Council that it suspects or knows that there may be a breach of Clause 11(a), the Service Provider must respond promptly to the Council's enquiries, co-operate with any investigation, and allow the Council to audit books, records and any other relevant documentation. This obligation shall continue for two years following the expiry or termination of this Agreement.
- 11(e) The Council may terminate this Agreement by written notice with immediate effect, and recover from the Service Provider the amount of any loss directly resulting from the cancellation, if the Service Provider or Service Provider Staff (in all cases whether or not acting with the Service Provider's knowledge) breaches Clause 11(a). At the Council's absolute discretion, in determining whether to exercise the right of termination under this Clause 11(e), the Council shall give consideration, where appropriate, to action other than termination of this Agreement unless the Prohibited Act is committed by the Service Provider or a senior officer of the Service Provider or by an employee, Sub-Contractor or supplier not acting independently of the Service Provider. The expression "not acting independently of" (when used in relation to the Service Provider or a Sub-Contractor) means and shall be construed as acting:

 - 11(e)(ii) with the actual knowledge of any one or more of the directors of the Service Provider or the Sub-Service Provider (as the case may be); or
 - 11(e)(iii) in circumstances where any one or more of the directors of the Service Provider ought reasonably to have had knowledge.
- 11(f) Any notice of termination under Clause 11(e) must specify:
 - 11(f)(i) the nature of the Prohibited Act;
 - 11(f)(ii) the identity of the party whom the Council believes has committed the Prohibited Act; and
 - 11(f)(iii) the date on which this Agreement will terminate.
- 11(g) Despite Clause 18 (Disputes), any dispute relating to:
 - 11(g)(i) the interpretation of Clause 11; or

- 11(g)(ii) the amount or value of any gift, consideration or commission, shall be determined by the Council and its decision shall be final and conclusive.
- 11(h) Any termination under Clause 11(e) will be without prejudice to any right or remedy which has already accrued or subsequently accrues to the Council.

12 INSURANCE

- 12(a) The Service Provider shall effect and maintain with a reputable insurance company a policy or policies of insurance providing an adequate level of cover, or in accordance with any legal requirement for the time being in force, in respect of all legal liability which may be incurred by the Service Provider, arising out of the Service Provider's performance of this Agreement, including death or personal injury, loss of or damage to property or any other loss, and unless otherwise agreed with the Council such policy or policies of Public Liability and Employers Liability insurance shall provide for a minimum indemnity limit of £5,000,000 (FIVE MILLION POUNDS).
- 12(b) If appropriate and requested in Writing, the Service Provider may also be required to provide Product Liability insurance of at least £2,000,000 (TWO MILLION POUNDS) cover for any one claim.
- 12(c) Where the Service Provider is providing Services of a professional nature, or the Council otherwise specifies that professional indemnity insurance is required, the Service Provider shall hold and maintain professional indemnity insurance cover and shall ensure that all professional consultants or Sub-Contractors involved in the provision of the Services hold and maintain policy cover which indemnifies the contractor for negligent acts arising out of the performance of this Agreement. To comply with its obligations under this clause, and as a minimum, the Service Provider shall ensure professional indemnity insurance held by the Service Provider and by any agent, Sub-Contractor or consultant involved in the performance of Services has a limit of indemnity of not less than £2,000,000 (TWO MILLION POUNDS) in respect of each and every claim.
- 12(d) The Service Provider shall hold and maintain any professional indemnity insurance required under this Agreement for a minimum of 6 years following the expiration or earlier termination of this Agreement
- 12(e) The Service Provider warrants that it has complied with this Clause 12 and warrants that any insurance policy or policies effected and maintained in accordance with this clause do not contain any endorsements or exclusions which have the effect of voiding, reducing or limiting the cover required in respect of the Services.
- 12(f) The Service Provider shall prior to commencement of this Agreement provide the Council and thereafter upon request, or at least annually during the Term, with:
 - (a) copies of the relevant insurance policy documents (including details of any warranties or exclusions); and
 - (b) receipts or other evidence of payment of the latest premiums due under those policies; and
 - (c) any other evidence reasonably requested by the Council to confirm that the required insurances are in force and effect and meet in full the requirements of this Clause 12.

Receipt of such evidence by the Council shall not in itself constitute acceptance by the Council or relieve the Service Provider of any of its liabilities and obligations under this Agreement.

- 12(g) The Service Provider shall:
 - (a) ensure nothing is done to invalidate any insurance policy or cause the relevant insurer to cancel,

- rescind or suspend any insurance or cover, or to treat any insurance, cover or claim as voided in whole or part, including ensuring that any warranties under the policy are complied with;
- (b) notify the Council as soon a reasonably practicable when it becomes aware of any relevant fact, circumstance or matter which, or is reasonably likely to provide grounds to, the relevant insurer to give notice to cancel, rescind suspend or void any insurance, or any cover or claim under any insurance in whole or in part.
- 12(h) For the avoidance of doubt, the terms of any insurance or the amount of cover shall not relieve the Service Provider of any liabilities under this Agreement.
- 12(i) Where the minimum limit of indemnity required in relation to any of the insurances is specified as being "in the aggregate":
 - 12(i)(i) if a claim or claims which do not relate to this Agreement are notified to the insurers which, given the nature of the allegations and/or the quantum claimed by the third party(ies), is likely to result in a claim or claims being paid by the insurers which could reduce the level of cover available below that minimum, the Service Provider shall immediately submit to the Council:
 - (a) details of the policy concerned; and
 - (b) its proposed solution for maintaining the minimum limit of indemnity specified; and
 - 12(i)(ii) if and to the extent that the level of insurance cover available falls below that minimum because a claim or claims which do not relate to this Agreement are paid by insurers, the Service Provider shall:
 - (a) ensure that the insurance cover is reinstated to maintain at all times the minimum limit of indemnity specified for claims relating to this Agreement; or
 - (b) if the Service Provider is or has reason to believe that it will be unable to ensure that insurance cover is reinstated to maintain at all times the minimum limit of indemnity specified, immediately submit to the Council full details of the policy concerned and its proposed solution for maintaining the minimum limit of indemnity specified.

13 INDEMNITY

- 13(a) The Service Provider shall indemnify the Council against all liabilities, costs, expenses, damages and losses (including any direct, indirect or consequential losses, loss of profit, loss of reputation and all interest, penalties and legal and other [reasonable] professional costs and expenses) suffered or incurred by the Council arising out of or in connection with:
 - (a) The performance, defective performance or otherwise of this Agreement by the Service Provider or the Service Provider Staff
 - (b) Any claim made against the Council for actual or alleged infringement of a third party's Intellectual Property Rights arising out of, or in connection with the provision of the Services
 - (c) Any claim made against the Council by a third party arising out of, or in connection with, the supply of the Services, to the extent that such claim arises out of the breach, negligent performance or failure or delay in performance of this Agreement by the Service Provider or the Service Provider's Staff; and
 - (d) Any claim made against the Council by a third party for death, personal injury or damage to property arising out of, or in connection with the delivery of the Services and performance of this

Agreement to the extent that the defective performance is attributable to the acts or omissions of the Service Provider or the Service Provider's Staff

- 13(b) The Council shall indemnify the Service Provider against all reasonable claims, costs and expenses which the Service Provider may incur and which arise, directly from the Council's breach of any of its obligations under this Agreement.
- 13(c) Nothing in this Agreement shall limit or exclude the liability of either Party for:
 - (a) death or personal injury resulting from negligence; or
 - (b) fraud or fraudulent misrepresentation; or
 - (c) the indemnities given in this Clause 13

14 AUTHORISED OFFICER AND SERVICE PROVIDER REPRESENTATIVE

- 14(a) An Authorised Officer may be appointed by the Council to act in the name of the Council for the purposes of the Agreement evidenced by this Agreement.
- 14(b) The Council may require the Service Provider to appoint a Service Provider Representative to act in the name of the Service Provider for the purposes of the Agreement evidenced by this Agreement
- 14(c) The Parties shall notify each other in writing of any replacement Authorised Officer or Service Provider Representative or if any person ceases to be either the Authorised Officer or Service Provider Representative.
- 14(d) The Authorised Officer shall monitor on behalf of the Council, the provision of the Services supplied by the Service Provider and act as liaison officer with the Service Provider's Representative in respect of the operation of the Services. Any issues raised by the Authorised Officer with regard to the delivery of the Services shall in the first instance be addressed and dealt with by the Service Provider's Representative on the Service Provider's behalf.

15 INTELLECTUAL PROPERTY

- 15(a) In the absence of prior written agreement by the Council to the contrary, all Intellectual Property created by the Service Provider or any employee, agent or subcontractor of the Service Provider:
 15(a)(i) in the course of performing the Services; or
 15(a)(ii) exclusively for the purpose of performing the Services, shall vest in the Council on creation.
- 15(b) Unless stated expressly in writing in this Agreement, neither Party will acquire any ownership interest in or licence of the other's Intellectual Property by virtue of this Agreement
- 15(c) The Service Provider shall indemnify the Council against all claims, demands, actions, costs, expenses (including legal costs and disbursements on a solicitor and client basis), losses and damages arising from or incurred by reason of any infringement or alleged infringement (including the defence of such alleged infringement) of any Intellectual Property Right by the availability of the Services, except to the extent that they have been caused by or contributed to by the Council's acts or omissions.
- 15(d) This provision shall survive the expiration or termination of the Agreement

16 TERMINATION, EXTENSION & SUSPENSION

16(a) Unless terminated in accordance with this Clause 16 or Clause 10 (Breach) or 11 (Prevention of Bribery), this Agreement will remain in force for the Initial Term and it is agreed between the Parties that the Council may exercise its Option to Extend this Agreement as follows:

- 16(a)(i) If the Council decides to exercise its Option to Extend the Initial Term it shall notify the Service Provider in writing at least 3 months in advance of the Initial Expiry Date. Where the Parties agree an extension of the Initial Term the provisions of this Agreement between the Council and the Service Provider shall be the terms to be applied to the extended contract period, save for any agreed variations in writing by the Parties to the terms of this Agreement or Payments which are to apply during the extension period.
- 16(a)(ii) If the Council decides that it does not wish to exercise its Option to Extend then this Agreement shall terminate on the Initial Expiry Date and the provisions of Clause 17 (Consequences of Termination) shall apply.
- 16(a)(iii) For the avoidance of doubt the maximum period that this Agreement shall be extended is three years from the Initial Expiry Date.
- 16(b) This Agreement may be terminated prior to the Expiry Date in the following circumstances:-
 - 16(b)(i) by either the Council or the Service Provider by giving **6 months**' Notice in Writing to the other party
 - 16(b)(ii) by the Council if in the reasonable opinion of the Council it is no longer practicable to maintain a satisfactory or viable relationship with the Service Provider because the Service Provider or its Staff have acted unlawfully or fraudulently or there has been a serious breakdown of mutual trust between the Parties
 - 16(b)(iii) by the Council if the Service Provider becomes the subject of a voluntary arrangement under section 1 Insolvency Act 1986 or is unable to pay its debts within the meaning of section 123 Insolvency Act 1986; has a receiver manager administrator or administrative receiver appointed over all or any parts of its undertaking assets or income; has passed a resolution for its winding up; has a petition presented to any court for its winding up or for an administration order; or if any distraint execution or other process is levied or enforced on any property of the other and is not paid out withdrawn or discharged within 14 days.
 - 16(b)(iv) by either Party if the other Party commits a material breach of this Agreement and, in the case of a breach capable of being remedied, fails to remedy it within 14 calendar days of being given notice in writing setting out the breach and indicating that failure to remedy the breach may result in termination of this Agreement.
 - 16(b)(v) by either Party where the other Party commits a series of minor breaches which, when taken together, amount to a material breach;
 - 16(b)(vi) by either Party where the other Party commits a material breach of this Agreement which cannot be remedied under any circumstances;
 - 16(b)(vii) by the Council forthwith by notice where the Service Provider commits a material breach as a result of a failure to comply with a Notice issued in accordance with Clause 10 (Breach)
 - 16(b)(viii) by either Party where the other Party ceases to carry on its business or substantially the whole of its business;
- 16(c) In the event of this Agreement being terminated at any time prior to the Expiry Date for any reason then the Council's obligations under Clause 2 (Payment) will cease no further Payment will be made and the Service Provider shall repay to the Council all (if any) of the Payment already received (after the liabilities

- of the Service Provider in the provision of the Service in accordance with this Agreement have been met).
- 16(d) Without prejudice to the generality of the foregoing the Council reserves the right to suspend referrals to the Service where in the reasonable opinion of the Council there is any improper conduct on the part of the Service Provider its Staff and Subcontractors and this will be considered a breach of this Agreement which may result in the suspension of referrals and or reduction / clawback of part of the Payment consistent with the reduction in Service. Improper conduct includes any action which the Council may reasonably consider to be to the detriment or the welfare of Service Users either by action or neglect including but not limited to:
 - 16(d)(i) Fraud or theft from Service Users
 - 16(d)(ii) Neglect of Service Users
 - 16(d)(iii) Cruelty and assault to or upon Service Users including verbal and any other forms of psychological abuse
 - 16(d)(iv) Financial malpractice
 - 16(d)(v) Sexual relationships between Staff and Service Users
 - 16(d)(vi) Racial harassment
 - 16(d)(vii) Loss of registration with Registration Body
 - 16(d)(viii)Any concerns about the Service under investigation by the Council.
- 16(e) If the Agreement is terminated as provided by Clause 10 (Breach) or 11 (Prevention of Bribery) or 16 (Termination, Extension & Suspension) above the Council shall:
 - 16(e)(i) cease to be under any obligation to make further Payment until the cost loss and/or damage resulting from or arising out of the termination of the Agreement shall have been calculated and provided such calculation shows a sum or sums due to the Service Provider;
 - 16(e)(ii) be entitled to make other arrangements and if necessary pay other persons to provide the Services
 - 16(e)(iii) be entitled to deduct from any sum or sums which would have been due from the Council to the Service Provider under this Agreement or be entitled to recover the same from the Service Provider as a debt any loss or damage to the Council resulting from or arising out of the termination of this Agreement and further such loss or damage shall include the reasonable cost to the Council of the time spent by its officers in terminating this Agreement and in making alternative arrangements for the provision of the Services provided that the Council will be under a duty to take all reasonable action to mitigate the loss or damage pursuant to this Clause 16.
- 16(f) Whilst this Agreement affords the Council and the Service Provider reciprocal rights to terminate as per the terms of Clause 16(b)(i) the Parties acknowledge that the expectation of most Service Users is that the Parties will not act unreasonably or to the prejudice of the Service Users so far as is reasonably practicable.
- 16(g) Where notice to terminate is given pursuant to this Clause 16, this Agreement shall terminate with effect on the date specified in the Notice.
- 17 CONSEQUENCES OF TERMINATION
- 17(a) Other than as set out in this Agreement, neither Party shall have any further obligations to the other

- under this Agreement after its termination
- 17(b) Any provision of this Agreement which expressly or by implication is intended to come into or continue in force on or after termination of this Agreement shall remain in full force and effect
- 17(c) Termination of this Agreement, for any reason, shall not affect the accrued rights, remedies obligations or liabilities of the Parties existing at termination
- 17(d) Notwithstanding its obligations in this Clause 17, if a Party is required by law, regulation, or government or regulatory body to retain any documents or materials containing the other Party's Confidential Information, it shall notify the other Party in writing of such retention, giving details of the documents and/or materials it must retain.
- 17(e) Upon termination of this Agreement for any reason, the Service Provider shall, at its own cost, deliver, and require that its employees, agents and Sub-Contractors deliver, to the Council any project materials, information and any other property of the Council which are in the possession or control of the Service Provider or the Service Provider's employees, agents or Sub-Contractors at the date of termination.

18 DISPUTES

- 18(a) If any dispute or difference shall arise between the Parties as to the construction of this Agreement or any matter or thing of whatever nature arising under this Agreement or in connection with it then the same shall be dealt with as follows:-
 - 18(a)(i)In the first instance a special meeting of both the Parties shall be arranged on 14 days' written notice to the other party and the matter shall be discussed and the representatives shall use their reasonable endeavours to resolve the dispute
 - 18(a)(ii)If the dispute cannot be resolved in accordance with the preceding sub-clause then either one of the Parties may serve the Council's Chief Executive or the Service Provider's senior officer or such other authorised officer of either party whose details have been notified to the other party, with notice of the dispute and those officers shall then appoint their representative to adjudicate and use their reasonable endeavours to resolve the dispute within 21 days of receipt of such notice

19 ASSIGNMENT, TRANSFER AND SUB-CONTRACTING

- 19(a) Neither Party shall be entitled to assign, novate or otherwise dispose of any or all of its rights and obligations under this Agreement without the prior written consent of the other Party PROVIDED that the Council may,
 - (a)(i) assign any of its rights under this Agreement; or
 - (a)(ii) transfer all of its rights or obligations by novation, to another person without the Service Provider's consent where such assignment, transfer or novation is to an Associated Person of the Council;
- 19(b) Any consent required under Clause 19(a) must not be unreasonably withheld or delayed and if not expressly refused within five Working Days shall be deemed given.
- 19(c) The Service Provider will not, without the written consent of the Council, Sub-Contract its right or obligations under this Agreement nor allow Services to be provided other than through the Service Provider's Staff and using its own equipment.
- 19(d) In the event that consent is given by either Party to the other Party to the placing of Sub-Contracts, copies of each Sub-Contract and order shall be sent by the sub-contracting Party to the consenting Party

- immediately it is issued
- 19(e) Subject to Clause 19(a), in the event that either Party wishes to assign its rights and obligations under this Agreement, the assignor must obtain a written undertaking from the assignee to the consenting Party that it will be bound by the obligations of the assignor under this Agreement.
- 19(f) Notwithstanding the Service Provider's right to Sub-Contract pursuant to this Clause 19, the Service Provider shall remain responsible for all acts and omissions of its Sub-Contractors and the acts and omissions of those employed or engaged by the Sub-Contractors as if they were its own and shall be responsible for the work of the Sub-Contractor whose work shall be undertaken to the same standard as stated in the Specification.
- 19(g) Where 20% or more of the Service Provider's overall workforce is made up of people from agencies (or not employed directly by the Service Provider) this may be considered assignment or subcontracting of the Service Provider's obligations under this Agreement and require written consent of the Council which it shall be absolutely entitled to withhold.

20 FORCE MAJEURE

- 20(a) Subject to the provisions of Clause 20(b) neither the Service Provider nor the Council shall be liable for any delay or failure in performing its obligations hereunder for any circumstances beyond its reasonable control such as (but not restricted to) flood fire and civil unrest but the Council shall in such circumstances be entitled to take such action as is reasonable and necessary to protect the interest of the Service Users.
- 20(b) Save where such delay or failure is caused by the act or omission of the other party (in which event the rights remedies and liabilities of the Parties shall be those conferred and imposed by the other terms of this Agreement and by Law):-
 - 20(b)(i) any charges arising from such delay or failure shall be borne by the party incurring the same 20(b)(ii) either party may if such delay or failure continues for more than 90 (ninety) days terminate this
 - Agreement forthwith on giving Notice (as determined by Clause 9 (Notices) to the other party in which event neither party shall be liable to the other by reason of such termination.
- 20(c) For the avoidance of doubt "force majeure" shall not include any labour dispute between the Service Provider and its Staff or the failure to provide the Service by any of the Service Provider's Subcontractors.

21 WAIVER

Failure at any time by either party to enforce any of the provisions hereof shall not be construed as a waiver of any such provisions and shall not affect the validity or any part of it or the right of the Council to enforce any provision of this Agreement in accordance with its terms.

22 SEVERANCE

If any of the provisions of this Agreement shall become or shall be declared by any court of competent jurisdiction to be invalid or unenforceable in any way such invalidity or unenforceability shall in no way impair or affect any other provision all of which shall remain in full force and effect.

23 LAW

This Agreement shall be governed and construed in accordance with the laws of England and the Parties agree to submit to the jurisdiction of the English Courts.

24 THIRD PARTY RIGHTS

Unless the right of enforcement is expressly provided it is not intended that a third party should have the right to enforce a provision of this Agreement under the Contracts (Rights of Third Parties) Act 1999.

25 REMEDIES CUMULATIVE

Any remedy or right which the Council may exercise in relation to a breach committed by the Service Provider shall be in addition to and shall be capable of being exercised without prejudice to all other rights and remedies available to the Council.

26 CONCLUSION OF AGREEMENT

26(a) Upon the expiry or termination of this Agreement and upon the Council's request the Service Provider must give an officer of the Council or any person the Council specifies copies of all data information files records documents and the like (in whatever form that they may be held) which the Council earlier supplied to the Service Provider for the purposes of this Agreement or which were produced or augmented by the Service Provider in connection with the carrying out of obligations under this Agreement and the Service Provider must retain Service User records for a minimum of 6 years after the expiry this Agreement.

27 SUSTAINABILITY

The Service Provider will at all times use its best endeavours to source all materials used to provide the Service from sustainable and renewable sources.

- 28 FREEDOM OF INFORMATION ACT 2000 (FOIA) AND ENVIRONMENTAL INFORMATION REGULATIONS 2004 (EIR)
- 28(a) The Service Provider acknowledges that the Council is subject to the requirements of the FOIA and the Environmental Information Regulations and shall assist and cooperate with the Council to enable the Council to comply with its Information disclosure obligations.
- 28(b) The Service Provider shall notify the Council of any Commercially Sensitive Information provided to the Council together with details of the reasons for its sensitivity and the Service Provider acknowledges that any lists or schedules of Commercially Sensitive Information so provided are of indicative value only and that the Council may be obliged to disclose such information.
- 28(c) The Service Provider shall:
 - 28(c)(i) transfer to the Council all Requests for Information that it receives as soon as practicable and in any event within two Working Days of receiving a Request for Information;
 - 28(c)(ii) provide the Council, at the Service Provider's expense, with a copy of all Information in its possession, or power in the form that the Council requires within five Working Days (or such other period as the Council may specify) of the Council's request; and
 - 28(c)(iii) provide, at the Service Provider's expense, all necessary assistance as reasonably requested by the Council to enable the Council to respond to the Request for Information within the time for compliance set out in section 10 of the FOIA or regulation 5 of the EIR.
- 28(d) The Council shall be responsible for determining in its absolute discretion and notwithstanding any other provision in this Agreement or any other agreement whether the Commercially Sensitive Information and/or any other Information is exempt from disclosure in accordance with the provisions of the FOIA or the EIR and in considering any response to a Request for Information the Council may consult with the Service Provider prior to making any decision or considering any exemption.

- 28(e) In no event shall the Service Provider respond directly to a Request for Information unless expressly authorised to do so by the Council.
- 28(f) The Service Provider acknowledges that (notwithstanding the provisions of this Clause 28) the Council may, acting in accordance with the Ministry of Justice's Code of Practice on the Discharge of the Functions of Public Authorities under Part 1 of the Freedom of Information Act 2000 ("the Code"), be obliged under the FOIA, or the EIR to disclose information concerning the Service Provider or the Services:
 - 28(f)(i) in certain circumstances without consulting the Service Provider; or
 - 28(f)(ii) following consultation with the Service Provider and having taken their views into account; provided always that where sub-clause 28(f)(i) above applies the Council shall, in accordance with any recommendations of the Code, take reasonable steps, where appropriate, to give the Service Provider advanced notice, or failing that, to draw the disclosure to the Service Provider's attention after any such disclosure.
- 28(g) The Service Provider shall ensure that all Information required to be produced or maintained under the terms of this Agreement, or by law or professional practice or in relation to the Agreement is retained for disclosure for at least the duration of the Agreement plus one year together with such other time period as required by the Agreement, law or practice and shall permit the Council to inspect such records as requested from time to time.
- 28(h) The Council shall in no event be liable for any loss, damage, harm, or detriment, howsoever caused, arising from or in connection with the reasonable disclosure under FOIA, or any other law, of any information (including Exempt Information) whether relating to this Agreement or otherwise relating to any other party.

29 TUPE

- 29(a) The Parties acknowledge that they do not consider that any change in the identity of the Service Provider following the termination of this Agreement will result in a Relevant Transfer for purposes of TUPE.
- 29(b) Where a subsequent change in the identity of the Service Provider is deemed to constitute a Relevant Transfer the Service Provider agrees to comply with its obligations under TUPE.

30 EQUALITIES

- 30(a) The Service Provider shall not unlawfully discriminate either directly or indirectly on such grounds as race or ethnic origin, disability, gender, sexual orientation, religion or belief, or age in the supply and provision of Goods, Services or Works under this Agreement, or in its employment practices.
- 30(b) Without prejudice to the generality of the foregoing, the Service Provider shall not unlawfully discriminate within the meaning and scope of the Equalities Act 2010 or other relevant legislation, or any statutory modification or re-enactment thereof.
- 30(c) In addition, the Service Provider in providing services to the Council will comply with the general duty imposed on local authorities by Section 149 of the Equality Act 2010 to eliminate discrimination, harassment and victimisation and promote equality of opportunity between persons who share a protected characteristic and those who do not share it and to foster good relations between persons who share a protected characteristic and those who do not share it.

- 30(d) The Service Provider will take all reasonable steps to observe as far as possible the Codes of Practice produced by the Equalities and Human Rights Commission, which give practical guidance to employers on the elimination of discrimination.
- 30(e) In the event of any finding of unlawful discrimination being made against the Service Provider during the Agreement period, by any court or employment tribunal, or any adverse finding or formal investigation by the Equalities and Human Rights Commission over the same period, the Service Provider shall inform the Council of this finding and shall take appropriate steps to prevent repetition of the unlawful discrimination.
- 30(f) The Service Provider will provide a copy of its policies to the Council at any time upon request. In addition, the Council may reasonably request other information from time to time for the purpose of assessing the Service Provider's compliance with the above conditions.

31 CONFIDENTIAL INFORMATION

- 31(a) The Service Provider will keep confidential any information it becomes aware of by reason of the operation of this Agreement and any other information which the Council may from time to time determine as relevant to this Agreement and shall not use divulge or communicate the same to any third party without the consent in writing of the Council.
- 31(b) The Service Provider shall at all times keep confidential all information held or known in respect of its past or present Service Users.
- 31(c) The Service Provider shall not mention the Council's name in connection with this Agreement or disclose the existence of the Agreement in any publicity material or other similar communication to third parties without the Council's prior consent in writing.
- 31(d) Except to the extent set out in this Clause 31 or where disclosure is expressly permitted elsewhere in this Agreement, each party shall:
 - 31(d)(i) treat the other Party's Confidential Information as confidential; and
 - 31(d)(ii) not disclose the other Party's Confidential Information to any other person without the owner's prior written consent
- 31(e) Clause 31(d) shall not apply to the extent that:
 - 31(e)(i) such disclosure is a requirement of law placed upon the party making the disclosure, including any requirements for disclosure under the Audit Commission Act 1998 or under the FOIA or the Environmental Information Regulations pursuant to the above Clause 28 regarding Freedom of Information
 - 31(e)(ii) such information was in the possession of the party making the disclosure without obligation of confidentiality prior to its disclosure by the information owner
 - 31(e)(iii) such information was obtained from a third party without obligation of confidentiality
 - 31(e)(iv) such information was already in the public domain at the time of disclosure otherwise than by a breach of this Agreement
 - 31(e)(v) it is independently developed without access to the other party's Confidential Information.
- 31(f) The Service Provider may only disclose the Council's Confidential Information to the Service Provider's Staff who are directly involved in the provision of the Service and who need to know the information, and

- shall ensure that such Service Provider's Staff are aware of and shall comply with these obligations as to confidentiality.
- 31(g) The Service Provider shall not, and shall procure that the Service Provider's Staff do not, use any of the Council's Confidential Information received otherwise than for the purposes of this Agreement.
- 31(h) The Service Provider shall ensure that its employees and agents are aware of and comply with Clause 31 and shall indemnify the Council against any loss or damage sustained or incurred as a result of any breach of confidence by the Service Provider, its employees or agents.
- 31(i) The Service Provider its Staff and any person employed or engaged by the Service Provider in connection with this Agreement shall:
 - 31(i)(i) only use the Confidential Information for the purposes of this Agreement
 - 31(i)(ii) not disclose any of the Confidential Information to any third party without the prior written consent of the Council which consent the Council shall be absolutely entitled to refuse
 - 31(i)(iii) not use the Confidential Information for the solicitation of business from the Council
- 31(j) Nothing in this Agreement shall prevent the Council from disclosing the Service Provider's Confidential Information:
 - 31(j)(i) to any consultant, contractor or other person engaged by the Council
 - 31(j)(ii) for the purpose of the examination and certification of the Council's accounts or any other form of audit of the Council.
- 31(k) The Council shall use all reasonable endeavours to ensure that any government department, employee, third party or Sub-contractor to whom the Service Provider's Confidential Information is disclosed pursuant to this Agreement is made aware of the Council's obligations of confidentiality.
- 31(I) The provisions of this Clause 31 shall survive the expiration or termination of this Agreement

32 COUNCIL DATA

- 32(a) The Service Provider shall not delete or remove any copyright or proprietary notices contained within or relating to the Council Data.
- 32(b) The Service Provider shall not store, copy, disclose, or use the Council Data except as necessary for the performance by the Service Provider of its obligations under this Agreement or as otherwise expressly authorised in writing by the Council and in particular the Service Provider shall not store any Council Data, which the Council has notified the Service Provider requires storage in an encrypted format, on any portable device or media unless that device is encrypted.
- 32(c) To the extent that Council Data is held and/or processed by the Service Provider, the Service Provider shall supply that Council Data to the Council as requested by the Council in any format specified reasonably requested by the Council.
- 32(d) The Service Provider shall take responsibility for preserving the integrity of Council Data and preventing the corruption or loss of Council Data and shall take such back up copies of the Council Data at regular intervals appropriate to the frequency of the revision of the Council Data.
- 32(e) The Service Provider shall ensure that any system on which the Service Provider holds any Council Data, including back-up data, is a secure system that complies with the Council's security policy to include, but not limited to, the following requirements:

- 32(e)(i) Access to the system is restricted to Service Provider Staff with a legitimate need to access the Council Data
- 32(e)(ii) The system is kept up to date with the latest versions of operating system and anti-virus updates
- 32(e)(iii) Transfer of data to and from the system is conducted in a secure manner.
- 32(f) If the Council Data is corrupted, lost or sufficiently degraded as a result of the Service Provider's default so as to be unusable, the Council may:
 - 32(f)(i) require the Service Provider (at the Service Provider's expense) to restore or procure the restoration of Council Data as soon as practicable; and/or
 - 32(f)(ii) itself restore or procure the restoration of Council Data, and shall be repaid by the Service Provider any reasonable expenses incurred in doing so including the restoration of the Council Data
- 32(g) If at any time the Service Provider suspects or has reason to believe that Council Data has or may become corrupted, lost or sufficiently degraded in any way for any reason, then the Service Provider shall notify the Council via the Council's ICT Helpdesk immediately and inform the Council of the remedial action the Service Provider proposes to take.
- 32(h) The Service Provider shall check for and delete Malicious Software and if Malicious Software is found, the Parties shall co-operate to reduce the effect of the Malicious Software and, particularly if Malicious Software causes loss of operational efficiency or loss or corruption of Council Data, assist each other to mitigate any losses and to restore the Services to their desired operating efficiency.
- 32(i) Any cost arising out of the actions of the Parties taken in compliance with the provisions of sub-clause 32(h) above shall be borne by the Parties as follows:
 - 32(i)(i) by the Service Provider where the Malicious Software originates from the Service Provider Software, the Third Party Software or the Council Data (whilst the Council Data was under the control of the Service Provider); and
 - 32(i)(ii) by the Council if the Malicious Software originates from the Council Software or the Council Data (whilst the Council Data was under the control of the Council).

33 DATA PROTECTION

- 33(a) Both parties will comply with all applicable requirements of the Data Protection Legislation and agree to take account of any guidance issued by the Information Commissioner's Office. This Clause 33 is in addition to, and does not relieve, remove or replace, a party's obligations under the Data Protection Legislation.
- 33(b) Where there is any conflict, ambiguity or inconsistency between this clause (including any associated definitions) and the remainder of this Agreement this Clause 33 shall take precedence.
- 33(c) The Parties acknowledge that for the purposes of the Data Protection Legislation, the Council is the Data Controller and the Service Provider is the Data Processor unless otherwise specified in Schedule 4. The only processing that the Data Processor is authorised to do is listed in Schedule 4 by the Data Controller and may not be determined by the Processor.
- 33(d) The Service Provider shall notify the Council immediately if it considers that any of the Council's

instructions infringe the Data Protection Legislation.

- 33(e) The Service Provider shall provide all reasonable assistance to the Council in the preparation of any Data Protection Impact Assessment prior to commencing any processing. Such assistance may, at the discretion of the Council, include:
 - (a) a systematic description of the envisaged processing operations and the purpose of the processing;
 - (b) an assessment of the necessity and proportionality of the processing operations in relation to the Services:
 - (c) an assessment of the risks to the rights and freedoms of Data Subjects; and
 - (d) the measures envisaged to address the risks, including safeguards, security measures and mechanisms to ensure the protection of Personal Data.
- 33(f) The Data Processor shall, in relation to any Personal Data processed in connection with its obligations under this Agreement:
 - (a) process that Personal Data only in accordance with Schedule 4 unless the Processor is required to do otherwise by Law. If it is so required the Data Processor shall promptly notify the Data Controller before processing the Personal Data unless prohibited by Law;
 - (b) ensure that it has in place Protective Measures, which are appropriate to protect against a Data Loss Event, which the Controller may reasonably reject (but failure to reject shall not amount to approval by the Controller of the adequacy of the Protective Measures), having taken account of the
 - (i) the nature of the data to be protected;
 - (ii) the harm that might result from a Data Loss Event;
 - (iii) the state of technological development; and
 - (iv) the cost of implementing any measures;
 - (c) ensure that:
 - (i) the Processor Personnel do not process Personal Data except in accordance with this Agreement (and in particular Schedule 4);
 - (ii) it takes all reasonable steps to ensure the reliability and integrity of any Processor Personnel who have access to the Personal Data and ensure that they:
 - (A) are aware of and comply with the Data Processor's duties under this clause;
 - (B) are subject to appropriate confidentiality undertakings with the Data Processor or any Sub-processor;
 - (C) are informed of the confidential nature of the Personal Data and do not publish, disclose or divulge any of the Personal Data to any third Party unless directed in writing to do so by the Data Controller or as otherwise permitted by this Agreement; and
 - (D) have undergone adequate training in the use, care, protection and handling of Personal Data; and
 - (E) are obliged to keep the Personal Data confidential; and
 - (F) shall not store any Personal Data on any portable device or media unless that

device is encrypted and

- (d) not transfer Personal Data outside of the EU unless the prior written consent of the Data Controller has been obtained and the following conditions are fulfilled:
 - (i) the Data Controller or the Data Processor has provided appropriate safeguards in relation to the transfer (whether in accordance with GDPR Article 46 or LED Article 37) as determined by the Data Controller;
 - (ii) the Data Subject has enforceable rights and effective legal remedies;
 - (iii) the Data Processor complies with its obligations under the Data Protection Legislation by providing an adequate level of protection to any Personal Data that is transferred (or, if it is not so bound, uses its best endeavours to assist the Data Controller in meeting its obligations); and
 - (iv) the Data Processor complies with any reasonable instructions notified to it in advance by the Data Controller with respect to the processing of the Personal Data;
- (e) at the written direction of the Data Controller, delete or return Personal Data (and any copies of it) to the Data Controller on termination of the Agreement unless the Data Processor is required by Law to retain the Personal Data.
- 33(g) Subject to Clause 33(h), the Data Processor shall notify the Data Controller immediately if it:
 - (a) receives a Data Subject Request (or purported Data Subject Request);
 - (b) receives a request to rectify, block or erase any Personal Data;
 - (c) receives any other request, complaint or communication relating to either Party's obligations under the Data Protection Legislation;
 - (d) receives any communication from the Information Commissioner or any other regulatory authority in connection with Personal Data processed under this Agreement;
 - (e) receives a request from any third Party for disclosure of Personal Data where compliance with such request is required or purported to be required by Law; or
 - (f) becomes aware of a Data Loss Event.
- 33(h) The Data Processor's obligation to notify under Clause 33(g) shall include the provision of further information to the Data Controller in phases, as details become available.
- 33(i) Taking into account the nature of the processing, the Data Processor shall provide the Data Controller with full assistance in relation to either Party's obligations under Data Protection Legislation and any complaint, communication or request made under Clause 33(g) (and insofar as possible within the timescales reasonably required by the Data Controller) including by promptly providing:
 - (a) the Data Controller with full details and copies of the complaint, communication or request;
 - (b) such assistance as is reasonably requested by the Data Controller to enable the Data Controller to comply with a Data Subject Request within the relevant timescales set out in the Data Protection Legislation;
 - (c) the Data Controller, at its request, with any Personal Data it holds in relation to a Data Subject;
 - (d) assistance as requested by the Data Controller following any Data Loss Event;
 - (e) assistance as requested by the Data Controller with respect to any request from the Information Commissioner's Office, or any consultation by the Data Controller with the Information

Commissioner's Office.

- 33(j) The Data Processor shall maintain complete and accurate records and information to demonstrate its compliance with this clause. This requirement does not apply where the Processor employs fewer than 250 staff, unless:
 - (a) the Data Controller determines that the processing is not occasional;
 - (b) the Data Controller determines the processing includes special categories of data as referred to in Article 9(1) of the GDPR or Personal Data relating to criminal convictions and offences referred to in Article 10 of the GDPR; or
 - (c) the Data Controller determines that the processing is likely to result in a risk to the rights and freedoms of Data Subjects.
- 33(k) The Data Processor shall allow for audits of its Data Processing activity by the Data Controller or the Data Controller's designated auditor.
- 33(I) Each Party shall designate its own Data Protection Officer if required by the Data Protection Legislation.
- 33(m) Before allowing any Sub-processor to process any Personal Data related to this Agreement, the Data Processor must:
 - (a) notify the Data Controller in writing of the intended Sub-processor and processing;
 - (b) obtain the written consent of the Data Controller;
 - (c) enter into a written agreement with the Sub-processor which give effect to the terms set out in this Clause 33(I) such that they apply to the Sub-processor; and
 - (d) provide the Data Controller with such information regarding the Sub-processor as the Data Controller may reasonably require.
- 33(n) The Data Processor shall remain fully liable for all acts or omissions of any of its Sub-processors.
- 33(o) The Data Controller may, at any time on not less than 30 Working Days' notice, revise this clause by replacing it with any applicable controller to processor standard clauses or similar terms forming part of an applicable certification scheme (which shall apply when incorporated by attachment to this Agreement).
- 33(p) The Parties agree to take account of any guidance issued by the Information Commissioner's Office. The Data Controller may on not less than 30 Working Days' notice to the Data Processor amend this Agreement to ensure that it complies with any guidance issued by the Information Commissioner's Office.
- 33(q) Where the Parties include two or more Joint Controllers as identified in Schedule 5 in accordance with GDPR Article 26, those Parties shall enter into a Joint Controller Agreement based on the terms outlined in Schedule 5 in replacement of Clauses 33(a)-33(p) for the Personal Data under Joint Control.

34 COUNCIL DATA AND PERSONAL INFORMATION AUDITS

- 34(a) Except where an audit is imposed on the Council by a Regulatory body, the Council may, acting reasonably, conduct an audit for the following purposes:
 - 34(a)(i) to review the integrity, confidentiality and security of the Council Data
 - 34(a)(ii) to review the Service Provider's compliance with the Data Protection Act 1998, the Freedom of Information Act 2000 in accordance with Clause 34 (Protection of Personal Data) and Clause 28 (Freedom of Information) and any other legislation applicable to the Services

- 34(b) The Council shall use its reasonable endeavours to ensure that the conduct of each audit does not unreasonably disrupt the Service Provider or delay the provision of the Services.
- 34(c) Subject to the Council's obligations of confidentiality, the Service Provider shall on demand provide the Council (and/or its agents or representatives) with all reasonable co-operation and assistance in relation to each audit, including:
 - 34(c)(i) all information requested by the Council within the permitted scope of the audit
 - 34(c)(ii) reasonable access to any sites controlled by the Service Provider and to any equipment used (whether exclusively or non-exclusively) in the performance of the Services
 - 34(c)(iii) access to Service Provider's Staff
- 34(d) The Service Provider shall implement all measurement and monitoring tools and procedures necessary to measure and report on the Service Provider's performance of the Service.
- 34(e) The Council shall endeavour to (but is not obliged to) provide at least 5 Working Days' notice of its intention to conduct an audit.
- 34(f) The Parties agree that they shall bear their own respective costs and expenses incurred in respect of compliance with their obligations under this Clause 34.
- 34(g) This Clause 34 shall not apply to any audit or inspection regarding the provision of the Services specified in the Service Specification or elsewhere in this Agreement which may be conducted as specified in this Agreement.

35 AGREEMENT STATUS AND TRANSPARENCY

- 35 (a) Further to the Local Government Transparency Code 2014 the Council is obliged to publish details of expenditure exceeding £500. The Parties acknowledge that, except for any information which is exempt from disclosure in accordance with the provisions of the FOIA, the content of this Agreement and any associated tender documentation provided by the Service Provider (the Tender Submission) is not Confidential Information. The Council shall be responsible for determining in its absolute discretion whether any of the content of the Agreement or the Tender Submission is exempt from disclosure in accordance with the provisions of the FOIA.
- 35(b) Notwithstanding any other term of this Agreement, the Service Provider hereby gives his consent for the Council to publish this Agreement and the Tender Submission in its entirety, including from time to time agreed changes to the Agreement, to the general public.
- 35(c) The Council may consult with the Service Provider to inform its decision regarding any exemptions but the Council shall have the final decision in its absolute discretion.
- 35(d) The Service Provider shall assist and cooperate with the Council to enable the Council to publish this Agreement and the Tender Submission.

36 DEPRIVATION OF LIBERTIES SAFEGUARDS

- 36(a) The Service Provider must always apply the principles of the Mental Capacity Act 2005 and the Deprivation of Liberty Safeguards. The Service Provider should always consult the relevant codes of practice for further detailed guidance. The Service Provider Manager is the managing authority for the purpose of the Mental Capacity Act: Deprivation of Liberty Safeguards (DOLS).
- 36(b) The Service Provider will comply with the conditions set as a result of DOLS Authorisation being given.

37 COMPLAINTS PROCEDURE

- 37(a) The Service Provider shall:
 - 37(a)(i) inform complainants that they may refer their complaint in respect of the services provided under this Agreement direct to the Council;
 - 37(a)(ii) promptly (and in any event within two Working Days of receipt) refer all Formal Complaints received in respect of the services provided on behalf of the Council under this Agreement to the Council for resolution and
 - 37(a)(iii) co-operate fully in any Council investigation into a complaint referred to the Council and provide any documents or information reasonably requested by the Council in relation to the complaint within the timescales specified by the Council.
- 37(b) The Service Provider shall operate a complaints procedure in respect of any services provided under this Agreement, to the entire satisfaction of the Council, and comply with the requirements of any regulatory body to which the Service Provider is subject (including any change in such requirements) and ensure that its complaints procedure meets the following minimum standards:
 - 37(b)(i) is easy to access and understand;
 - 37(b)(ii) informs complainants that they may refer their complaint in respect of services provided under this Agreement direct to the Council;
 - 37(b)(iii) clearly sets out time limits for the Service Provider to respond to complaints referred to it and for keeping the complainant and the Council informed of progress with such complaints;
 - 37(b)(iv) provides confidential record keeping to protect employees under this Agreement and the complainant
 - 37(b)(v) provides information to management so that services can be improved
 - 37(b)(vi) provides effective and suitable remedies
 - 37(b)(vii) is regularly monitored and audited and which takes account of complainant and Council feedback.
- 37(c) The Service Provider shall make its complaints procedure available upon request.
- 37(d) The Service Provider shall ensure that all its employees and persons employed in the performance of this Agreement are made aware of its complaints procedure.
- 37(e) Where the Service Provider is undertaking an investigation into a complaint, the Service Provider shall ensure that, under no circumstances, is the complaint investigated by a member of its staff who may be part of the complaint and that the investigation is carried out by someone who is independent of the matter complained of.
- 37(f) The Service Provider shall keep accurate and complete written records of all complaints received and the responses to them and shall make these records available to the Council on request or at 12 monthly intervals in any event.
- 37(g) The Service Provider should note that if a complaint is made to the Council by a third party relating to the goods, services or works provided on behalf of the Council under this Agreement, the Local Government Ombudsman has the power to investigate such a complaint and the Council requires the Service Provider to fully to co-operate in any such investigation. If the Council is found guilty of maladministration or injustice by the Local Government Ombudsman because of the act or default of the Service Provider the

Service Provider shall indemnify the Council in respect of the costs arising from such maladministration or injustice.

38 NOTIFICATION

- 38(a) The Service Provider will inform the Council's First Point of Contact immediately (normally the first working day) and confirm by email within 3 working days if any of the following occur:
 - 38(a)(i) hospital admission of a Service User
 - 38(a)(ii) the death of a Service User receiving the Service
 - 38(a)(iii) a formal written complaint received from the Service User
 - 38(a)(iv) allegation of or actual abuse to a Service User
 - 38(a)(v) disappearance of a Service User
 - 38(a)(vi) any circumstances where a Service User has refused provision of the Service
 - 38(a)(vii) significant change to the physical or mental condition of the Service User
 - 38(a)(viii) major injury to a Service User as defined in the "Reporting of Injuries Diseases and Dangerous Occurrences" Regulations 1995
 - 38(a)(ix) allegation of or actual racial harassment or discrimination
 - 38(a)(x) any other serious issues causing concern about the well being of a Service User.
- 38(b) The Service Provider will notify the Council's Contracts Manager by email of inspection reports carried out by the Registration Body within 3 days of the final report being received by the Service Provider. If the draft inspection report indicates an overall rating of "Inadequate" the Service Provider will notify the Council immediately.

39 SAFEGUARDING

- 39(a) The Parties acknowledge that the Service Provider is a Regulated Activity Provider with ultimate responsibility for the management and control of the Regulated Activity provided under this Agreement and for the purposes of the Safeguarding Vulnerable Groups Act 2006. The Service Provider shall:
 - 39(a)(i) ensure that all individuals engaged in the provision of the Service or activity, and prior to commencing the provision of the service or activity, are subject to a valid enhanced disclosure check undertaken through the Disclosure and Barring Service including a check against the adults' barred list or the children's barred list, as appropriate; and
 - 39(a)(ii) monitor the level and validity of the checks under this Clause 40(a) for each member of the Service Provider's Staff.
- 39(b) The Service Provider warrants that at all times for the purposes of this Agreement it has no reason to believe that any person who is or will be employed or engaged by the Service Provider in the provision of a Service or activity that is a Regulated Activity is barred from the activity in accordance with the provisions of the Safeguarding Vulnerable Groups Act 2006 and any regulations made thereunder, as amended from time to time.
- 39(c) The Service Provider shall immediately notify the Council of any information that it reasonably requests to enable it to be satisfied that the obligations of this Clause 40 have been met.
- 39(d) The Service Provider shall refer information about any person carrying out the Services or the activity to the Disclosure and Barring Service where it removes permission for such person to carry out the Services or activity (or would have, if such person had not otherwise ceased to carry out the Services or the

- activity) because, in its opinion, such person has harmed or poses a risk of harm to the Service Users, children or vulnerable adults.
- 39(e) The Service Provider shall not employ or use the services of any person who is barred from, or whose previous conduct or records indicate that he or she would not be suitable to carry out Regulated Activity or who may otherwise present a risk to Service Users.
- 39(f) Where the service requirement or specification specifies that the Service or activity to be provided under this Agreement involves a Regulated Activity, or the Council otherwise notifies the Service Provider, acting reasonably, that the Service Provider's Staff are required to be subject to a Disclosure and Barring Service check, the Service Provider shall comply with Clause 40(a) above.

40 COUNTERPARTS

- 40(a) This Agreement may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.
- 40(b) Transmission of the executed signature page of a counterpart of this Agreement (a) by fax or (b) by e-mail (in PDF, JPEG or other agreed format) shall take effect as delivery of an executed counterpart of this Agreement. If either method of delivery is adopted, without prejudice to the validity of the agreement thus made, each party shall provide the others with the original of such counterpart as soon as reasonably possible thereafter.

41 ENTIRE AGREEMENT

This Agreement, the schedules and the documents annexed to it or otherwise referred to in it together with any individual care agreement as appropriate issued in connection with this Agreement contain the whole agreement between the parties relating to the subject matter hereof and supersede all prior agreements, arrangements and understandings between the parties relating to the subject matter.

42 CONFLICT OF TERMS

If there is any ambiguity or inconsistency in or between the Agreement Documents the Council shall determine, at its sole discretion, the priority of the documents.

43 EMERGENCY PLANNING

The Service Provider will ensure that it has business continuity plans in place for a range of emergency situations should they arise for example pandemic influenza, power cuts etc.

The Specification: Service Delivery & Standards

RECOVERY NURSING BEDS TO SUPPORT HOSPITAL ADMISSION AVOIDANCE and HOSPITAL DISCHARGE

The Specification sets out the specific Recovery Nursing Beds service, core nursing service and associated expectations regarding standards of delivery across all elements of the Service.

SCHEDULE 1: SERVICE DESCRIPTION: RECOVERY NURSING BEDS

The Service must provide a care home based short term nursing service that focuses on rehabilitation and/or enablement in support of hospital admission avoidance, and discharge from hospital for Pathway 2 and Pathway 3 Service Users

1.0 RECOVERY NURSING BED SERVICE AIMS

- 1.1 The Council and the Service Provider agree that the aims of this Service are to:
 - 1.1.1 maximise people's capacity for independent living.
 - 1.1.2 increase the number of people able to remain living at home.
 - 1.1.3 reduce the number of people permanently admitted to long term care.
 - 1.1.4 reduce admissions and readmissions to hospital
 - 1.1.5 where the referral relates to Service Users leaving hospital, support timely discharge from Hospital (SATH) so that the Service User can move to a more appropriate location for assessment of their future needs.
 - 1.1.6 provide an environment which helps people meet their rehabilitation and reablement potential and to become as functionally independent as possible,
 - 1.1.7 provide a competent, skilled workforce who will support and encourage Service Users to achieve their optimum functional independence, within agreed care plans.
 - 1.1.8 provide a supportive care environment whereby some degree of recovery/recuperation can take place allowing a more accurate assessment of ongoing care needs
 - 1.1.9 build on current collaborative working with Shropshire health and social care colleagues to meet agreed milestones and goals.

2.0 THE RECOVERY NURSING BED SERVICE TO BE PROVIDED BY THE SERVICE PROVIDER

- 2.1 The Council and the Service Provider agree that in the provision of the Service the Service Provider will:
 - 2.1.1 have available **SEVEN** dedicated beds at the Home for the provision of the Service and are able to accept admissions 7 days a week between 9am to 6pm. Of the seven beds, five will operate as general nursing recovery beds; two as nursing recovery beds with dementia care. The nursing recovery beds with dementia care will be located within an appropriate dementia unit within the Home.
 - 2.1.2 respond to the varied needs of different Service Users, giving regard to needs arising from; acute illness (that can be managed without the requirement for hospital care), significant reduction in ability to live independently, nursing needs, dementia.
 - 2.1.3 be expected to provide person centred support and follow the guidance of the Equality Act 2010 in taking into account wherever possible ethnicity, culture, beliefs, special needs and gender specific concerns when meeting need and care planning.
 - 2.1.4 communicate with Service Users, families and carers that the Service Users stay at the placement is short term whilst they are supported with ongoing recovery and assessments. It is fundamental that the Service Provider explains to Service Users and their family / carers that they will not be able to remain in the bed long term and that there is an expectation that wherever possible individuals will return to their own homes to rebuild their independence. If in exceptional circumstances, the individual is unable to return to their previous arrangements the Service

- Provider must ensure that all decisions will be explored fully in partnership with their ICS Case Manager.
- 2.1.5 ensure Service Users are admitted and supported in a way that facilitates a thorough assessment of all their needs and empowers the Service User wherever possible to 'do for themselves' moving away from a more traditional 'do for' approach to the delivery of their care.
- 2.1.6 ensure that within 48 hours of admission of the Service User to the bed they receive a full and thorough assessment of their rehabilitation and/or enablement needs and development of their individualised holistic rehabilitation/enablement plan and goals. If the outcome of this initial assessment is that the Service User's rehabilitation and/or enablement needs can be safely and effectively met at their home the Service User will be discharged from the Home and arrangements made for timely transfer to Pathway 1 'home based rehab and enablement'.
- 2.1.7 provide a therapeutic environment for assessment which is more relaxed and appropriate in which to engage with family and friends to enable informed long term care decisions to be made if required.
- 2.1.8 has a "enabling" ethos that promotes the short-stay nature of the assessment and therapeutic offer and emphasises independence so that Service Users have the best opportunity to meet their rehabilitation and re-enablement potential in a safe and supported environment initially.
- 2.1.9 facilitate access to the Service Users by the Designated GP and appropriate therapists as and when required
- 2.1.10 facilitate and work towards discharging Service Users within a maximum period of up to 6 weeks from the date of their admission to the Home.
- 2.1.11 wherever possible, actively encourage Service Users to participate in social and planned interactive activity sessions within the Home to meet emotional and psychological needs.
- 2.1.12 where appropriate seek the assistance of the Council's assisted technology team and help Service Users trial pieces of assisted technology in the Home that they could use in their home / regular care setting and which will assist with a safe discharge from the Service
- 2.1.13 work with the Council's ICS Team to review goal plans, feedback progress and if required assist Service Users and/or their family to visit and review their future placement, step down, options and manage the Service User's expectations to discharge within 6 weeks of being admitted to the Home.
- 2.1.14 provide the Service User with information about the Home and Service in accordance with Schedule 2 Paragraph 8.0.
- 2.1.15 ensure that each Service User will have an assigned case manager and will be supported by Designated GP for the period they are in the Home.
- 2.1.16 provide access to contact the practitioner if requested by the Service User at any point during their admission to the placement.
- 2.1.17 always make available a Service Provider representative who will be expected to attend and participate within the weekly Service MDT meeting, attended by a representative of the Council's ICS Team, the Designated GP and other care and health practitioners as appropriate, to discuss

- the Service Users' progress against the agreed re-enablement goal, nursing care plan, Individual Care Plan and estimated date of discharge.
- 2.1.18 ensure that each Service User has an Individual Care Plan which includes a therapeutic reenablement plan with goals, progress records, outcomes and review dates. This will be jointly monitored daily and reviewed weekly between the Service Provider, the ICS Case Manager and wherever possible with the individual and those closest to them to ensure that discharge planning remains on track and within the planned time frame of up to six weeks.
- 2.1.19 ensure that all Service Users' progress will be proactively managed along the agreed care pathway with records of accountability and governance made for agreed actions and reviews.
- 2.1.20 ensure all Service Users will have a baseline weight and Waterlow score recorded within 24 hours of the Service User's admission and at planned weekly intervals and prior to planned discharge date; and if the Service User is receiving enteral or supplementary feeds to be reviewed with the Community Dietician as to frequency of recorded weights and monitoring.
- 2.1.21 identify with the ICS Case Manager if Service Users need access to any additional postural or therapeutic/functional equipment to support the safe implementation of the Individual Care Plan. The ICS case manager will ensure that the additional equipment is made available as requested, and log all requests and resourced items.

3.0 MEDICAL CARE

- 3.1 The Service Provider will ensure that:
 - 3.1.1 once a Service User has been admitted to the Home medical cover is provided by the Designated GP.
 - 3.1.2 Service Users will be registered with the Designated GP who will be responsible for providing their medical care, in hours, Monday to Friday, during the period that the Service User is in receipt of the Service at the Home.
 - 3.1.3 all Service Users are reviewed by the Designated GP within 48 hours of admission to the Home, or sooner if the Service Provider feels that their medical condition requires it. The Designated GP will be a required member of the Council's MDT and will attend the weekly MDT meeting. The Designated GP will also be available in-hours (Monday to Friday) and the Service Provider should seek support or guidance whenever it is felt that GP input could contribute to Service Users timely discharge from the home.
 - 3.1.4 the out of hours GP services are used for any medical issues which occur after 5.30pm on Monday to Friday and between 5.30pm on Friday to 08.30 am Monday.
 - 3.1.5 it contacts the MDT, Designated GP and ICS Case Manager should a Service User have a rapidly deteriorating condition whereby "Fast Track" Continuing Health Care consideration is required.

4.0 MEDICATION

- 4.1 The Service Provider will ensure that:
 - 4.1.1 it has policies and procedures in place for the receipt, recording, storage, handling, administration and disposal of medicines in accordance with:

- The Handling of Medicines in Social Care Settings by The Royal Pharmaceutical Society of Great Britain 2007 or subsequent revisions; and
- Professional advice documents from registration authorities and Care Standards, including
 The Administration of Medicines in Care Homes, Medicine Administration Records (MAR) In
 Care Homes and Domiciliary Care, and the Safe Management of Controlled Drugs in Care
 Homes or subsequent revisions.
- 4.1.2 Staff understand that policies and procedures listed above and adhere to them
- 4.1.3 its policy for medicines administration will include procedures to ensure that Service Users are able to take responsibility for their own medication if they wish, within a risk management framework and the Home's policies and procedures will protect Service Users in doing so.
- 4.1.4 all changes to prescribed medication are clearly documented as part of the discharge information provided to their Normal GP and, where the Service User is in receipt of formal care their care agency or the care home at which they usually reside.
- 4.1.5 the information relating to medicines sent from GP practices or other care settings is accurately checked, before it is recorded, to ensure that it relates to the Service User for which the medicines information has been sought.
- 4.1.6 all known allergies, including food intolerances, must be noted appropriately and prominently for each Service, and be included in the discharge information to person(s) who provide informal care, their Normal GP and, where the Service User is in receipt of formal care, their care agency or the care home at which they usually reside.

5.0 REFERRALS INTO THE SERVICE AND RESPONSE TIMES

- 5.1 The hospital discharge and admission avoidance pathways which this Service is part of are set out in Appendix 1.The Council and the Service Provider have agreed that the Service is for Service Users who:
 - 5.1.1 need a place to recover from the impact and consequences of an acute illness or episode before an assessment can be made about their potential requirement for long term care. This will include Service Users with a cognitive impairment.
 - 5.1.2 will have their needs fully assessed and risks to identify the long term care and support which they might require following guidance under the Care Act 2014
 - 5.1.3 with regard to the hospital discharge pathway, are an adult, in hospital, predominantly aged over 65 years (but could be younger in exceptional circumstances) who have completed their acute episode of care but are unable to return home in the short term, or to their usual place of residence unsupported. This includes Service Users that may have a cognitive impairment and need specialist support and/or exhibit altered behaviour.
 - 5.1.4 are likely to be frail with multiple co-morbidities and could require access to 24 hour nursing care.
- 5.2 All referrals into the Service / to the Service Provider will be made direct from the Council's ICS Team and a basic Assessment of Need, the FFA will be provided. If Service Users lack capacity a separate capacity assessment and best interests decision will also be completed. For complex discharges from hospital the ICS Team will complete full social care assessments and associated paperwork..
- 5.3 The Service Provider is expected to accept all referrals into beds in the Service on the basis of a "trusted assessment" of the Service User as being appropriate and eligible for the Service. For the

- avoidance of doubt there will be no requirement by the Service Provider to visit the potential Service User in Hospital or in their own home, to undertake an assessment, before accepting the referral.
- 5.4 At the Commencement Date of the Agreement the Service Provider will provide details of their named point of contact for referral of potential Service Users. This named individual(s) will be at the Home, available and responsible for receiving Service User referrals 7 days a week between 9am to 6pm.
- 5.5 The Service Provider will immediately (no later than the next day) notify the Council once the Service Provider becomes aware that a bed within the service is to become vacant.
- 5.6 The Service Provider shall immediately (no later than the next day) notify the Council if a bed in the Service becomes vacant at short notice.
- 5.7 When beds within the Service are available the Service Provider will arrange for planned transfer of the identified Service User within a maximum of 24 hours of receiving the referral.
- 5.8 If the Service Provider fails to admit an agreed referral within 24 hours or rejects an appropriate referral from the Council and as a result beds in the Service are not occupied the Council may reduce the amount payable for that bed under this Agreement

6. STAFFING / SKILL MIX AND COMPENTENCIES

- 6.1 The Staff will be recruited; trained, supervised and deployed, and have the experience and qualifications, as set out in Schedule 3 Paragraph 4 Staffing
- 6.2 The Service Provider and the Council have agreed:
 - all Service Users transferred to the Home will be adults and most will be elderly but some will
 have more complex issues than others. The Service Provider will provide nursing and care Staff
 cover at all times to respond to Service User who have the highest level of need, including those
 with cognitive impairment.
 - the Service Provider must ensure that the team Staff deployed within the Home to deliver the Service have the skill, training and qualification mix to respond to the fluctuating dependency levels of different Service Users
 - the Service Provider will ensure that there is 24 hour nurse and care support dedicated to the Service that has the competency and experience to support the rehabilitation and enablement focus of the Service Users in the Recovery Nursing Beds.
 - the Service Provider will ensure that staffing levels relating to the Service at the Home will, at all times, reflect the needs of individual Service Users. The Service Provider will have clear and transparent processes for assessing and determining the staffing levels and roles required to provide the Service.
 - the Service Provider will be mindful of the need to ensure the training and competency of nursing Staff, in particular, in relation to use of syringe drivers and will implement an action plan to address any gaps.
 - the Service Provider will be mindful of the need to ensure that all Staff supporting Service Users with dementia care needs have appropriate training, expertise and experience.

• Service Users will receive a high quality Service that reflects outcome based care and support in a safe and supportive staffing environment using evidence based nursing practices which meet all professional care standards.

7.0 TRANSPORT FROM HOSPITAL

- 7.1 For Service Users being discharged from hospital, the Shropshire Clinical Commissioning Group Patient Transport Service at the hospital will provide transport for: -
 - 7.1.1 admission to the Service Providers Care Home from hospital
 - 7.1.2 scheduled out-patient appointments/care assessments whilst at the Home.(The Service Provider is responsible for booking this transport)
 - 7.1.3 For the avoidance of doubt the Patient Transport Services will not be available for:
 - any other activity such as planned visits to alternative care home sites, or social activity.
 - discharge from the Home after the Service User has received the Service to return the Service
 User to their own home or another appropriate care provision.
 - 7.1.4 In these instances, the Service Provider will initially seek assistance from the Service Providers family to assist where possible, and if family or friends are unable to provide transport, advise should be sought from the relevant ICS Case Manager.

8.0 DISCHARGE FROM THE SERVICE

- 8.1 The Service Provider will ensure that each Service User will be reviewed and assessed for a planned discharge if:-
 - 8.1.1 they are assessed to have met the rehabilitation/reablement goals in their Individual Care Plan
 - 8.1.2 they have been assessed as having their rehabilitation/reablement needs better met in a Pathway
 - 8.1.3 the ongoing needs of the Service User can be met at home with or without ongoing community health and social care support.
 - 8.1.4 a transfer to alternative care is required to meet specific identified nursing or care needs; or
 - 8.1.5 long term care needs are identified that are more appropriate to provide in another environment
- 8.2 Planned discharge will be facilitated by the relevant ICS Case Manager in liaison with the MDT and the Service Provider. Where ongoing care or support is needed the discharge can only be facilitated following approval of required funding by the social work team working in conjunction with the ICS Team Manager and ICS Case Manager.

9.0 RECOVERY NURSING BEDS SERVICE OUTCOMES AND DAILY REPORTING

- 9.1 The Service Provider and their Staff will be responsible and accountable for directly informing the ICS Team Manager and relevant ICS Case Manager at the earliest point they become aware of any Service User and/or their family members expressing their interest to scope remaining in the care home bed for any time beyond the maximum 6 weeks length of stay.
- 9.2 The Council's ICS Team need to be kept updated on a daily basis on progress of the Service. The Service Provider will ensure that it records the following information for each Service User detailing as a minimum (in able an easy to read table format) the following information:

Reason in Hospital (reference Service Users discharged from hospital)

Reason for Admission to Hospital

(reference Service Users discharged from hospital)

Date Assessments undertaken

Initial Assessment of Needs/FFA

Assessment of activities of daily living

Weight (on arrival and discharge)

Waterlow (on arrival and discharge)

GP review

Medication review

OT assessment

Physio assessment

Exploration of assisted technology

Date of referral to Lets Talk Local

Facilitation of a home or alternative placement visit

Length of stay in the Home to date

Fit to transfer out of the Service date

7 days prediction of forthcoming discharge

Reason for any delays in being transferred out of the Home

Service User outcomes (inc returned home, transferred to another home, Date of Death if relevant)

Date of Discharge from the Home

Future living arrangements ie Home/Residential Home/Nursing Home

- 9.3 This information must be emailed daily by 8.30 am (at the latest) to the ICS Team Manager.
- 9.4 The Parties acknowledge that with regard to the data set out in 9.2 provision of the information may sometimes be dependent upon action or data required from the ICS Team or Hospital and in these circumstances the Provider will not be held responsible for particular data which it is unable to provide.
- 9.5 The Service Provider will immediately notify the ICS Team Manager
 - 9.5.1 of any outbreak of infections that may impact on capacity/accessibility to the Service.
 - 9.5.2 any delay of discharge of a Service User from the service

SCHEDULE 2: SERVICE DESCRIPTION: NURSING CARE SERVICE

The Service Provider will ensure that the following core nursing care provision is provided as part of the Service to each Service User;

1.0 CORE SERVICE ELEMENTS

1.1. Accommodation

Accommodation provided by the Service Provider shall:

- 1.1.1 be appropriate as agreed for each individual Service User, be within a single room that shall be comfortable and appropriate for social care, personal care and nursing care, giving particular regard to dementia care needs, with the room being provided for nursing with dementia care being located on a dedicated dementia wing or unit. The Service User's rooms must be appropriately furnished to a reasonable standard of comfort. Fixtures and fittings to be fit for purpose, robust and suitable for the needs of the Service User. Temperatures in Service User's rooms should be controllable and be kept at relevant temperatures to reflect the Service User's preferences and requirements. Service Users should be encouraged to bring personal belongings as appropriate on admission in agreement with the Service Provider.
- 1.1.2 have communal areas of the Home which are decorated and furnished to a good standard in a non-institutional manner and be maintained at appropriate temperatures. Gardens and grounds must be well maintained and accessible to Service Users
- 1.1.3 include easy access to bathing washing and toilet facilities as necessary
- 1.1.4 include domestic services including regular cleaning of Service User's rooms and bed making daily.

 Service Users should be encouraged and permitted to dust and tidy rooms if they wish.
- 1.1.5 include sufficient bed linen (for warmth and comfort) and towels for each Service User. Service Users should have access to a constant supply of clean towels and flannels for their individual use
- 1.1.6 include laundry facilities (to provide a laundry service for personal items and the general laundry of the home)
- 1.1.7 include use of equipment relating to the implementation of the Assessment of Needs/FFA and subsequent reviews.
- 1.1.8 include access to communal television radio newspapers and private access to a telephone

It has been agreed between the Council and Service Provider that.

- 1.1.9 no holding fees will be charged
- 1.1.10 allocation of a room to a Service User implies a licence to occupy a room and would normally be for the full period of occupation of the Service User.
- 1.1.11 If a Service User requests a change of room or if the needs and requirements of the Service User change the Service Provider must liaise with the relevant ICS Case Manager
- 1.1.12 In exceptional circumstances, in the event of redecoration the Service Provider may with the Council and Service Users agreement move the Service User on a temporary basis (without there being any additional charge to the Council or Third Party) to facilitate the completion of the work

1.2 Meals and Beverages

The Service Provider will ensure that:

- 1.2.1 all meals and beverages it provides for service Users shall
 - include all meals snacks and non-alcoholic beverages (to include breakfast lunch tea and supper with snacks and drinks available freely on request)
 - consist of a healthy nutritious balanced menu which offers a choice and reflects the views and preferences of the Service Users which shall include hot and cold options, special diets vegetarian

meals and those reflecting a cultural preference

- 1.2.2 Service Users are actively consulted about what food they like or dislike and what food and drinks are provided and their availability in the Home. They should also be encouraged to prepare drinks and snacks for themselves where appropriate.
- 1.2.3 Staff receive adequate training to identify and respond in a timely and appropriate manner to nutritional and hydration issues relating to the Service Users
- 1.2.4 it encourages the Home to achieve any healthy eating award administered by their local area council

1.3 Personal Care

- 1.3.1 The Service Provider will ensure that:
 - 1.3.1.1 personal care is of a high standard and delivered in a person centred way promoting choice based on personal preferences.
 - 1.3.1.2 personal care is offered at a level the Service User considers acceptable and as defined in the Assessment of Needs/FFA. This shall include (if required) assistance with
 - Dressing
 - Washing (including hair)
 - Bathing
 - Taking to the toilet (including the management of catheters and the provision and changing of incontinence pads).
 - Shaving
 - Eating and drinking
 - Finger and toe nail care
 - Oral hygiene
 - 1.3.1.3 where a Service User is unable to purchase basic requirements to maintain personal hygiene the Home will ensure that the personal hygiene needs of the Service Users are met within the Payments
 - 1.3.1.4 Personal Care should include access to incontinence services and aids provided by other agencies
 - 1.3.1.5 minor repairs to clothing are inclusive in the Payments.
- 1.3.2 The Council does not encourage the charging of Service Users for additional services. However where additional services are offered a scale of charges must be displayed within the Home (and made clear in the terms and conditions given to the Service Users). Such services may include:
 - hairdressing
 - · dry cleaning
 - exceptional trips (that are not part of everyday life)
 - non-basic toiletries
 - major clothing repairs
 - chiropody
 - alcoholic beverages
 - cigarettes

- replacement clothing (unless the originals have been lost by the Service Provider)
- · personal copy of a news paper
- alternative therapies

and the costs for these may be met by way of Service User or in agreement in advance from another paying party.

1.4 Nursing Care

In the provision of nursing care the Service Provider will ensure that:

- 1.4.1 The organisation and provision of nursing care should be Service User centered and be efficient effective and systematic in its approach to nursing practice.
- 1.4.2 The care is be assessed, managed and evaluated, and where appropriate, provided by a Registered Nurse using an appropriate model of care.
- 1.4.3 The nursing care service gives regard to the physical social personal psychological and spiritual needs of the Service User
- 1.4.4 The nursing care service takes a holistic approach to the care of an individual and gives regard to the people that matter most to the Service User
- 1.4.5 Nursing and personal care should be of a high standard. It should be offered to a level the Service User and where appropriate, their family, considers acceptable.
- 1.4.6 The following are provided as part of nursing care
 - Nursing input and support to personal (as described in Schedule 2 Paragraphs 1.3) and social care as described in Schedule 2 Paragraphs 1.5)
 - Pain and symptom control
 - Wound care
 - Infection control
 - Elimination (including the management of catheters and colostomy bags etc.)
 - Nutrition and diet including parental feeding
 - Administration of medications
 - Invasive care e.g. Tracheotomy; PEG feed; Stoma bags

1.5 Social Care

In the provision of social care the Service Provider will ensure that:

- 1.5.1 the Home has social facilities as part of a homely environment such as TV and board games and also organizes social activities within the Home or away from the Home which would constitute part of an ordinary lifestyle e.g. shopping trips, walks, visits to church, mosque or temple
- 1.5.2 Service Users are encouraged to follow (where possible) their chosen life style which should include leisure and social pursuits and allow them the opportunity to meet their spiritual needs
- 1.5.3 Service Users have the right to choose and wear their own clothes which should be clean and in good repair at all times. Minor repairs are the responsibility of the Service Provider.
- 1.5.4 Where appropriate Service Users are encouraged to go on shopping trips or have access to a shopping facility to purchase personal items. If an additional cost is incurred a charge equivalent to the hourly Staff rate may only be made where it has been agreed in advance with the Service User/family or ICS

- Case Manager as appropriate. Shopping for special occasions such as Christmas and Easter should not incur an additional charge.
- 1.5.5 Service Users' visitors are welcome at all reasonable times. There should be access to facilities for Service Users and visitors to have access to or make drinks. Where required the Service Provider should make available for families and other visitors, a private area which is free from interruption.
- 1.5.6 any costs incurred by the Service Provider in the arrangement of transport and escorts as necessary to enable the Service User to access external social activities must be agreed by the Service User (or paying party) in advance.
- 1.5.7 where external activities or a specific day service is agreed as part of the assessment process the Council may meet the additional cost of transport and in these circumstances this will be detailed in the Assessment of Need/FFA.
- 1.5.8 the Service Provider will in the first instance seek the assistance of Service User's family members or friends or the appropriate heath provider to transport the Service User to meet health needs. Where Staff must accompany the Service User, this expectation will be agreed as part of the Individual Care Plan and the Service Provider will not make a charge for this arrangement. Where the expectation that Staff accompany the Service User is not set out in the Individual Care Plan and the Service User wishes to be accompanied by a member of Staff an additional charge equivalent to the relevant hourly Staff rate may be made to the Service User only where it has been agreed in advance with the ICS Case Manager.
- 1.5.9 access to the provision of aids and equipment is which may enhance the quality of life of the Service Users is arranged in line with the Assessment of Needs and Individual Care Plan.

1.6 Infection Control

The Service Provider will ensure that it complies with the Registration Body guidelines regarding infection control and that

- 1.6.1 infection control management is an integral part of the overall management of the Home
- 1.6.2 infection control guidelines are available at the Home and Staff are trained to follow them
- 1.6.3 a protocol is available highlighting basic principles of risk assessment in relation to microbiological hazards
- 1.6.4 cleaning schedules are available covering all equipment and the environment to ensure good standards of general hygiene are maintained throughout the Home
- 1.6.5 correct facilities are available to enable Staff, Service Users and visitors to decontaminate their hands appropriately
- 1.6.6 clinical care guidelines and guidelines on decontamination of equipment reflect current evidence based infection control guidelines
- 1.6.7 facilities are available at the Home to manage waste and dirty linen in accordance with the legal and infection control requirements
- 1.6.8 it can produce evidence of planned and regularly updated training for all Staff in infection control
- 1.6.9 the correct adequate disposable protective equipment is provided to Staff for their use.
- 1.6.10 allows reasonable access to independent professionals to carry out an infection control audit of the home and acts upon the findings and recommendations of the audit.

1.7 Service Users' Finances

- 1.7.1 Service Users should be free to take responsibility for their own finances if able to do so.
- 1.7.2 Where the Service User is unable to manage their finances unaided the Service Provider will provide appropriate support as detailed in the Individual Care Plan
- 1.7.3 Where the Service Provider holds or handles money on behalf of Service Users arrangements must be in place to ensure the Service Users money is held safely and clear records are kept of all transactions, such records to be made available to the Council for inspection on request
- 1.7.4 No additional charges or costs shall be made to the Service User by the Service Provider for any services provided under this Agreement. .
- 1.7.5 The Service User's Personal Allowance is not to be used for the purchase of or contribution towards any part of the Service required to be provided under this Agreement and the Service User's Personal Allowance should be available to the Service User to spend as they choose
- 1.7.6 The Council does not encourage the charging of Service Users for additional Services not provided under this Agreement. However where additional services are offered, a scale of charges must be displayed within the Home (and made clear in the terms and conditions given to the Service Users) and the costs for these may be met by way of Service User's Personal Allowances or in advance from a paying party in agreement with the Care Manager
- 1.7.7 Where the Service User is unable to make decisions and has no family with whom arrangements have been made to manage the money which are satisfactory to the ICS Case Manager in accordance with the Assessment of Needs the ICS Case Manager may require the Service Provider to collect state benefit or entitlement on behalf of the Service User
- 1.7.8 If the Service Provider is required to collect state benefit or other entitlement on behalf of a Service User either
 - the Service User receives any Personal Allowance or
 - proper arrangements are made in agreement with the Service User or their nominated representative for the safe-keeping of such Personal Allowance
- 1.7.9 The Service Provider shall at all times ensure that any money or personal effects owned by the Service User are recorded on the Service User's admission and any such effects which are subsequently stored by the Service Provider on behalf of the Service User are clearly labelled as to ownership and are stored securely at all times.

1.8 Equipment and Materials

The Service Provider will ensure that appropriate equipment and materials should be available to facilitate high quality personal and nursing care for each Service User in accordance with the Assessment of Needs/FFA and subsequent reviews. This must include the following:-

1.8.1 a range of pressure relieving aids and devices obtained from the relevant agency.

- 1.8.2 all the equipment required to ensure safe handling and movement of Service Users.
- 1.8.3 a range of aids to daily living and to support personal and nursing care.
- 1.8.4 suction equipment and airways
- 1.8.5 the required oxygen storage facilities for its use as a prescribed commodity
- 1.8.6 equipment to deliver pain relief to include syringe drivers. The Service Provider should ensure that there is a member of Staff on duty at the Home 24 hours a day who is competent and trained to operate the syringe driver

2.0 RIGHTS OF SERVICE USERS

2.1 Core Rights

Service Users have the right to:-

- 2.1.2 Be encouraged to exercise personal independence and choice
- 2.1.3 Have their personal dignity respected, and be treated with respect and politeness
- 2.1.4 Have their cultural social religious and emotional needs respected
- 2.1.5 Have access to all personal information held by the Service Provider and are made aware of the procedures for maintaining confidentiality
- 2.1.6 Participate in formulating their own Assessment of Needs/FFA/Individual Care Plan
- 2.1.7 Participate in any reviews or re-assessment of their needs
- 2.1.8 Receive a non-discriminatory service
- 2.1.9 Receive assistance to maintain personal skills
- 2.1.10 Have access to an independent advocacy service who can offer representation and advice as appropriate
- 2.1.11 Complain or make compliments about the Service
- 2.1.12 Maintain their entitlements associated with citizenship.
- 2.1.13 Have the right to be involved in any decision-making process as it affects them including the right to refuse reasonably a part of the Service and to comment on the Service under this Agreement by means of an independent representative if necessary without fear of reprisal

2.2 Dignity

The Service Provider shall:

- 2.2.1 recognise the intrinsic value of people regardless of circumstances by respecting their uniqueness and their personal needs including the right to decide how they wish to be addressed.
- 2.2.2 give consideration to the gender and ability of the Staff assisting in intimate care tasks must be considered to avoid embarrassment and discomfort of both the Staff and the Service User
- 2.2.3 make provision for Service Users from ethnic religious or cultural groups (this will be identified in the individual Assessment of Needs/FFA) and the Services will be arranged in agreement with the Service Provider the Council and the Service User. This should include participation by the Service User in religious and cultural festivals as appropriate.
- 2.2.4 ensure compliance with any special customs and services associated with the death of a Service User

2.3 Independence

The Service Provider shall ensure that

2.3.1 the Service User will have the opportunity to act and think without reference to another person including

- a willingness to incur a degree of calculated risk provided that does not place another person at risk or in breach of the Service Provider's obligations under legislation.
- 2.3.2 all Service Users have the right to appropriately express their sexuality although the Service Provider will also recognise the vulnerability of Service Users to sexual exploitation.
- 2.3.3 each Service User has the right to take part in any decision about life within the Home and shall be consulted about any significant changes proposed

2.4 Choice

The Service Provider will ensure that Service Users will:

- 2.4.1 be given the right to personal choice regarding daily routines including times to go to bed and to get up; choice of meals, snacks and drinks and the freedom to choose where and when to eat meals
- 2.4.2 have the opportunity to make their own choices in respect of their care where appropriate.
- 2.4.3 have the right to access services provided flexibly for their benefit in the least restrictive way possible.
- 2.4.4 where appropriate be free to administer their own medication in accordance with guidelines issued by the Registration Body from time to time

2.5 Fulfilment

The Service Provider will ensure that Service Users:

- 2.5.1 have the right to realise their personal aspirations and abilities in all aspects of daily life
- 2.5.2 are encouraged and enabled to maintain links with family friends carers and communities and enter into activities in the wider community.
- 2.5.3 ensures the Service meets cultural emotional spiritual and sexual needs with understanding and support as necessary

2.6 **Security**

The Service Provider will ensure that the Home is an environment which affords the Service User protection and security

2.7 **Privacy**

The Service Provider will ensure that Service Users have:

- 2.7.1 the right to privacy i.e. to be left alone or undisturbed including the right to invite guests into their room, receive post unopened and receive private phone calls
- 2.7.2 the right to be free from intrusion or public attention in their affairs
- 2.7.3 awareness of and access to their personal records and the procedures for maintaining confidentiality
- 2.7.4 private access to a telephone and private space to receive visitors

3.0 REFERRALS TO THE HOME

Referrals to the Home shall be made in accordance with schedule 1 section 1.5 Referrals into the Service and response times

4.0 ADMISSION TO THE HOME

Upon admission to the Home the Service Provider will ensure that:

- 4.1. appropriate information about the Service User is recorded in a logical organised and timely fashion and shall include:
 - Service User's name and address, next of kin details, Normal GP details, Social Worker details, wishes
 upon death, date of admission to the Home, religion, gender, ethnic origin, spiritual preference (where

shared)

- the previous medical history, critical incidents and also current medication and where appropriate the recording of visual findings on arrival of the Service User at the Home (i.e. a Waterlow, risk assessment and body chart)
- life details including likes and dislikes (activities)
- care plans, specialist assessments, risk assessments
- mobility and moving and handling assessment
- risk assessments (general and specific)
- photograph of the Service User (if they are in agreement)
- inventory of belongings and or monies held or managed on the Service User's behalf
- daily report
- daily living aids (i.e. glasses, hearing aids, consent for use of bed rails etc.)
- assessments (including incontinence) and professional reports and visits
- dietary requirements
- LPA/Advanced Care Plan and Living Will as appropriate
- 4.2 the requirements above are audited by the Service Provider on a regular basis to ensure that a consistent approach within the Service and the information is kept up to date. A record of the audit will be kept and held at the Home.
- 4.3 written permission is sought from the Service User to allow the Council access to the Service Users care file for monitoring purposes (as detailed in paragraph 9 in Schedule 3)
- 4.4 Service Users are registered with local health services if appropriate

5.0 REVIEW OF THE SERVICE TO INDIVIDUALS AND CARE MANAGEMENT

- 5.1 Ongoing review and care management of Service Users in the Recovery Nursing Beds is an intrinsic part of the Service as described in Schedule 1, The Recovery Bed Service to be Provided by the Service Provider
- 5.2 During the ongoing review and care management it is agreed that the Service Provider shall
 - if requested, allow the Council (and other Health and Social Care professionals included in the assessment and care management process) access to the Service User in private.
 - support the Service User, and where appropriate their family and friends, to participate in assessments and reviews of their care, goals and outcomes.,

6.0 CHALLENGING BEHAVIOUR

- 6.1 Where the Service Provider is concerned that a Service User's behaviour (or that of family or a friend) is adversely affecting the health safety comfort and quality of life of other Service Users and or the health and safety of Staff the Service Provider must bring the matter to the attention of the relevant ICS Case Manager (who placed the Service User at the Home) as soon as possible and discuss/ keep under review if it is appropriate to consider a safeguarding referral (as detailed in Schedule 3 paragraph 9) and may:
 - 6.1.1 discuss the matter with the Service User;
 - 6.1.2 discreetly sensitively and with regard to confidentiality gauge the response of those affected

by the behaviour;

- 6.1.3 discuss the matter with the Service Users family friends (if appropriate);
- 6.1.4 involve other specialist professionals;
- 6.1.5 maintain adequate records so that care plans and other documents may be able to give some indication to the behaviour patterns
- 6.2 The Service Provider will have a written policy on the use of restraint which will be communicated to Staff and available on request to the Council.
- 6.3 The appropriateness and level of medical intervention to address challenging behaviour including the administration of drugs or medication shall be decided only by a GP or Medical Consultant. The ICS Case Manager must be informed by the Service Provider as soon as possible of any such intervention.
- 6.4 The Service Provider will work to the Council's Management of Actual and Potential Aggression Policy and ensure that care Staff are trained in the Management of Actual and Potential Aggression accredited or BILD equivalent and this training is refreshed and updated in line with recommendations or every two years.
- 6.5 Staff will be given appropriate training to develop their skills in non-drug based interventions.

7.0. GENERAL OUTCOMES OF THE SERVICE

- 7.1 To provide the Service User with a temporary place of residence in accordance with the requirements of assessed needs
- 7.2 The encouragement of the Service User's independence through therapeutic approaches and the utilization of his or her practical skills
- 7.3 The enabling of Service User choice in relation to the day to day routine.
- 7.4 The recognition of the symptoms of institutionalisation within Service Users and the implementation of strategies to build on his or her self-esteem and self-determination
- 7.5 A full and on-going assessment of social, educational, physical, spiritual and emotional needs of the Service User, working in collaboration with other relevant agencies to achieve best outcomes
- 7.6 Provision to the Service User of ongoing and timely review systems and appropriate adjustments to the Service to meet changes in need and choices
- 7.7 The implementation of coping strategies, assessment and intervention during difficulties, through the provision of 24 hour supervision which will provide mechanisms for on-going surveillance and monitoring of the Service User
- 7.8 The reporting of any significant changes in a Service User's physical, psychosocial and emotional well-being to relevant professionals, and the full and accurate recording of events in order to support any required changes to the Service and associated support

8.0. INFORMATION FOR SERVICE USERS

The Service Provider will ensure that:

it makes available a copy of its brochure and provides the Service User with details of other relevant information including, specific information about the Recovery Nursing Beds service, and any terms and conditions of residency at the Home. The Service Provider will ensure that the Home's terms and conditions do not conflict with the terms of this Agreement and that they comply with the legislation and guidance issued by the Office of Fair Trading in particular "Fair Terms for Care"

- 8.2 Service Users and their families are advised of activities and leisure opportunities that are available at the home and links that the home has with the local community, voluntary and independent groups.
- 8.3 Service Users and their families are advised of the arrangements and times for visiting the home. Visiting arrangements are expected to be flexible and visitors welcomed at all reasonable times
- 8.4 Service Users are given details of additional services available which are not included in the Service e.g. chiropody (and those items listed in 9.3.2) and the costs itemised so that the Service User can make an informed choice about purchasing.
- 8.5 Service Users have prompt access to their own files in accordance with all regulations on request. This includes nursing records and medical records dated from November 1992 following consultation with the Service User's own General Practitioner.
- 8.6 it informs the Service User whether smoking is permissible at the Home. Where smoking is allowed the Service Provider should carry out an individual risk assessment where it is reasonable to assume there may be a safety risk to the Service User or others. Where smoking is not allowed this must be made clear to the Service User before they take up a place at the Home or to any family member, social worker or health care professional or carer acting on their behalf.
- 8.7 it informs the Service User that Staff may not accept money (as a gift or loan) or other gifts from the Service User. Small token gifts on special occasions will be reported to the Service Provider and recorded by them. The Service Provider will make available to the Staff and the Service User its policy about gifts and personal boundaries.
- 8.8 it provides information about the philosophy and operation of the service.
- 8.9 it provides information on how Service Users can make complaints or compliments about the service.
- 8.10 information is provided about the Home's equalities policy
- 8.11 information is provided about the Home's confidentiality policy and when confidentiality will be breached.

9.0 SENSORY AND MOBILITY LOSS AND IMPAIRMENT

The Service Provider will ensure that

- 9.1 Staff observe any indications of changes in sensory abilities or physical mobility of Service Users and report them to the Service Provider. These will be recorded in the Service User's Individual Care Plan and in consultation with the Service Users and a referral may be made for medical advice or treatment.
- 9.2 as far as practicable prescribed aids and equipment are to be obtained for Service Users
- 9.3 it is aware of and encourages the Service User to use any other aids and equipment which enhances the Service User's life (e.g. Talking Books magnifying glasses
- 9.4 all aids and equipment are kept clean and maintained in good working order and in accord with manufacturing instructions. Under no circumstances will defective equipment or aids be used
- 9.5 Staff are trained in assisting Service Users in the proper use of the aids and it is the responsibility of the Service Provider to secure this training
- 9.6 Staff can communicate with Service User with sensory impairments and are trained in the basic skills of assisting Service Users who have impaired mobility and the Service Provider will endeavour to promote the independence of the Service User wherever possible
- 9.7 Staff are aware of the social isolation which may arise from sensory impairment and physical impairment and poor or reduced mobility and will seek ways of addressing such isolation in consultation with the

SCHEDULE 3: SERVICE STANDARDS

1.0 GUIDING PRINCIPLES

- 1.1 The Parties will seek to provide a Service that:
 - 1.1.1 encourages the rights of Service Users to make decisions about their own lives
 - 1.1.2 acknowledges and seeks to address and avoid the ways in which Service Users are marginalised and subjected to discrimination
 - 1.1.3 ensures that members of Staff are committed to anti-discriminatory and anti-oppressive practice and seek to examine their own attitudes.
 - 1.1.4 ensures that the privacy and individuality of all Service Users is respected
 - 1.1.5 respects the cultural, social, religious and emotional needs of Service Users
 - 1.1.6 respects the confidentiality of any information gained about Service Users whilst ensuring that Staff are clear that they have a duty to share any concerns about Service Users' mental and physical welfare with their managers and other professionals involved in the Service Users support
 - 1.1.7 fosters independence and enables Service Users to reach their full potential
 - 1.1.8 protects Service Users when they are at risk
- 1.2 The Service Provider must provide the Service in accordance with the terms of this Agreement and with all the skill, care and diligence to be expected of a competent provider of services of a similar kind to the Service
- 1.3 In providing the Service the Service Provider must also comply with any of the practices performance ratings and quality standards that are set out or referred to in this Agreement and all statutory provisions and guidance which apply to the Service and are issued from time to time by the Registration Body

2.0 POLICIES, PROCEDURES AND GUIDANCE

- 2.1 The Service Provider should have the following policies, procedures and/or guidance in place
 - 2.1.1 Operational policies including recruitment and retention of Staff.
 - 2.1.2 Grievance and disciplinary procedures.
 - 2.1.3 Health and safety policy in line with all relevant legislation
 - 2.1.4 Confidentiality, record keeping, security and access to records policy.
 - 2.1.5 Lone/out of hours working policy.
 - 2.1.6 Staff training policy.
 - 2.1.7 Risk management policy and procedure.
 - 2.1.8 Service User rights and responsibility statement
 - 2.1.9 Whistle blowing policy
 - 2.1.10 Mental Capacity Act: Deprivation of Liberties Safeguard policy and procedure

 Dealing with violence, aggression and disruptive behaviour in line with the Council's

- 2.1.11 Management of Actual and Potential Aggression Policy
- 2.1.12 Recording of incidents & accidents
- 2.1.13 Supporting Service Users who take prescribed and un-prescribed medication
- 2.1.14 Missing persons policy
- 2.1.15 Fire safety policy
- 2.1.16 Staff Code of Conduct and Responsibilities
- 2.1.17 Equality and diversity policy
- 2.1.18 Smoking policy
- 2.1.19 Infection control policy
- 2.1.20 Adult safeguarding policy and procedure
- 2.2 The Service Provider will ensure that all Staff have copies of all the policies and procedures listed above and that Staff sign to indicate that they have received read and understood each one and such documentation will be retained for management and monitoring purposes. In addition, the Service Provider will ensure that Staff have access to and operate to the requirements of the "West Midlands Adult Safeguarding Policy and Procedures" and the Shropshire Council whistleblowing policy "Speak Up about Wrongdoing".

3.0 RECORD KEEPING & CONFIDENTIALITY

- 3.1 The Service Provider's facilities for storing records such as filing cabinets must be lockable and in a secure environment. Evidence must be available that any statutory requirements relating to the premises have been complied with.
- 3.2 Information relating to the Service Users should be recorded in accordance with Schedule 2 Paragraph 2.4 (Admission to the Home).
- 3.3 A register of Staff must be maintained which should include the following information
 - name, address and telephone number
 - position held (including the date started) and hours worked
 - next of kin name, address and telephone number
 - GP name, address and telephone number
 - Date of issue of identification and retrieval if appropriate
 - Recruitment details including a minimum of two references from previous employers, evidence of DBS checks and interview questions and responses.
 - Induction and training records
 - Copies of identification, training certificates and qualifications
- The Service Provider will ensure that each member of Staff is made aware that their files may be inspected by Officers of the Council for the purpose of monitoring

4.0 STAFFING

4.1 General Standards

- 4.1.1 The Service Provider will ensure that there are enough appropriately trained, qualified, skilled and experienced Staff on duty at the Home, particularly nursing staff, at all times to deliver a high standard of care.
- 4.1.2 In addition, the Service Provider will check the competency of Staff to deliver all aspects of care or nursing and will keep a record of these checks.
- 4.1.3 Where an allegation of abuse occurs against a member of Staff, where the Home is in Shropshire, the West Midlands Adult Safeguarding Policy and Procedures must be followed by the Service Provider forthwith.
- 4.1.4 The Service Provider will ensure that all Staff know that they are exempt from the Provision of the Rehabilitation of Offenders Act 1974.
 - they must sign a declaration of all previous criminal convictions
 - it is a disciplinary offence to make a false declaration
- 4.1.5 In circumstances where the Council has a concern in relation to a member of Staff, if required by the Council, a meeting will be arranged within 24 hours or within other such time as shall be agreed to discuss the concerns of the Council
- 4.1.6 Care staff must be employed in accordance with the code of conduct and practice set by the general social care council and all Staff must be given copies of the code by the Service Provider
- 4.1.7 The Service Provider will ensure that all Staff are aware that it is not acceptable for any relationship to develop between Staff and Service Users either physical financial or of an exploitative nature, and any relationship of this type will be a disciplinary matter.

4.2 The Home Manager

- 4.2.1 The Home Manager is to be registered with the Registration Body. Where a new manager is appointed at the Home, the Home will apply for registration with the Registration Body as soon as practicably possible and no later that six weeks of the date the Home Manager commenced the post.
- 4.2.2 The Council's contracts team are to be notified within ten working days if the Home Manager ceases to be employed in the post of Home Manager.
- 4.2.3 The Council's contracts team are to be notified within ten working days of commencement when a Home Manager is appointed to their role
- 4.2.4 There is an expectation that the Home Manager will be appointed to manage the Home. If the Home Manager is expected to manage another home, or any other business, concurrently or is moved to cover another home the Council's contracts team are to be notified within ten working days of any of these arrangements commencing.
- 4.2.5 The Home Manager must be suitably experience and qualified. It is expected that the manager holds, or is actively working towards, a Level 5 Diploma in Leadership for Health and Social Care and Children and Young People's Services having followed the

- "Management of Adult Residential Services" pathway.
- 4.2.6 The Home Manger will have sufficient supernumerary time to carry out the managerial tasks associated with the role to include, but not be limited to; staff supervisions; staff meetings; auditing of Individual Care Plans and Individual Support Plans and associated documentation.
- 4.2.7 The Home Manager will have daily access to a computer at the Home including a secure email address. This email address is to be made available to the Council.

4.3 Recruitment and Selection

- 4.3.2 The Service Provider shall at all times during the period of this Agreement engage sufficient Staff of sufficient ability skill knowledge training and experience for the proper performance of the Service and shall continuously supervise the performance of Staff and ensure that there is a sufficient reserve available to provide the Service at all times
- 4.3.3 The Service Provider shall be entirely responsible for the employment and conditions of service of its own employees and shall at all times be fully responsible for the payment of all salaries and wages income or other taxes national insurance contributions or levies of any kind relating to or arising out of the employment of any persons employed by the Service Provider and shall fully and promptly indemnify the Council in respect of any liability of the Council in respect thereof
- 4.3.4 The Service Provider shall provide a means of identification to all its Staff and shall require them to produce such identification on request
- 4.3.5 There must be a clear written job description and employee specification for all positions with the Home and all Staff
- 4.3.6 Job applications must be in writing and describe previous experience, training, full employment history since leaving school and explain and any gaps in employment and reasons for leaving previous employment.
- 4.3.7 Candidates selected for possible appointment must be interviewed.
- 4.3.8 Two satisfactory written references must be obtained before employment commences, and the authenticity of the reference should be verified. One reference must be from the applicant's current or last employer, and should be obtained from a previous employer in the care sector where applicable. Provision must be made for references to be taken from all previous employers if required. References should ask reasons for leaving, whether the employer providing the reference would offer re-employment and whether any disciplinary investigations have been undertaken and why.
- 4.3.9 Applicants must make a written declaration of previous convictions and disqualifying conditions and provide information about any other name by which they have been known.
- 4.3.10 Recruitment procedures are to be in accordance with Clause 39 (Safeguarding).

- 4.3.11 The identity of all Staff should be verified prior to employment using an official document.
- 4.3.12 The authenticity of qualifications should be checked prior to employment.
- 4.3.13 Staff should be provided with information about their conditions of employment.
- 4.3.14 All Staff must make a written undertaking in respect of confidentiality.
- 4.3.15 In the event of agency Staff being used the Service Provider must ensure that the agency has carried out thorough checks including references and hold a valid certificate of clearance issued by CRB and that selection processes have been rigorous.
- 4.3.16 All new Staff must be appointed on a probationary contract, renewal of which must be dependent upon satisfactory performance and completion of the induction programme.

 This provision must also apply to internal transfers.
- 4.3.17 Where any concerns have been raised about a potential member of Staff by a referee or through the DBS check and the person is nevertheless deemed to be suitable for support work appropriate and sufficient monitoring is undertaken by the Service Provider in respect of the concerns raised. The Service Provider must be able to demonstrate that such monitoring has been carried out.

The Service Provider must inform Staff that the Council reserves the right to view their 4.3.18 Staff records

4.4 Qualifications & Experience

- 4.4.1 It is essential that the Home Managers hold a Level 5 Diploma in Leadership for Health and Social Care and Children and Young People's Services, having followed the "Management of Adult Residential Services" pathway, or be actively working toward this qualification when taking up their role.
- 4.4.2 It is desirable that Deputy Managers have a qualification in Social Care or Nursing and essential that they have had 3 to 5 years' experience in Social Care. It is desirable that Deputy Managers have a qualification in Management if not they must work towards achievement of a Level 4 Diploma in Adult Care or equivalent qualification.
- 4.4.3 It is desirable that Senior Care Staff have a qualification in Social Care or Nursing and essential that they have had previous experience in Social Care. It is desirable that Senior Care Staff have a qualification in management if not they must work towards achievement of a Level 4 Diploma in Adult Care or equivalent qualification.
- 4.4.4 Nursing Staff should be fully qualified Registered Nurses, preferably with experience of working in a nursing home or other social care establishment or similar service that employs Registered Nurses..
- 4.4.4 Managers and senior care staff should provide evidence of the ability to manage Staff and systems effectively and to establish positive relationships with other professionals.
- 4.4.5 Care Staff must have previous relevant experience or training to enable them to provide the Service to the Service Users at the Home and should hold or work towards achieving a Level 2 or Level 3 Diploma in Health and Social Care or equivalent qualification.

- 4.4.6 Staff must be able to demonstrate their ability to follow policies and procedures.
- 4.4.7 All Staff must be committed to meeting the needs of the Service Users and maximising their capacity for independence and self-determination.

4.5 Induction

- 4.5.1 The Service Provider will provide a structured induction programme to all Staff that will be made available to the Council if requested. The induction programme must meet all aspects of training covered by the Care Certificate and will include
 - an introduction to the policies procedures and codes of conduct of the Service
 Provider which Staff will be expected to follow
 - an introduction to current national policy and strategy with regard to care for older people and people with dementia.
 - an introduction to the Service, the principles and features of the Service and the rights of Service Users and expected outcomes for Service Users.
 - instruction in safe moving and handling
 - administration of medication including administration of stesolid if required
 - breakaway and restraint techniques in line with the Council's Management of Actual and Potential Aggression Policy
 - familiarisation with the Individual User Care Plans and risk assessments
 - Health and Safety
 - basic First Aid
 - non-aversive intervention
 - the West Midlands Adult Safeguarding Policy and Procedure

4.6 Training

4.6.5

- 4.6.1 An ongoing programme of training must be provided for Staff at the Home.
- 4.6.2 The training programme must; underpin knowledge for and include relevant qualifications, respond to emerging local and national requirements or priorities; support Staff to deliver the Service to a high standard, and enable Staff to continually improve their performance.
- 4.6.3 The Service Provider will ensure that, where appropriate, the training Staff receive is made relevant to supporting older people and people with dementia.
- 4.6.4 The Home manager should undertake regular appraisals of Staff performance and training needs. Targets should be set to ensure all Staff achieve qualifications relevant to their role in the Home (include required refresher training) to include those set out in Schedule 3 paragraph 4.4 (Qualifications and Experience).
 - The Service Provider will operate a system that holds clear records of all staff training, training targets and, where appropriate, expiry and refresher dates for training.
- 4.6.6 The Council has an approved list of training providers from which the Service Provider may wish to select. Where the Service Provider uses training organisations not approved by the Council, if requested by the Council, the Service Provider must demonstrate that

the training provider is of a suitable standard.

The Service Provider will ensure that all nurses at the Home are appropriately trained and have their training, practice and registration refreshed, maintained and current in accordance with best practice from the Nursing and Midwifery Council or equivalent body

4.7 Supervision

- 4.7.1 Supervision will take place between all Staff and their line manager in accordance with the requirements of the Regulatory Body and as a minimum on a two monthly basis and written records will be kept on the content and outcome of each meeting
- 4.7.2 Written records will be kept on the content and outcome of each supervision meeting.

4.8 Use of Agency Staff and Volunteers

- 4.8.1 The Service Provider may use volunteers and agency staff to deliver some of the activities provided as part of the Service.
- 4.8.2 In all cases volunteers and agency staff must be recruited in line with the Guidance of the DBS and as a minimum 2 references which must be taken up by the Service Provider, or evidenced as being taken up, prior to any volunteer or agency worker commencing work.
- 4.8.3 Volunteers and agency staff must receive adequate training appropriate to the duties they are to undertake. In particular if volunteers or agency Staff are to be used in any instances for care duties they must receive and comply with the training and skills expected of care Staff.
- 4.8.4 Agency staff may only be employed from an agency accredited with Shropshire Council or registered with the Regulatory Body.

5.0 TRANSPORT

- 5.1 Risk Assessments in respect of each Service User should be carried out in respect of transfers from the Home to activities and Risk Assessments must be made available for inspection.
- 5.2 Staff must monitor the escort arrangements as required by each Individual Care Plan.
- Any vehicles used by Staff to transport the Service Users must have a current MOT certificate if over 3 years old and have adequate third party and passenger liability insurance.
- Any vehicles used to transport the Service Users should be regularly serviced and any concerns about road worthiness and safety reported to the Home Manager.
- 5.5 Any driver used by the Service Provider to transport the Service Users MUST: be authorised by management for this role.

 hold a current driving license suitable for the vehicle being driven.

 make a declaration of any license endorsements or penalty points.
- 5.6 Staff may not use their cars for work purposes unless they have appropriate business class insurance.

6.0 HEALTH & SAFETY AND RISK MANAGEMENT

- 6.1 The Service Provider shall ensure that:
 - 6.1.1 the Service is provided with proper regard to Health and Safety legislation which shall comprise all statutes codes of practice Regulations British Standards and Guidance Notes relevant to Health and Safety and the performance of this Agreement. Further guidance is obtainable from the Registration Body the Health and Safety Executive and the local authority Environmental Health Inspectors
 - 6.1.2 it has a Health and Safety Policy Statement meeting the requirements of the Health and Safety at Work Act 1974 and the Health & Safety at Work Regulations 1992 and any amendments thereof and management must make Staff aware of its contents. Where there are four or less employees the Service Provider will have a statement which will be issued by the Council and subsequently endorsed by the Service Provider agreeing to meet certain health and safety and other requirements when requested to do so by the Council
 - 6.1.3 it undertakes a risk assessment in respect of each Service User at least annually or other such frequency as shall be agreed and to update the Individual Care Plan accordingly
- 6.2 Staff should be required to follow good practice in moving and handling and be provided with appropriate training and refresher training. Certificates of training undertaken should be held on their Staff files.
- 6.3 Records of all Health & Safety training, including refresher training must be kept and held locally
- 6.4 All accidents, incidents and violent 'near misses' involving Staff and Service Users must be recorded. This record should include any steps taken to prevent a recurrence. Accidents must also be recorded in an accident book
- 6.5 A full written risk assessment should be completed under the requirements of the Health and Safety at Work regulations 1992 on the Service and if required in respect of each Service User when they are first admitted and when any changes to their care needs arise.
- The Service Provider will have a risk management policy in respect of Service Users. Steps taken to minimise risk will be discussed with the Service User's family or ICS Case Manager. The policy will recognise the Service User's right to take risks as an expression of independence but will take into account other Service Users and Staff. This policy should be communicated to all Staff, Service Users and their family and ICS Case Manager

7.0 QUALITY ASSURANCE

- 7.1 The Service Provider must be able to demonstrate to the Council that it has a commitment to the quality of the Service.
- 7.2 The Service Provider must have documented systems which enable it to:
 - 7.2.1 check on whether it is delivering the Service in accordance with the Agreement

- and its Specification
- 7.2.2 check whether it is doing this efficiently and effectively
- 7.2.3 check on whether Staff are provided safe systems of work
- 7.2.4 check whether the Service is being delivered in a way which takes account of the Service User's needs and preferences and satisfaction
- 7.2.5 check to ensure that all records are up to date
- 7.2.6 check whether in the view of Service Users parents / carers the Council and other relevant agencies consider the quality of the Service can be improved
- 7.2.7 provide information to the Council evidencing that the systems are in place and being used and hold all records which demonstrate this at the Home.
- 7.3 The Service Provider must have care management documentation systems in place that include Assessment of Needs/FFA's, Individual Care Plans, where appropriate specialist assessments and risk assessments

8.0 AGREEMENT MONITORING

- 8.1 Nominated officers of the Council may seek to monitor this Agreement by:
 - 8.1.1 visiting the Home (announced or unannounced from time to time) to undertake a review on any or all aspects of the operation of the Service and compliance by the Service Provider with the terms of this Agreement. This may include viewing the Home and areas used at the Home for the provision of the Service such as Service Users' bedrooms (Officers shall have regard to Service User's privacy whilst at the Home) communal areas, kitchen, bathrooms, halls, and any areas that a Service User have access to. The Council will have careful regard to the nature of the Service provided and shall when on premises controlled by the Service Provider respect Service Provider's rules as to security, health and safety. The Council may prepare a report of the visit to be shared with the Service Provider.
 - 8.1.2 carrying out a quality assurance exercise which may involve contacting Service Users and/or their families and friends and ascertaining their views on the provision of the Service at the Home,
 - 8.1.3 assessing information from CQC reports, Healthwatch reports, feedback from social work teams and staff within the CCG, IPC audits, the outcome of safeguarding processes, financial information.
 - 8.1.4 holding a meeting between The Service Provider and the Council to discuss:
 - Finance
 - Staff (recruitment / leavers / sickness and agency)
 - Operation of the Service (existing and future)
 - Feedback from Service Users on the Service

- Incidents or concerns raised about the Service and actions taken to address these.
- Liaison with health care professionals
- Results of the Service Provider's own quality assurance mechanisms

The Service Provider will:

8.2

- 8.2.1 allow Officers of the Council access to the Home (upon the production by Council Officers of an identity badge) to carry out any monitoring work or visit described in 9.1
- 8.2.2 give assistance to Officers and prompt access to at any file information or record it holds in respect of the Service User or the provision of Service to the Service Users as required by this Agreement (which may include but is not limited to Service User's care files (including care plans, reviews, Assessment of Needs/FFA, risk assessments, daily notes), the recruitment and selection of Staff, policies and procedures, the induction, training and supervision of staff; informal records such as staff handover book, staff rota; and documentation relating to the Personal Allowance (if applicable)
- 8.2.3 allow Officers of the Council to speak to Service User's and Staff in private (the Council shall have regard to the Service User's needs and Staff needed on duty to provide the Service)
- 8.2.4 upon request provide photocopies of documentation (subject to the Council contributing to the Service Provider's reasonable photocopy costs)
- 8.2.5 supply to the Council upon request the names of Service Users resident at the Home (at any one time) and or any contact details the Service Provider holds for next of kin or family / friends that visit the Home for the purpose of contacting them to ascertain their views of the Service provided at the Home
- 8.2.6 meet reasonable requests by Officers for information in order to; investigate complaints made by Service Users; to assess the financial viability of the Service Provider, the reliability and quality of care provision throughout this Agreement period, consistency and standards of care, the Service User's and/or their representative's views of the care provided; to complete government returns or performance indicators
- 8.2.7 keep an accurate record of all Staff on duty at the Home at any time usually called the Staff rota) including a note if the Home Manager or any member of Staff leaves the Home for a period of time during their shift, and make these available to Council Officers on request.
- 8.2.8 keep a record of all audits of records carried out at the Home and make these available to Council Officers on request
- The ICS Case Manager is responsible for monitoring the provision of Service to the

Service User as detailed in the Assessment of Need/FFA, the Individual Care Plan and :

- 8.3 8.3.1 may seek to monitor the Service Provider's in-house systems of monitoring and review in respect of the provision of the Service to the Service User and evidence that the systems are being used effectively and that Individual Care Plans are being implemented and monitored and that needs identified within a Service User's Assessment of Needs/FFA are being met effectively.
 - 8.3.2 will inform the Service Provider if it fails to meet the requirements of Individual Care Plan and Assessment of Need/FFA and will require improvements by appropriate timescales that will evidence the needs of the Service User are being met.

The Service Provider will ensure that it obtains any necessary consent from Staff and/ or Service Users to allow access to files to monitor the provision of the Service.

8.4 The Service Provider will complete and submit Appendix 2 if requested to do so.

9.0 SAFEGUARDING ADULTS

- **9.1** The Service Provider must fulfil its commitment to safeguard and promote the welfare of Service Users and vulnerable adults and shall have the following in place:
 - 9.1.1 Clear priorities for safeguarding and protecting vulnerable adults explicitly stated in strategic policy documents.
 - 9.1.2 A clear commitment by senior management of the organisation to the importance of safeguarding and protecting vulnerable adults.
 - 9.1.3 A clear line of accountability within the organisation for overseeing safeguarding and protecting vulnerable adults and a definition of the roles and responsibilities of relevant officers for taking action and reporting and, where the Home is in Shropshire, how this links, to engagement by the Service Provider with regard to the West Midland Adult Safeguarding Policy and Procedures as set out in this paragraph 13.2.
 - 9.1.4 Arrangements to ensure that all Staff receive supervision and undertake safeguarding and protection of vulnerable adult training in order to carry out their safeguarding responsibilities effectively. Refresher training must be provided at regular intervals and all Staff including temporary Staff and volunteers who work with vulnerable adults must be made aware of the organisations arrangements for protecting vulnerable adults.
 - 9.1.5 Arrangements to work effectively with other organisations involved in the delivery of services to vulnerable adults in order to safeguard adults, including arrangements for sharing information.
 - 9.1.6 A culture of listening to and engaging in dialogue with vulnerable adults and seeking their views and taking account of those views both in individual decisions and the establishment or development of services.

- 9.1.7 Whistle blowing procedures and a culture that enables issues about safeguarding and protecting vulnerable adults to be raised.
- 9.1.8 A clear policy and procedure for safeguarding that reflects how the Service Provider deals with allegations of abuse; incorporates the requirements above, and is regularly reviewed and updated to reflect safeguarding best practice and quidance.
- 9.2 The Service Provider must operate in accordance with the West Midlands Adult Safeguarding Policy and Procedures. With regard to this arrangement the Service Provider shall
 - 9.2.1 Ensure staff awareness of the West Midlands Adult Safeguarding Policy and Procedure and the circumstances in which it applies.
 - 9.2.2 Co-operate fully with the Council and all other relevant agencies in working to the West Midlands Adults Safeguarding Policy and Procedure.
 - 9.2.3 Adopt an approach to information sharing that fully supports the procedures and processes within the West Midlands Adults Safeguarding Policy and Procedure
 - 9.2.3 Ensure senior management input into operation to, and engagement with, the West Midlands Adult Safeguarding Policy and Procedure.

10 HEALTHWATCH


- 10.1 The Service Provider will allow an Authorised Representative of Healthwatch to access the Home to enter and view the Home and observe the carrying on of activities and the Services at the Home.
- 10.2 The duty on the Service Provider to allow the Authorised Representative access in accordance with paragraph 9.6 above shall not apply where:
 - 10.2.1 the presence of the Authorised Representative at the Home or in a part of the Home would compromise either the effective provision of the Services or the privacy or dignity of any person;
 - 10.2.2 the Authorised Representative does not comply with the following:
 - a. any viewing or observation carried out by the Authorised Representative is to be carried out for the purposes of the Healthwatch and;
 - b. whilst at the Home pursuant to paragraph 9.6 above the Authorised Representative does not act in any way that compromises the effective provision of the Services or the privacy or dignity of any person;
 - 10.2.3 access is requested to Excluded Premises;
 - 10.2.4 the Authorised Representative wishes to observe the carrying-on of Excluded Activities;
 - 10.2.5 the Authorised Representative requests to enter and view the Home or part of the Home for the purpose of observing the carrying-on of Excluded Activities
 - 10.2.6 access is requested to the Home or part of the Home at any time when the Services are not being provided at the Home or any part of the Home;

- 10.2.7 in the opinion of the Service Provider the Authorised Representative is not acting reasonably and proportionately in seeking to enter and view and observe the carrying-on of activities at the Home; or
- 10.2.8 the Authorised Representative does not provide the Service Provider with written evidence that he or she is authorised by the Healthwatch

11 HEALTHWATCH REQUESTS FOR INFORMATION

- 11.1 Upon receipt from Healthwatch of a request in writing for information which in the opinion of the Healthwatch representative making the request is necessary for the effective carrying on of Healthwatch's activities the Service Provider will respond as follows:
 - 11.1.1 where the information requested is held by the Service Provider and is not exempt information in accordance with paragraph 11.2 below, the Service Provider must provide the information to Healthwatch within 20 (twenty) Working Days following the date of receipt of the request for information by the Service Provider;
 - 11.1.2 where the Service Provider holds the information and it is exempt information in accordance with paragraph 11.2 the Service Provider must:
 - a. if paragraph 11.2 applies provide the information to Healthwatch in a form in which the identity of the individual cannot be ascertained, within 20 Working Days following the date of receipt of the request for information by the Service Provider; or
 - b. in any other case, within 20 (twenty) Working Days following the date of receipt of the request for information by the Service Provider notify Healthwatch that the Service Provider is not required to disclose the information requested;
 - 11.1.3 where the Service Provider does not hold the information, notify Healthwatch of this within 20 (twenty) Working Days following the date of receipt of the request for information by the Service Provider;
- 11.2 For the purposes of paragraph 11 information is exempt if it is:11.2.1 confidential and relates to a living individual, unless the individual consents to the information being disclosed; prohibited from disclosure by any enactment or order of court; or
 - 11.2.3 prohibited or restricted from disclosure by any rule of common law.
 - This paragraph shall apply where information requested under paragraph 11 is exempt by virtue of:
- 11.3 11.3.1 the application of sub-paragraph 11.2.1; or
 - 11.3.2 the application of sub-paragraph 11.2.2 or 11.2.3 because the information is capable of identifying an individual; and which can be disclosed in a form from which the identity of the individual to whom that information relates or is capable of identifying cannot be ascertained.

Shropshire Council Instructions for tendering

Contract Description/Specification:

Shropshire Council is committed to developing and supporting a range of intermediate care services to achieve effective hospital discharge and hospital admission avoidance.

Intermediate care is a range of integrated services to:

- Prevent unnecessary acute hospital admissions
- Prevent premature admission to long term residential care
- Support timely discharge from hospital
- Promote recovery from illness and maximise independent living

Short term quality care provision in nursing homes is recognised as an important element of intermediate care, and to enhance current services the Council is seeking to secure from a sole provider

7 "Recovery Beds": nursing care beds, 2 of which will be with dementia care, to flexibly support hospital admission avoidance and discharge from hospital. This requires a close proximity to the Royal Shrewsbury Hospital and hence the Council is inviting tenders from nursing homes based nearby who are able to offer nursing beds with and without dementia care from 1 March 2019.

1.0 Contract terms

The contract for the beds will be for an initial term of 13 months, with provision for possible extension beyond this term, for periods up to 3 years.

The terms, conditions and standards are contained in the enclosed form of contract.

Shropshire Council is tendering this service in order to meet the ongoing requirement of demonstrating Value for Money. It is anticipated that providers tendering for these services will be able to identify improved efficiencies whilst still maintaining a quality service.

If the successful tenderer/s does not have relevant registration with the Care Quality Commission for homes in Shropshire, registration will be required prior to commencement of contract on 1 March 2019.

Shropshire Council will act as Commissioning Authority for the tender process.

1.1 Service and Service User Details

Recovery Beds must offer:

- Good quality short term care provision in a nursing home, appropriately registered with the CQC, and appropriately located.
- Personal care and support, required specialist care to include dementia care, social activities and opportunities to engage with the community and with family and friends, hotel services, 24hr nursing care from a qualified nurse specialised and/or experienced in care to older people
- Accommodation in single rooms allocated exclusively to the Council's contract
- Facilitated access for dedicated GPs and therapists

- Active support and engagement with residents to promote their rehabilitation and/or enablement as guided by relevant therapists
- Information and advice to families and residents to fully understand the philosophy of intermediate care, recover beds, and the temporary nature of the residents stay at the home
- Support to families, residents and practitioners to facilitate successful discharge from the nursing home at the end of their stay.

Service users: The majority of service users accessing beds under the contracts are expected to be over 65 and requiring, nursing care, or nursing care with dementia care, in a care home setting. Some provision may be required for adults under 65 whose personal, dementia and/or nursing care needs are best met in the Recovery Beds.

1.3 Contract volume and types:

The contract will be for 7 beds. All 7 will be nursing beds, 2 of which will also be required to provide dementia care. All 7 beds will be used flexibly to support hospital admission avoidance and discharge from hospital (Pathways 2 and 3).

1.4 Contract values:

Contract values will reflect the number of beds within each contract; bed week prices submitted; and contract term.

1.5 Bed availability:

The Council requires all beds to be available from the commencement date of the contract, 1 March 2019.

1.0 <u>Invitation to Tender</u>

- 1.1 You are invited to tender for the provision of seven recovery beds to support hospital discharge and hospital avoidance as detailed in the Tender Response Document. The contract for the beds will be for an initial term of 13 months, with provision for possible extension beyond this term, for periods up to 3 years commencing on the 1st March 2019.
- 1.2 Tenders are to be submitted in accordance with the Terms and Conditions of Shropshire Council and the instructions outlined within this document.
- 1.3 Tenders must be submitted in accordance with the following instructions. Tenders not complying in any particular way may be rejected by Shropshire Council (the Council) whose decision in the matter shall be final. Persons proposing to submit a Tender are advised to read the Invitation to Tender documentation carefully to ensure that they are fully familiar with the nature and extent of the obligations to be accepted by them if their Tender is accepted.
- The Invitation to Tender documents must be treated as private and confidential. Tenderers should not disclose the fact that they have been invited to tender or release details of the Invitation to tender document other than on an "in confidence" basis to those who have a legitimate need to know or who they need to consult for the purpose of preparing the tender as further detailed in these Instructions for Tendering.
- 1.5 Tenderers shall not at any time release information concerning the invitation to tender and/or the tender documents for publication in the press or on radio, television, screen or any other medium without the prior consent of the Council.
- The fact that a Tenderer has been invited to submit a tender does not necessarily mean that it has satisfied the Council regarding any matters raised in the pretender questionnaire submitted. The Council makes no representations regarding the Tenderer's financial stability, technical competence or ability in any way to carry out the required services. The right to return to any matter raised in any pretender questionnaire submitted as part of the formal tender evaluation is hereby reserved by the Council.
- 1.7 The Invitation to Tender is issued on the basis that nothing contained in it shall constitute an inducement or incentive nor shall have in any other way persuaded a tenderer to submit a tender or enter into a Contract or any other contractual agreement.
- 1.8 Shropshire Council is purchasing on behalf of itself and any wholly owned local authority company or other entity that is deemed to be a contracting authority by virtue of the Council's involvement.

2.0 <u>Terms and Conditions</u>

- 2.1 Every Tender received by the Council shall be deemed to have been made subject to the General Terms and Conditions and these Instructions for Tendering unless the Council shall previously have expressly agreed in writing to the contrary.
- The Tenderer is advised that in the event of their Tender being accepted by the Council, they will be required to undertake the required services.

3.0 <u>Preparation of Tenders</u>

3.1 Completing the Tender Response Document

- 3.1.1 Tenders should be submitted using the 'Tender Response Document' following the instructions given at the front of the document. The Tenderer's attention is specifically drawn to the date and time for receipt of Tenders and that no submission received after the closing time will be considered.
- **3.1.2** All documents requiring a signature must be signed;
 - a) Where the Tenderer is an individual, by that individual;
 - b) Where the Tenderer is a partnership, by two duly authorised partners;
 - c) Where the Tenderer is a company, by two directors or by a director and the secretary of the company, such persons being duly authorised for the purpose.
- **3.1.3** The Invitation to Tender Documents are and shall remain the property and copyright of the Council

3.2 Tender Preparation and Costs

- 3.2.1 It shall be the responsibility of Tenderers to obtain for themselves at their own expense all information necessary for the preparation of their Tender. No claim arising out of want of knowledge will be accepted. Any information supplied by the Council (whether in the Tender Documentation or otherwise) is supplied only for general guidance in the preparation of tenders.
- 3.2.2 Any Tenderer considering making the decision to enter into a contractual relationship with the Council must make an independent assessment of the Tender opportunity after making such investigation and taking such professional advice as it deems necessary.
- 3.2.3 Tenderers will be deemed for all purposes connected with their Tender submission where appropriate to have visited and inspected the Council, its assets, all the locations in respect of the delivery of the services/supplies/works and to have satisfied themselves sufficiently as to the nature, extent and character of the services supplies/works sought, and the human resources, materials, software, equipment, machinery, and other liabilities and other matters which will be required to perform the contract.
- **3.2.4** The Council will not be liable for any costs incurred by Tenderers in the preparation or presentation of their tenders.
- 3.2.5 Tenderers are required to complete all pricing schedules in the Invitation to tender documents. The terms "Nil" and "included" are not to be used but a zero or figures must be inserted against each item. Unit rates and prices must be quoted in pounds sterling and whole new pence.
- 3.2.6 It shall be the Tenderer's responsibility to ensure that all calculations and prices in the Tender documentation are correct at the time of submission.
- 3.2.7 The Tenderer is deemed to have made him/herself acquainted with the Council's

requirements and tender accordingly. Should the Tenderer be in any doubt regarding the true meaning and intent of any element of the specification he is invited to have these fully resolved before submitting his Tender. No extras will be allowed for any loss or expense involved through any misunderstanding arising from his/her failure to comply with this requirement.

- 3.2.8 Any Tender error or discrepancy identified by the Council shall be drawn to the attention of the Tenderer who will be given the opportunity to correct, confirm or withdraw the Tender.
- 3.2.9 The Tender Documents must be treated as private and confidential. Tenderers should not disclose the fact that they have been invited to tender or release details of the Tender document other than on an In Confidence basis to those who have a legitimate need to know or whom they need to consult for the purpose of preparing the Tender.

3.3 Parent Company Guarantee

It is a condition of contract that if the tendering company is a subsidiary then its Ultimate Group/Holding Company must guarantee the performance of this contract and provide a letter to that effect signed by a duly authorised signatory of the Ultimate Group/Holding Company if requested to do so by the Council. Where the direct parent company cannot provide an adequate guarantee in the opinion of the Council, the Council will look to another group or associate company, with adequate assets, to be the guarantor. In cases where the contract is with a Joint Venture Company (JVC) or a Special Purpose Vehicle (SPV) company, which may have two or more parent companies and which may not be adequately capitalised or have sufficient financial strength on its own to support the risk and obligations it has under the contract, 'joint and several' guarantees / indemnities from the parent companies of the JVC or SPV may be sought.

3.4 Warranty

The Tenderer warrants that all the information given in their Tender and if applicable their Request to Participate Questionnaire is true and accurate. The information provided will be deemed to form part of any contract formed under this contract.

The Tenderer warrants that none of their current Directors have been involved in liquidation or receivership or have any criminal convictions

4.0 <u>Tender Submission</u>

- 4.1 Tenders must be submitted strictly in accordance with the letter of instruction accompanying this Invitation to Tender. Tenders must be submitted by the deadline of noon, Friday 30th November 2018
- 4.2 No unauthorised alteration or addition should be made to the Specification and Tender Response Document, or to any other component of the Tender document. If any such alteration is made, or if these instructions are not fully complied with, the Tender may be rejected.
- 4.3 Qualified tenders may be submitted, but the Council reserves the right not to accept any such tender. The Council's decision on whether or not a Tender is

- acceptable will be final.
- 4.4 Tenderers should note that their Tender must remain open and valid and capable of acceptance for a period of at least 90 days.
- 4.5 Tenderers should note that Tenders and supporting documents must be written in English and that any subsequent contract, which may or may not be entered into, its formation, interpretation and performance, shall be subject to and in accordance with the laws of England and subject to the jurisdiction of the Courts of England and Wales.
- 4.6 Where Tender submissions are incomplete the Council reserves the right not to accept them.

5.0 <u>Variant Bids</u>

- 5.1 The Council is interested in alternative solutions which would provide and develop opportunities for savings in service costs, service improvement or other financial benefits. In particular, the Council wishes to encourage solutions which also deliver benefits and added value to the local economy, residents and the business community.
- Tenderers may submit, at their discretion, a Tender offering a different approach to the project as a "Variant Bid". However, to permit comparability, at least one bid must be submitted strictly in accordance with the Invitation to Tender Documents(the "Compliant Tender"). Any Tender variant proposed must clearly state how it varies from the requirements of the Compliant Tender Documents, and be explicit in demonstrating the benefits that will accrue to the Council from adopting this approach. Tenderers will be required to identify which submission, in their view, demonstrates best value to the Council.
- Variant Bids must contain sufficient financial and operational detail to allow any Variant Bid to be compared with the standard Tender, permitting its considerations in written form.

6.0 Tender Evaluation

- 6.1 The Tenderers may be called for interview to seek clarification of their tender or additional or supplemental information in relation to their tender. The presentations will not carry any weighting to the final score achieved by Tenderers, but will be used to clarify and moderate issues raised in the Tenderer's submissions. Any areas of discrepancy between submissions and information gained from the presentations will be reviewed and scores previously awarded will be amended if necessary.
- 6.2 If the Council suspects that there has been an error in the pricing of a Tender, the Council reserves the right to seek such clarification, as it considers necessary from the Tenderer in question.

7.0 Clarifications

7.1 Tenderers are responsible for clarifying any aspects of the tendering process and/or the Invitation to Tender documents in the manner described below.

- **7.2** If you are unsure of any section and require further clarification, please contact via our Delta Tenderbox.
- **7.3** Where appropriate, the Authorised Officer named above may direct the Tenderer to other officers to deal with the matter.
- **7.4** All queries should be raised as soon as possible (in writing), in any event not later than **23**rd **November 2018**.
- 7.5 All information or responses that clarify or enhance the tendering process will be supplied to all Tenderers on a uniform basis (unless expressly stated otherwise). These responses shall have the full force of this Instruction and where appropriate the Conditions of Contract. If a Tenderer wishes the Council to treat a question as confidential this must be expressly stated. The Council will consider such requests and will seek to act fairly between the Tenderers, whilst meeting its public law and procurement duties in making its decision.
- 7.6 Except as directed in writing by the Authorised Officer, and confirmed in writing to a Tenderer, no agent or officer or elected Member (Councillor) of the Council has any express or implied authority to make any representation or give any explanation to Tenderers as to the meaning of any of the Tender Documents, or as to anything to be done or not to be done by a Tenderer or to give any warranties additional to those (if any) contained in the ITT or as to any other matter or thing so as to bind the Council in any way howsoever.

8.0 Continuation of the Procurement Process

- **8.1** The Council shall not be committed to any course of action as a result of:
 - i) issuing this Invitation to Tender;
 - ii) communicating with a Tenderer, a Tenderer's representative or agent in respect of this procurement exercise;
 - iii) any other communication between the Council (whether directly or through its agents or representatives) and any other party.
- 8.2 The Council reserves the right at its absolute discretion to amend, add to or withdraw all, or any part of this Invitation to Tender at any time during the tendering stage of this procurement exercise.
- 8.3 At any time before the deadline for receipt of tender returns the Council may modify the Invitation to Tender by amendment. Any such amendment shall be numbered and dated and issued by the Council to all participating tenderers. In order to give prospective Tenderers reasonable time in which to take the amendment into account in preparing its Tender return, the Council may in its sole discretion, extend the deadline for submission of the tender returns. The Council reserves the right to amend, withdraw, terminate or suspend all or any part of this procurement process at any time at its sole discretion.

9.0 Confidentiality

- **9.1** All information supplied by the Council in connection with or in these Tender Documents shall be regarded as confidential to the Council unless the information is already within the public domain or subject to the provisions of the Freedom of Information Act 2000.
- **9.2** The Contract documents and publications are and shall remain the property of the Council and must be returned upon demand.
- **9.3** Tenderers shall ensure that each and every sub-contractor, consortium member and/or professional advisor to whom it discloses these papers complies with the terms and conditions of this ITT.
- **9.4** The contents of this Invitation to Tender are being made available by the Council on condition that:
- 9.4.1 Tenderers shall at all times treat the contents of the Invitation to tender and any related documents as confidential, save in so far as they are already in the public domain and Tenderers shall not, subject to the provisions relating to professional advisors, sub-contractors or other persons detailed below, disclose, copy, reproduce, distribute or pass any of the contents of the Invitation to tender to any other person at any time or allow any of these things to happen;
- **9.4.2** Tenderers shall not use any of the information contained in this Invitation to tender for any purpose other than for the purposes of submitting (or deciding whether to submit) the tender; and
- **9.4.3** Tenderers shall not undertake any publicity activity within any section of the media.
- **9.5** Tenderers may disclose, distribute or pass this Invitation to tender to their professional advisors, sub-contractors or to another person provided that:
- **9.5.1** this is done for the sole purpose of enabling an Invitation to tender to be submitted and the person receiving the Information undertakes in writing to keep the Invitation to Tender confidential on the same terms as if that person were the Tenderer; or
- **9.5.2** the Tenderer obtains the prior written consent of the Council in relation to such disclosure, distribution or passing of the Invitation to Tender; or
- 9.5.3 the disclosure is made for the sole purpose of obtaining legal advice from external lawyers in relation to the procurement or to any Contract(s) which may arise from it or
- **9.5.4** the Tenderer is legally required to make such a disclosure.
- 9.6 The Council may disclose detailed information relating to the Invitation to Tender to its officers, employees, agents, professional advisors or Governmental organisations and the Council may make any of the Contracts and procurement documents available for private inspection by its officers, employees, agents, professional advisors, contracting authorities or Governmental organisations.

9.7 Transparency of Expenditure

Further to it's obligations regarding transparency of expenditure, the Council may be required to publish information regarding tenders, contracts and expenditure to

the general public, which could include the text of any such documentation, except for any information which is exempt from disclosure in accordance with the provisions of the Freedom of Information Act to be determined at the absolute discretion of the Council.

10.0 Freedom of Information

- Please note that from 1 January 2005 under the provisions of the Freedom of Information Act 2000, the public (included in this are private companies, journalists, etc.) have a general right of access to information held by public authorities. One of the consequences of those new statutory responsibilities is that information about your organisation, which Shropshire Council may receive from you during this tendering process may be subject to disclosure, in response to a request, unless one of the various statutory exemptions applies.
- In certain circumstances, and in accordance with the Code of Practice issued under section 45 of the Act, Shropshire Council may consider it appropriate to ask you for your views as to the release of any information before we make a decision as to how to respond to a request. In dealing with requests for information under the Act, Shropshire Council has to comply with a strict timetable and it would therefore expect a timely response to any such consultation within five working days.
- If, at any stage of this tendering process, you provide any information to Shropshire Council in the expectation that it will be held in confidence, then you must make it clear in your documentation as to the information to which you consider a duty of confidentiality applies. The use of blanket protective markings such as "commercial in confidence" will no longer be appropriate and a clear indication as to what material is to be considered confidential and why should be given.
- 10.4 Shropshire Council will not be able to accept that trivial information or information which by its very nature cannot be regarded as confidential should be subject to any obligation of confidence.
- 10.5 In certain circumstances where information has not been provided in confidence, Shropshire Council may still wish to consult with you as to the application of any other exemption such as that relating to disclosure that will prejudice the commercial interests of any party. However the decision as to what information will be disclosed will be reserved to Shropshire Council.

11.0 Disqualification

- **11.1** The Council reserves the right to reject or disqualify a Tenderer's Tender submission where:
- 11.1.1 The tenderer fails to comply fully with the requirements of this Invitation to tender or is in breach of clause 15 of the Council's General Terms and Conditions relating to Bribery and Corruption or is guilty of a serious or intentional or reckless misrepresentation in supplying any information required; or
- **11.1.2** The tenderer is guilty of serious or intentional or reckless misrepresentation in relation to its tender return and/or the procurement process.

11.1.3 The tenderer directly or indirectly canvasses any member, official or agent of the Council concerning the award of the contract or who directly or indirectly obtains or attempts to obtain information from any such person concerning any other Tender or proposed Tender for the services. The Canvassing Certificate must be completed and returned as instructed.

11.1.4 The Tenderer :

- a) Fixes or adjusts the amount of his Tender by or in accordance with any agreement or arrangements with any other person; or
- b) Communicates to any person other than the Council the amount or approximate amount of his proposed Tender (except where such disclosure is made in confidence in order to obtain quotations necessary for preparation of the Tender for insurance purposes); or
- c) Enters into an agreement or arrangement with any other person that he shall refrain from tendering or as to the amount of any Tender to be submitted; or
- d) Offers or agrees to pay or give or does pay or gives any sum of money, inducement or valuable consideration directly or indirectly to any person for doing or having done or causing or having caused to be done in relation to any Tender or proposed Tender for the services any act or omission.
- Any disqualification will be without prejudice to any other civil remedies available to the Council and without prejudice to any criminal liability which such conduct by a Tenderer may attract. The Non-Collusive Tendering Certificate must be completed and returned as instructed.
- 11.3 The Council reserves the right to disqualify an Applicant from further participating in this procurement process where there is a change in the control or financial stability of the Tenderer at any point in the process up to award of a contract and such change of control or financial stability has a materially adverse effect on the Tenderer's financial viability or ability to otherwise meet the requirements of the procurement process.

12.0 <u>E-Procurement</u>

As part of its procurement strategy Shropshire Council is committed to the use of technology that can improve the efficiency of procurement. Successful Tenderers may be required to send or receive documents electronically. This may include purchase orders, acknowledgements, invoices, payment advices, or other procurement documentation. These will normally be in the Council's standard formats, but may be varied under some circumstances so as not to disadvantage small and medium suppliers.

13.0 <u>Award of Contract</u>

13.1 Award Criteria

The Award Criteria has been set out within the Tender Response Document accompanying this invitation to tender. The Council is not bound to accept the lowest or any Tender.

13.2 Award Notice

The Council will publish the name and addresses of the successful Tenderers in the Official Journal of the European Union (OJEU) where appropriate. The Contracting Authority reserves the right to pass all information regarding the outcome of the Tendering process to the Office of Fair Trading to assist in the discharge of its duties. Additionally, the Council will adhere to the requirements of the Freedom of Information Act 2000 and Tenderers should note this statutory obligation.

13.3 Transparency of Expenditure

Further to it's obligations regarding transparency of expenditure, the Council may also be required to publish information regarding tenders, contracts and expenditure to the general public, which could include the text of any such documentation, except for any information which is exempt from disclosure in accordance with the provisions of the Freedom of Information Act to be determined at the absolute discretion of the Council.

14.0 Value of Contract

Shropshire Council cannot give any guarantee in relation to the value of this contract.

15.0 Acceptance

- 17.4 The Council shall not be liable for any costs or expenses incurred by any Tenderer in connection with the preparation of a Tender return for this procurement exercise, its participation in this procurement whether this procurement is completed, abandoned or suspended.
- Whilst the Tender Documents have been prepared in good faith, they do not purport to be comprehensive nor to have been formally verified. Neither the Council nor any of its staff, agents, elected Members, or advisers accepts any liability or responsibility for the adequacy, accuracy or completeness of any information given, nor do they make any representation or given any warranty, express or implied, with respect to the Tender Documents or any matter on which either of these is based (including, without limitation, any financial details contained within the Specification and Contract Documentation). Shropshire Council is committed to developing and supporting a range of intermediate care services to achieve effective hospital discharge and hospital admission avoidance.

Intermediate care is a range of integrated services to:

- Prevent unnecessary acute hospital admissions
- Prevent premature admission to long term residential care
- Support timely discharge from hospital
- Promote recovery from illness and maximise independent living

Short term quality care provision in nursing homes is recognised as an important element of intermediate care, and to enhance current services the Council is seeking to secure from a sole provider

7 "Recovery Beds": nursing care beds, 2 of which will be with dementia care, to flexibly support hospital admission avoidance and discharge from hospital. This requires a close proximity to the Royal Shrewsbury Hospital and hence the Council is inviting tenders from nursing homes based nearby who are able to offer nursing beds with and without dementia care from 1 March 2019.

1.0 Contract terms

The contract for the beds will be for an initial term of 13 months, with provision for possible extension beyond this term, for periods up to 3 years.

The terms, conditions and standards are contained in the enclosed form of contract.

Shropshire Council is tendering this service in order to meet the ongoing requirement of demonstrating Value for Money. It is anticipated that providers tendering for these services will be able to identify improved efficiencies whilst still maintaining a quality service.

If the successful tenderer/s does not have relevant registration with the Care Quality Commission for homes in Shropshire, registration will be required prior to commencement of contract on 1 March 2019.

Shropshire Council will act as Commissioning Authority for the tender process.

1.1 Service and Service User Details

Recovery Beds must offer:

- Good quality short term care provision in a nursing home, appropriately registered with the CQC, and appropriately located.
- Personal care and support, required specialist care to include dementia care, social activities and opportunities to engage with the community and with family and friends, hotel services, 24hr nursing care from a qualified nurse specialised and/or experienced in care to older people
- Accommodation in single rooms allocated exclusively to the Council's contract

- Facilitated access for dedicated GPs and therapists
- Active support and engagement with residents to promote their rehabilitation and/or enablement as guided by relevant therapists
- Information and advice to families and residents to fully understand the philosophy of intermediate care, recover beds, and the temporary nature of the residents stay at the home
- Support to families, residents and practitioners to facilitate successful discharge from the nursing home at the end of their stay.
