the full width of that part of Footpath UN1 Wem Rural, from point A on the Order Map (SJ 5230 2847) where it leaves Weir Lane, passing in front of Weir Cottage and running in a general westerly direction to meet a footbridge at point B on the Order Map (SJ 5222 2846); a total distance of approximately 94 metres; **onto a line** from a pedestrian gate at point A on the Order Map (SJ 5230 2847) where it leaves Weir Lane, running in a general NNW direction for approximately 14 metres, then following the bank of the River Roden in a general westerly direction to meet the footbridge at point B on the Order Map (SJ 5222 2846); a total distance of approximately 97 metres with a width of 2 metres throughout.
