

**NOTICE OF PUBLIC PATH DIVERSION AND DEFINITIVE MAP
AND STATEMENT MODIFICATION ORDER
TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257
WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53(A)(2)**

**THE SHROPSHIRE COUNCIL (FOOTPATH 5 (PART) PARISH OF CHILDS
ERCALL) PUBLIC PATH DIVERSION ORDER 2018.**

The above order was made on 25th January 2018. The effect of the order will be to divert

The full width of that part of Footpath 5 from point **A** (SJ 6588 2567) on the Order Map, running in a general SSE direction on a natural surface to point **B** at SJ 6590 2561 on the Order Map: a total distance of approximately 70 metres onto a line leaving a gate at point **A** (SJ 6588 2567) on the Order Map running in a general WSW, SSE then ENE direction on a 2 metre wide surfaced path to join the Definitive line of FP 5 at point B on the Order Map (SJ 6590 2561); a total distance of approximately 137 metres.

If no such representations or objections are duly made, or if any so made are withdrawn, the Council may itself confirm the order as an unopposed order. If the order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations or objections which have not been withdrawn will be sent with the order.
