<b>Annex : Failure to meet a Soundness Test</b>	
<b>1</b>	It has not been prepared in accordance with the authority's Local Development Scheme (LDS).
<b>2</b>	<b>A</b> It has not been prepared in compliance with the Statement of Community involvement (SCI).
	<b>B</b> Where no SCI exists, it has not been prepared in accordance with the minimum requirements of the Town and Country Planning (Local Development) (England) Regulations 2004.
<b>3</b>	The plan and its policies have not been subject to sustainability appraisal.
<b>4</b>	<b>A</b> It is not a spatial plan, or it has not properly had regard to any other relevant plans, policies and strategies relating to the area or to adjoining areas.
	<b>B</b> It is inconsistent with national planning policy.
	<b>C</b> It is not in general conformity with the regional spatial strategy (or spatial development strategy in London).
<b>5</b>	It does not have regard to the authority's community strategy.
<b>6</b>	The strategies/policies/allocations in the plan are not coherent and consistent within and between Development Plan Documents (DPDs) prepared by the authority and by neighbouring authorities, where cross boundary issues are relevant.
<b>7</b>	The strategies/policies/allocations fail to represent the most appropriate in all the circumstances, having considered the relevant alternatives, and they are not founded on a robust and credible evidence base.
<b>8</b>	There are no clear mechanisms for implementation and monitoring.
<b>9</b>	The plan is not reasonably flexible to enable it to deal with changing circumstances.
