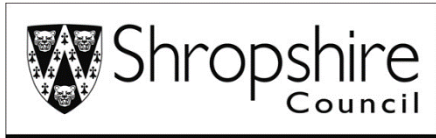

#### Addendum to original report

#### 6. Background

- 6.4 Due to the changes in the regulated entertainment regime including the introduction of The Live Music Act 2012, which de-regulation live music in venues and amended the Licensing Act 2003, certain hours applied for by the applicant are exempt provided the audience does not exceed 500.

If organisers are uncertain as to the audience sizes in the area applied for, it might be easier and more flexible to secure an appropriate authorisation. A fire risk assessment would determine the maximum number of persons in a premises/ venue.

Therefore, as per plan, if the licence was granted as per the application only the following would be the licensable, assuming the audience would never exceed 500:

#### **Supply of Alcohol (On premises)**

Sunday to Thursday - 12:00 to 23:00  
Friday and Saturday – 12:00 to 00:00

#### **Late night refreshment (Indoors)**

Friday and Saturday – 23:00 to 00:00

#### **Performance of dance (Indoors)**

Friday and Saturday – 23:00 to 23:30

#### **Recorded music (Indoors)**

Friday and Saturday – 23:00 to 00:00

*Exempt for premises that sell alcohol for consumption on those premises between 08:00 – 23:00 hours, but also village halls and similar community premises that are not licensed to sell alcohol for consumption on those premises.*

**Live music (Indoors)**

Friday and Saturday – 23:00 to 00:00

*Exempt for premises that sell alcohol for consumption on those premises between 08:00 – 23:00 hours, but also village halls and similar community premises that are not licensed to sell alcohol for consumption on those premises. This includes both amplified and unamplified live music.*

**Films (Indoors)**

Sunday to Thursday - 12:00 to 23:00

Friday and Saturday – 12:00 to 23:30

Required, unless 'not- for- profit' film exhibition held in community premises.

**Plays (Indoors and outdoors)**

Friday and Saturday – 23:00 to 23:30

*The balcony/ veranda has been included on the plan, which would be classed as outdoors.*

**Opening Hours**

Sunday to Thursday - 08:00 to 23:30

Friday and Saturday – 08:00 to 00:30

To include non- standard timings for Christmas Eve, New Year's Eve and Private parties until 01:00, excluded performance of dance and films.

Events held in private are not Licensable unless those attending are charged for the entertainment with a view to making a profit.
