In the event that the current member structure continues unchanged, the proposals, should the report be adopted in full, for amendments to the Basic and Special Responsibility Allowance, will result in an increase in spending on members allowances of £28,846.50. The table below contains a detailed breakdown of the consequences of each of the proposed amendments.
