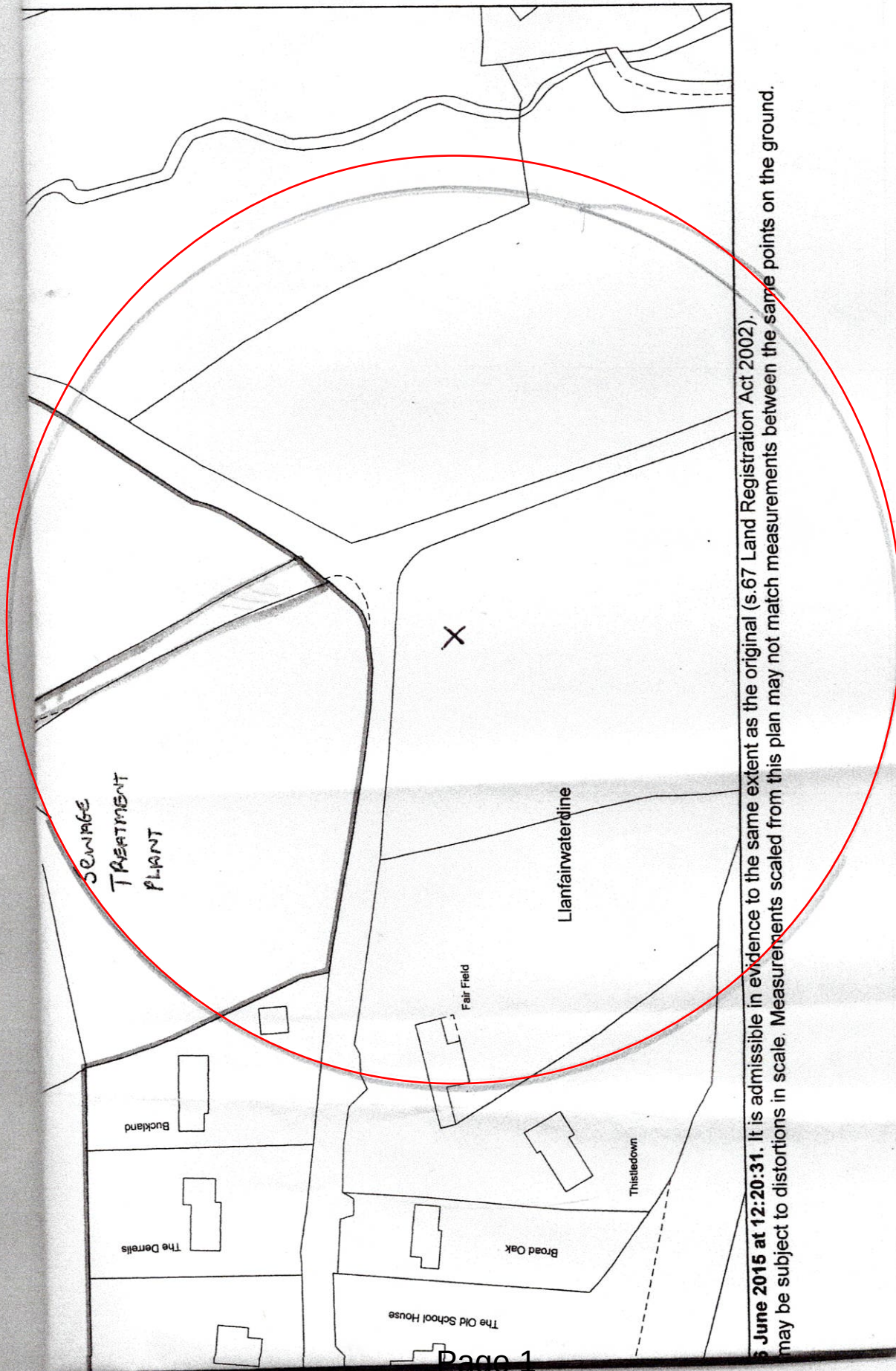

LLANFAIR WATERDINE COMMUNITY TRUST FULL VARIATION TO PREMISES LICENSE

Llanfair Waterdine Community Trust have applied for a full variation to the current premises license held at The Pavilion.

The reason for this is to ease the running of these facilities for the committee and enable us to continue opening weekly for social evenings and private events. We are aware that the current holder of the Personal License is looking to stand down from the Management Committee. Without a member of LWCT or Management Committee obtaining a personal license at the cost of over £200 per person, we will be unable to open for any licensable activities after February (Weekly social evenings, community events etc.)

The variation includes removing all of Annex 3 conditions (excluding condition 2 - "All windows and doors shall be closed between 21:30 - 08:00 except for access and egress"). The aim of the variation is to extend the opening and licensed hours by 1.5 hours daily, and to include off sales on the Boules Court and immediate surrounding lawns.

We ask for you to sign this document as a user of the pavilion, in support of this variation, for LWCT to use as part of its supporting document for a public hearing which is now due on 16th February 2023.
