The following motions had been received in accordance with Procedure Rule 16:

Notice of Motion 1

The following motion was moved by Councillor Gwylim Butler and seconded by Councillor Dan Morris.

Successive governments have allowed a serious funding imbalance to develop between rural authorities and their urban and metropolitan counterparts. Despite Governments' recognition of the higher cost of delivering services in rural areas, this imbalance has been allowed to increase year on year. Rural Services Network - which has a wide membership of rural authorities and has long championed fairer funding settlements for rural areas – has analysed the present government's Provisional funding settlement 2021/22 and calculates that rural residents, when compared with urban:

- Will still be paying over £96 per head more in Council tax
- Receive some 61% (£107) per head less from Settlement Funding Assessment (SFA general grant)
- Get £11 less per head in specific social care costs, despite a higher proportion or elderly rural residents
- Suffer a 16% gap compared with urban of the new social care grants
- Excluding council tax, receive over £112 (42% per head) less in Government Funded Spending Power

As a result, Principal Councils serving rural areas, when compared with urban authorities have to cope with less government grant per head of population; are required to pay more per head of population in Council tax from lower rural incomes; fund more of their essential services through Council Tax (69.29% compared to 55.80%) and yet receive fewer services which are often more expensive to access.

Prior to the Covid pandemic we note that this government was committed to deliver a fairer funding formula for local government and embark on a levelling up agenda, which was primarily aimed at raising funding levels for underfunded regions in the north of the country.

Shropshire residents feel strongly that sparse rural authorities such as ours should also benefit from the levelling up agenda to reduce the current unfair funding disparities between urban and rural authorities and ensure the delivery of equitable funding settlements throughout the country. We seek equality of outcomes and funding for the people and economy of Shropshire; and reduced reliance on Council tax to compensate for inadequate government support.

"This Council therefore instructs the Leader of the Council and the Chief Executive to write to the Prime Minister/Chancellor/SoS MHCLG seeking a commitment that the levelling up agenda should be widened to include Shropshire and other rural Shire Counties; and that the Government should commit to and deliver a fairer funding settlement for Council services and infrastructure requirements."

RESOLVED: That the Notice of Motion be supported.

Notice of Motion 2 - Principles for LTP4

The following motion was moved by Councillor Julian Dean and seconded by Councillor David Vasmer

This council recognises the urgent need to address the transport related climate emergency whilst supporting better and more inclusive connectivity for our residents. We further recognise the opportunity that a switch to active travel presents to address public health issues associated with sedentary lifestyles. This requires policies that follow the hierarchy of traffic reduction, modal shift and electrification. Reduced per-person journeys has been a feature in the UK since the beginning of the century, so this hierarchy is in line with changing patterns of behaviour and the well-researched popular desire for enhanced local living. Following this policy hierarchy will support a resilient and inclusive recovery from the pandemic.

We further recognise that a new Local Plan will be strengthened in its climate, sustainability, and inclusivity objectives by the adoption of a robust and ambitious Local Transport Plan.

We resolve to use our influence at Midlands Connect to pursue the reduce/shift/electrify

hierarchy. As the sub-national body Midlands Connect should produce its own transport decarbonisation strategy, should review all infrastructure plans against this and should apply for all available powers on transport including those over bus franchising.

We further resolve that the forthcoming Local Transport Plan will:

- 1. Include a commitment that LTN 1/20 is fully adopted when planning active travel routes and infrastructure.
- 2. Adopt 'Transport for New Homes' principles for responding to development proposals. Where proposals do not meet high standards against the Transport for New Homes checklist they should be rejected.
- Include Public Health as an originator and consultee in its development, recognising the impact that transport planning will have on health and wellbeing.
- 4. Include a pathway to net zero carbon emissions from transport that is compatible with local, regional and national carbon budgets and our net zero targets, to include interim emissions targets and monitoring processes.

Councillor Nicholas Bardsley proposed the following amendment

Proposed amendment to Motion 2 Principles for LTP4

Insert after "We further resolve that the forthcoming Local Transport Plan will: A new item 1

- 1. recognise and welcome the vital part played by the construction of the North West Relief Road in:
- providing a strategic road link from the A5 to Battlefield entirely bypassing the town centre
- enhancing the economic development of Shropshire as a whole
- -relieving Shrewsbury itself and many villages North of the town from the blight of through traffic which currently causes so much congestion, pollution and danger to pedestrians in these communities.

The amendment was seconded by Councillor Davenport. In moving the amendment, Councillor Bardsley stated that anything he said was in the context of not knowing the details of the planning application and he had formed no view of the planning application. The Monitoring Officer confirmed that a planning application had not yet been submitted. Councillor Bardsley requested a recorded vote:

Upon being put to the vote the amendment proposed by Councillor Evans was lost with the majority voting against it.

Members debated the substantive motion as amended by Councillor Bardsley.

RESOLVED:

This council recognises the urgent need to address the transport related climate emergency whilst supporting better and more inclusive connectivity for our residents. We further recognise the opportunity that a switch to active travel presents to address public health issues associated with sedentary lifestyles. This requires policies that follow the hierarchy of traffic reduction, modal shift and electrification.

Reduced per-person journeys has been a feature in the UK since the beginning of the century, so this hierarchy is in line with changing patterns of behaviour and the well-researched popular desire for enhanced local living. Following this policy hierarchy will support a resilient and inclusive recovery from the pandemic.

We further recognise that a new Local Plan will be strengthened in its climate, sustainability, and inclusivity objectives by the adoption of a robust and ambitious Local Transport Plan.

We resolve to use our influence at Midlands Connect to pursue the reduce/shift/electrify hierarchy. As the sub-national body Midlands Connect should produce its own transport decarbonisation strategy, should review all infrastructure plans against this and should apply for all available powers on transport including those over bus franchising.

We further resolve that the forthcoming Local Transport Plan will:

- 1. Recognise and welcome the vital part played by the construction of the North West Relief Road in:
- providing a strategic road link from the A5 to Battlefield entirely bypassing the town centre
- enhancing the economic development of Shropshire as a whole
- -relieving Shrewsbury itself and many villages North of the town from the blight of through traffic which currently causes so much congestion, pollution and danger to pedestrians in these communities.
- 2. Include a commitment that LTN 1/20 is fully adopted when planning active travel routes and infrastructure
- 3. Adopt 'Transport for New Homes' principles for responding to development proposals. Where proposals do not meet high standards against the Transport for New Homes checklist they should be rejected.
- 4. Include Public Health as an originator and consultee in its development, recognising the impact that transport planning will have on health and wellbeing.
- 5. Include a pathway to net zero carbon emissions from transport that is compatible with local, regional and national carbon budgets and our net zero targets, to include interim emissions targets and monitoring processes.

Notice of Motion 3.

The following motion was proposed by Councillor Julian Dean and seconded by Councillor Kate Halliday.

Support the Climate and Ecological Emergency Bill

Humans have already caused irreversible climate change, the impacts of which are being felt in the UK and around the world. Global temperatures have increased by 1 degree Celsius from pre-industrial levels. Atmospheric CO₂ levels are above 400 parts per million (ppm) and continue to rise. This far exceeds the 350 ppm deemed to be a safe level for humanity.

Without more significant and sustained action, the world is set to exceed the Paris Agreement's 1.5°C limit between 2030 and 2040. Therefore the current UK target of net zero by 2050 is not satisfactory. It is too little too late.

The increase in harm caused by a rise of 2°C rather than 1.5°C is significant. This is described by the Intergovernmental Panel on Climate Change's Special Report on Global Warming of 1.5°C published in October 2018. According to the IPCC, limiting heating to 1.5°C may still be possible with ambitious action from national and subnational authorities, civil society, the private sector and local communities. The costs of failing to address this crisis will far outstrip the investments required to prevent it. Investing now will bring many benefits in the form of good jobs, breathable cities and thriving communities.

Council notes that

- (i) This council has declared a climate emergency;
- (ii) Many local authorities have established Citizens' Assemblies that are playing an important role in assisting them in their plans to achieve net zero by 2030 or before; and that
- (iii) There is a Bill before Parliament—the Climate and Ecological Emergency Bill (published as the "Climate and Ecology Bill")—according to which the Government must develop an emergency strategy that:
 - a. requires that the UK plays its fair and proper role in reducing greenhouse gas emissions consistent with limiting global temperature increase to 1.5 degrees C above pre-industrial temperatures;
 - b. ensures that all the UK's consumption emissions are accounted for;
 - c. includes emissions from aviation and shipping;
 - d. protects and restores biodiverse habitats along overseas supply chains;
 - e. restores and regenerates the UK's depleted soils, wildlife habitats and species populations to healthy and robust states, maximising their capacity to absorb CO₂ and their resistance to climate heating:
 - f. sets up an independent Citizens' Assembly, representative of the UK's population, to engage with Parliament and Government and help develop the emergency strategy.

Council therefore resolves to:

- (i) Support the Climate and Ecological Emergency Bill
- (ii) Inform the local media of this decision;
- (iii) Write to local MPs, asking them to support the Bill; and
- (iv) Write to the <u>CEE Bill Alliance</u>, the organisers of the campaign for the Bill, expressing its support (campaign@ceebill.uk).

Councillor Dean Carroll submitted the following amendment to the Motion:

Proposed amendment to Motion 3. Support for CEE Bill

That the recommendation be amended as follows: -

To remove everything after "This Council resolves too" and replace with "Refer this matter to a Task & Finish Group to look at the Climate & Ecological Emergency Bill in detail and to make recommendations on Shropshire Council's response to the Bill"

Councillor Paul Milner seconded the amendment. Upon being put to the vote, the proposed amendment was agreed.

RESOLVED:

This Council resolves too refer this matter to a Task & Finish Group to look at the Climate & Ecological Emergency Bill in detail and to make recommendations on Shropshire Council's response to the Bill

The meeting was adjourned at 2.11 p.m. and reconvened at 2.22 p.m.

Motion No. 4.

The following motion was moved by Councillor David Vasmer and seconded by Councillor Andy Boddington.

Putting Pedestrians First

This Council notes:

- 1. Pedestrians includes all those who walk including parents with prams and pushchairs and those who use mobility aids such as wheelchairs or scooters.
- 2. The special needs of people who are partially sighted or blind.
- 3. Increased numbers of people are walking due to the COVID-19 pandemic.
- 4. 16% of Shropshire households do not have a car and 42% of Shropshire households have one car. Therefore, a large number of people are reliant on alternative forms of transport.
- 5. In 2018, 27% of all trips were made by walking, covering 3% of all distance travelled.
- 6. The Department of Transport has just concluded a consultation into changes to the Highway Code which propose a hierarchy of users, putting pedestrians first.
- 7. In September 2020 Shropshire Council unanimously resolved to support the Prime Minister's Gear Change policy: "A bold vision for cycling and walking".
- 8. The Government's Gear Change policy says:
 - a. "Increasing walking and cycling can help tackle some of the most challenging issues we face as a society – improving air quality, combatting climate change, improving health and wellbeing, addressing inequalities and tackling congestion on our roads."
 - b. "well-planned improvements in the walking environment" can increase footfall by up to 40%
 - c. "We want to see a future where half of all journeys in towns and cities are cycled or walked. 58% of car journeys in 2018 were under 5 miles."
 - d. From now "cycling and walking measures are no longer seen as an afterthought but have moved to the very heart of considerations for all transport policy and planning, at all levels of leadership."
 - e. A new commissioning body and inspectorate, Active Travel England, led by a new national cycling and walking commissioner which will be established in the next few months.

- f. Active Travel England will also begin to inspect, and publish annual reports on, highway authorities. They will be graded on their active travel performance and dangerous failings in their highways for cyclists and pedestrians will be identified.
- g. "It is our intention that the commissioner and inspectorate will, in this regard, perform a similar role to Ofsted in raising standards and challenging failure."
- 9. The Department for Transport (DfT) is drawing up legislation to enact Part 6 of the 2004 Traffic Management Act.
- 9. Part 6 will allow local authorities outside London to enforce common road offences for the first time in England. This will mean that Shropshire Council is able to enforce School Streets and Low Traffic Neighbourhoods using cameras without the need for physical barriers in the road.

This Council further notes:

- 11. A large number of pavements across Shropshire are damaged, too narrow, or inadequate in some other way.
- 12. In rural areas pavements are often missing on routes to community facilities such as GP surgeries, schools, and shops.
- 13. Pavements are often blocked by temporary road signs for roadworks.
- 14. The level of pavements is often disrupted for access to driveways and other inlets.
- 15. Pavement users in wheelchairs, and those with prams and pushchairs, cannot always find dropped kerbs to cross roads.
- 16. Pavements are often damaged and uneven as result of being uplifted by tree roots.
- 17. Pavements are not swept regularly which in autumn means they can become very slippery with rotting leaves.
- 18. In winter pavements are not cleared of snow and the contrast with major roads, which are always cleared of snow, could not be more stark. At such times, many pedestrians are forced to walk in the road.
- 19. All of the above make it difficult for pedestrians, particularly those with mobility issues or those using prams and pushchairs and can act as a disincentive to leave home and thereby increase social isolation.
- 20. Walking is an important, but often ignored, part of our transport system.
- 21. Shropshire needs to be proactive rather than reactive to the establishment of Active Travel England.
- 22. Shropshire only received 14% of the funds it bid for in Phase 2 of the Active Travel Fund (75% of the indicative funding allocation).

This Council resolves to:

- 23. Widen the Commonplace consultation launched by the Big Town Plan to cover the whole of Shropshire with the aim of allowing residents to identify where pavements and the walking environment is inadequate. This would enable the council to develop a list of locations that require attention.
- 24. Ensure that all new housing developments in Shropshire are easily and safely accessible and navigable by foot.
- 25. Instruct the Director of Place to investigate and report back to Scrutiny how to
 - a. Ensure that all temporary roadwork signs are installed at a high level, making use of lampposts or other Council infrastructure, so that messages are clear to

- drivers but do not restrict the pavement or the roadway. Where this is not possible, signs should be placed on the road and never on the pavement.
- b. Ensure that a constant pavement height is maintained where driveways are installed across the pavement.
- c. Increase the number of pedestrian crossings and reduce pedestrian waiting times at crossings to a minimum.
- 26. Ensure that Shropshire is ready to use the new powers enabled by Section 6 of the 2004 Traffic Management Act to improve the walking environment.
- 27. Appoint an officer in Highways to have specific responsibility for walking.
- 28. Establish a Task and Finish Group to review pavement maintenance.
- 29. Ensure that Shropshire is fully prepared for the establishment of Active Travel England and associated funding streams.
- 30. Ensure that pedestrians are placed at the top of the hierarchy of users in LTP4

RESOLVED:

That the Motion on Notice be supported.

Notice of Motion 5 – Provision of Skips after Flooding.

The following Motion was proposed by Councillor Nat Green and seconded by Councillor Nigel Hartin.

Council notes

- 1. The transfer of the provision of emergency skips from Street Scene to Highways.
- Highways during the recent floods provided just one skip to Coton Manor flats and refused to supply any extra ones that were needed. This contrasts with the swift and plentiful supply of skips that were supplied by Street Scene after the flooding last year.
- 3. The provision of skips is not a luxury; it is essential for the maintenance of public health and to assist the psychological well-being of those who have been flooded, as it enables them to make the first step in rebuilding their lives.

Council resolves

- To reverse this recent change in policy and that in future when flooding does occur, no matter where it is, the previous practise of providing as many skips as needed will continue to be provided by whichever department has from time to time the responsibility for skip provision.
- 2. All skips that are provided to assist residents suffering from flood problems will be supplied at no cost to the local residents.

Received from Councillor Ruth Houghton and answered by Councillor Robert Macey, Portfolio Holder for Housing and Strategic Planning, in relation to empty homes in Shropshire. By way of a supplementary question, where empty homes are and particularly in relation to where people are bidding on Home Point and where there is a need. The Portfolio Holder for Housing and Strategic Planning responded by confirming that he would take the supplementary question back to Officers to prepare a response.

Received from Councillor Andy Boddington and answered by Councillor Peter Nutting, The Leader of Shropshire Council, in relation to the 'support for you from your council during lockdown' letter that had been sent to every household within Shropshire.

Received from Councillor David Vasmer and answered by Councillor Steve Davenport, Portfolio Holder for Highways and Transport, in relation to the North West Relief Road. By way of a supplementary question, Councillor Vasmer made reference to page 320 of the agenda, the Capital Programme report and questioned that the figures referred to for the North West Relief Road spending did not tally with the figures given in the Portfolio Holders response to the his question. The Portfolio Holder responded by confirming that he would check the figures and respond by email after the meeting and include all Members in his response.

Received from Councillor David Vasmer and answered by Councillor Steve Davenport, Portfolio Holder for Highways and Transport, in relation to the performance of Highways contractor Kier. By way of a supplementary question, Councillor Vasmer asked why, when the Portfolio Holders response made it clear that Keir were not performing as they should be has Members not been informed. The Portfolio Holder responded by confirming that he would take the supplementary question back to officers and circulate the response with all Members, adding that some of the key performance indicators were still going through the legal processes.

Received from Councillor Kate Halliday and answered by Councillor Steve Davenport, Portfolio Holder for Highways and Transport, in relation to flood prevention plans in Shropshire.

The Speaker reported that an additional, seventh question had been allowed as it had been received in time, but omitted due to officer error.

Summary

Council is asked to make appointments to outside bodies, committees and groups where urgent appointments are required. It is also requested to agree a process for the consideration of appointments to the remaining committees, groups and outside bodies.

Recommendations

- A To agree urgent appointments to the outside bodies, committees and groups set out in Appendix 1 to this report.
- B To agree that a small working group comprising Group Leaders or their nominated representatives be established to appoint to the remaining outside bodies, committees and groups, and that any bodies where agreement cannot be reached by the Group be referred back to Council for decision.
- C That, the Chief Executive in consultation with appropriate Group Leaders be authorised to agree any other appointment that may be necessary as a matter of urgency.

REPORT

Background

- 1. Shropshire Council is asked to make appointments to various committees, groups and over 50 outside bodies.
- 2. The outside bodies range from national, regional and county organisations down to local charitable bodies. Under the Constitution, appointments to outside bodies are the responsibility of Council at their Annual meeting. Between these meetings the Leader of the Council has authority to approve appointments regardless of how they might occur and to inform the Chief Executive accordingly.
- 3. Some appointments need to be made urgently as meetings are scheduled for late May and June. National and Regional Local Government Associations also need to know representation in order to set political balance.
- 4. It should be noted that all the outside bodies appointed to in 2017 have been approached to see if they still require Council representation and the list included as Appendix 1 has been updated to reflect their responses. The lists of remaining outside bodies, committees and groups requiring representation have likewise been amended.

Proposals

- 5. Those outside bodies, Committees and groups where urgent appointments are required are set out in Appendix 1 to this report. Council is asked to agree appointments to these bodies. (Names to be circulated at the meeting.)
- 6. It is then recommended that the remaining appointments are considered by a Working Group comprising of Group Leaders or their nominated representatives and that any areas where agreement cannot be reached by the Group be referred back to Council for decision.

REPORT OF THE INDEPENDENT REMUNERATION PANEL 2021

1. INTRODUCTION

1.1 The Independent Remuneration Panel met on 18 November 2020 and received oral representation from:

Andy Begley, Chief Executive.

Councillor Peter Nutting, Leader.

Councillor Ann Hartley, Chair of the Council.

Councillor Gwilym Butler, Portfolio Holder.

Councillor Claire Wild, Chair of Performance Management Scrutiny Committee.

Councillor Tom Biggins, Chair of the Pensions Committee.

Councillor Roger Evans, Liberal Democrat Group Leader.

1.5 The Panel obtained a breakdown of the number of Full Council and Sub-Committee meetings for 2018 and 2019 and the attendance of Councillors at training events in 2017.

2. MEMBERS BASIC ALLOWANCE

2.1 Recommendation.

The Basic Allowance be increased to 12,000.00 per annum.

2.2 Reasoning.

There was representation from some Councillors of a need to increase the basic allowance, particularly in view of the reduction in allowance from that received in 2009, but this was not a universal opinion.

Some Councillors suggested an increase in the basic allowance would attract younger, and more diverse, candidates for election. There was also comments on the higher "workload" experienced by Councillors representing rural areas compared with urban areas. The Panel understands that the Basic Allowance is an amount that will be paid to every elected Councillor and there is no ability to vary that according to any differences arising from the peculiarities of the constituency that a Councillor represents.

The Panel referred to the CIPFA Benchmarking table for Shropshire Council dated 2017/18 and noted that, at that time, the Basic Allowance was above the median level for the group but not at the top of the range.

The Panel concluded that an increase at this time was justified and the proposed increase remains within the "spread" of allowances shown in the CIPFA Benchmarking table.

3. SPECIAL RESPONSIBILITY ALLOWANCES.

The Special Responsibility Allowance is stated as a proportion of the Basic Allowance. The Panel decided to continue this method.

3.1 Comment on the roles of Chairman of the Council and Speaker of the Council.

The Panel understands that the Speaker is responsible for chairing full Council meetings and the Chairman is the civic head of the Council. They each serve as a deputy to the other. The Panel felt that this was an unusual arrangement and, initially, somewhat confusing. The Council may wish to regularise the arrangement.

3.2 Chairman of the Council

Recommendation

The Special Responsibility Allowance for the Civic Head of the Council (the Chairman) be reduced from 0.75 to 0.25

Reasoning.

The panel considered that the existing Special Responsibility Allowance is not commensurate with the role when compared to the other roles attracting a Special Responsibility Allowance.

3.3 Speaker of the Council.

Recommendation.

The Special Responsibility Allowance for whoever chairs the Full Council Meetings (The Speaker) be reduced from 0.75 to 0.5

Reasoning.

The Panel considered that the existing Special Responsibility Allowance was not commensurate with the role, particularly when compared to the other Roles attracting a Special Responsibility Allowance.

3.4 Leader of the Council

Recommendation.

The Special responsibility Allowance be increased from 2.0 to 2.25

Reasoning.

The majority of Councillors who expressed a view considered that the level of responsibility of the Leader had increased significantly. The panel noted that the CIPFA comparison placed the Leader significantly below the median level for the group.

3.5 Deputy Leader of the Council.

Recommendation.

The Special Responsibility Allowance be increased from 1.25 to 1.5

Reasoning

As for the Leader, there has been an increase in the level of responsibility and the CIPFA comparison was significantly below the median.

3.6 Executive Members (Portfolio Holders)

Recommendation.

The Special responsibility Allowance remain at 1.0

Reasoning.

The level of responsibility remains unchanged.

3.7 Deputy Portfolio Holders

Recommendation

The Special responsibility Allowance of 0.5 be reduced to 0.25

Reasoning

A Deputy Portfolio Holder has an advisory and supporting role to the Portfolio Holder; is not a member of the Cabinet and does not exercise any executive responsibility. Shropshire Council Constitution states that such appointments are at the discretion of the Leader of the Council.

3.8 Opposition Group Leader(s) (with, at least, 10% of the membership of the Council.)

Recommendation.

That the Special responsibility Allowance remain at 0.5

Reasoning

The level of responsibility remains unchanged.

3.9 Chairman of Scrutiny Committee(s)

Recommendation

That the level of the Special Responsibility Allowance remain at 1.0

Reasoning

The role description for the Chair suggests a significant level of responsibility in addition to chairing the Committee.

3.10 Chairman of Area Planning Committee(s)

Recommendation.

That the level of Special Responsibility Allowance be increased from 0.5 to 0.75

Reasoning

A number of Councillors informed the Panel that the "workload" of the Planning Committees had increased since the number of Planning Committees was reduced from three to two with a consequential rise in the number of meetings for both remaining committees.

3.11 Vice Chairman of Area Planning Committee(s)

Recommendation.

That the level of Special Responsibility Allowance be increased from 0.125 to 0.25

Reasoning

The increase in Committee meetings, as referred to above.

3.12 Chairman of Strategic Licensing Committee

Recommendation

That the level of Special Responsibility Allowance remain at 0.25

Reasoning

The panel consider this to be commensurate with the responsibility of the role.

3.13 Chairman of the Licensing Sub-Committee/ Vice-Chairman of the Strategic Licensing Committee.

Recommendation

That the level of Special Responsibility Allowance of 0.25 be reduced to 0.125

Reasoning

The Panel understands that there has been a significant reduction in the workload of this subcommittee.

3.14 Chairman of Audit Committee

Recommendation

That the level of the Special Responsibility Allowance be reduced from 0.5 to 0.3

Reasoning

There does not appear to be a written Role Description for the Chairman of the Audit Committee and so the Panel are relying on verbal information. The Panel understand that the role is primarily a review function and consider that the Special responsibility Allowance should be reduced.

3.15 Chairman of Pensions Committee or Vice-Chairman of pensions Committee

Recommendation

That the Special Responsibility Allowance for the Chairman remain at 0.25 but that the Special responsibility Allowance for the Vice-Chairman be discontinued.

Reasoning

The Panel understands that this committee is a joint committee for Shropshire Council and Telford and Wrekin Council. The Chairman is traditionally from one Authority and the Vice-Chairman from the other Authority.

The Panel concluded that the role of Vice-Chairman did not warrant a Special responsibility Allowance.

4. Child and Dependent Carers Allowance.

4.1 The following is extracted from the document setting out the Shropshire Council – Members Allowances Scheme.

"5. Child and Dependant Carers' Allowance

A child care allowance of up to £6.19 per hour (wef 01/10/12), subject to a maximum of £2,500 per member per annum, will be paid towards the costs of child care, on evidence being supplied of the amount claimed having been incurred in employing a carer to look after a child or dependant who is a member of the councillor's family and living with the councillor and who cannot be left alone."

4.2 Recommendation

That the allowance of "up to £6.19 per hour" should be amended to "up to the National Living Wage hourly rate or the actual cost, whichever is lower", and the "maximum of £2,500 per member per annum" be increased to a "maximum of £3,500 per member per annum."

The Panel understands that, from April 2021, the National Living Wage for those 23 years and over will be £8.91 per hour.

4.3 Reasoning

Several Councillors referred to the desirability of younger and more diverse candidates seeking election to the Council. The Panel considers that the existing allowance is too low and could inhibit those with caring responsibilities from undertaking Council duties.

5. Travelling and Subsistence Allowances

The Panel does not make any recommendations. The Panel understands that "mileage" allowances are subject to HMRC guidance in respect of tax liability.

6. Comment on Training Provision for Councillors

The Panel were provided with a spreadsheet showing attendance at training sessions by Councillors in 2017 as part of understanding the range of activities undertaken by Councillors.

The Panel suggest that the Council give consideration to designating certain training as "Essential Training" which Councillors are required to undertake as a condition of receiving the full Basic Allowance.

7. Recommendations.

- 7.1 That the Basic Allowance be increased to £12000.00
- 7.2 That the Special Responsibility Allowance multiplier for the Chairman of the Council (Civic Head) be reduced from 0.75 to 0.25
- 7.3 That the Special Responsibility Allowance multiplier for the Speaker (Chair of Full Council Meetings) be reduced from 0.75 to 0.5
- 7.4 That the Special Responsibility Allowance multiplier for the Leader of the Council be increased from 2.0 to 2.25
- 7.5 That the Special Responsibility Allowance multiplier for the Deputy Leader of the Council be increased from 1.25 to 1.5
- 7.6 That the Special Responsibility Allowance multiplier for Executive Members (Portfolio Holders) remain at 1.0
- 7.7 That the Special Responsibility Allowance multiplier for Deputy Portfolio Holders be reduced from 0.5 to 0.25
- 7.8 That the Special Responsibility Allowance multiplier for Opposition Group Leader(s) remain at 0.5
- 7.9 That the Special Responsibility Allowance multiplier for Chairman of Scrutiny Committee(s) remain at 1.0
- 7.10 That the Special Responsibility Allowance multiplier for Chairman of Area Planning Committee(s) be increased from 0.5 to 0.75
- 7.11 That the Special Responsibility Allowance multiplier for Vice Chairman of Area Planning Committee(s) be increased from 0.125 to 0.25
- 7.12 That the Special Responsibility Allowance multiplier for Chairman of Strategic Licensing Committee remain at 0.25
- 7.13 That the Special Responsibility Allowance multiplier for Chairman of the Licensing Sub-Committee/Vice Chairman of the Strategic Licensing Committee be reduced from 0.25 to 0.125
- 7.14 That the Special Responsibility Allowance multiplier for Chairman of Audit Committee be reduced from 0.5 to 0.3
- 7.15 That the Special Responsibility Allowance multiplier for Chairman of Pensions Committee remain unchanged at 0.25.

7.16 That the Special Responsibility Allowance multiplier for Vice Chairman of Pensions Committee be discontinued.

7.17 That the Child and Dependent Carers Allowance be amended as follows:

That the allowance of "up to £6.19 per hour" should be amended to "up to the National Living Wage hourly rate or the actual cost, whichever is lower", and the "maximum of £2,500 per member per annum" be increased to a "maximum of £3,500 per member per annum."

7.18 The Panel makes no recommendation with regard to Travel and Subsistence Allowances.
