## 1. Summary

To consider an application for a new Premises Licence.

Premises: Gather, Unit 2, SY8 Studios, Gravel Hill, Ludlow, SY8 1FP

Shropshire Council being the authorised licensing authority for the above premises has received an application for a new premises licence.

The application has been accepted as a valid application and during the statutory consultation period relevant representations were made. The application is therefore required to be determined by way of a hearing of the Licensing Sub-Committee.

In determining the application the licensing authority must give appropriate weight to:

- the steps that are necessary to promote the licensing objectives;
- the representations (including supporting information) presented by all parties;
- Guidance issued under Section 182 of the Licensing Act 2003;
- Shropshire Council's Licensing Policy 2019 2024.

After considering all the relevant issues the licensing authority may grant the application in full or in part, subject to such conditions that are deemed necessary and appropriate. Any conditions imposed must be appropriate for the promotion of the licensing objectives.

Alternatively the application can be refused if it is considered appropriate for the promotion of the licensing objectives.

Following a hearing, the licensing authority should give its decision and provide reasons to support it. This will be important if there is an appeal by any of the parties.

All parties are required to be notified of a decision and that decision should be accompanied by information on the right of the party to appeal.

#### 2. Recommendations

That the Sub-Committee determines the application in accordance with the Statutory Guidance issued under s182 of the Licensing Act 2003, the Council's Statement of Licensing Policy, the information contained within this report, supporting documentation and having had due regard to the applicant and the parties/authorised bodies making relevant representations.

That the Sub-Committee determines the application in accordance with the options in paragraph 11.

That the Sub-Committee provides the reasons for its decision.

# 6. Purpose of report

To consider an application for a new Premises Licence for Gather, Unit 2, SY8 Studios, Gravel Hill, Ludlow, SY8 1FP (A copy of the location map and location photographs can be found at **Appendix A and B**).

# 7. Background

7.1 Art- Iculate (Shropshire) Ltd have made an application for a new premises licence for Unit 2 of SY8 Studios, which is a detached two storey building accessed via

Ludlow Community Hospital entrance. (A copy of the application and plan can be found at **Appendix C and D**).

The applicant's proposal is to run a cowork and small events space, along with a shop. Alcohol purchased would be for consumption on and off the premises, with the provision of films to be shown predominantly from the first floor for approximately 10- 20 people.

7.2 The requested licensable activities and opening hours are:

#### Supply of Alcohol (Consumption on and off the premises)

Monday to Saturday 12:00 till 23:00

Sunday 12:00 till 22:00

## Films (Indoors)

Monday to Friday 17:00 till 22:00

Saturday and Sunday 09:00 till 22:00

#### **Opening Hours**

Monday to Saturday 08:00 till 23:30

Sunday 08:00 till 22:30

7.3 For a new application, applicants are required to submit an operating schedule detailing how they intend to promote the four licensing objectives, these are the prevention of crime and disorder, promotion of public safety, the prevention of public nuisance and the protection of children from harm. The applicant has indicated those steps on their application within section M of the application.

Representations were received off authorities and then withdrawn following agreements between the applicant and Environmental Protection, Trading Standards, Police and Public Health.

Planning made comments only.

7.4 A document to show all agreed conditions and times between applicant and authorities, including unamended conditions from the application form has been produced for clarity and to prevent duplication. (A copy of the 'consolidated proposed conditions and times' can be found at **Appendix E**).

## 8. Representations received (Responsible Authorities)

8.1 Police agreed:

#### Prevention of Crime and Disorder

- 1. Colour digital CCTV, with a picture quality capable of being used for evidence will be installed to cover point(s) of sale, entrances / exits and any external areas used for licensable activities or where outside seating is provided. The CCTV will be always operational the premises is open to the public.
- 2. CCTV recordings will be retained for a minimum of 30 days and made available in a viewable format to any authorised authority on request. On request means at the time of the request, in a format which is viewable remotely and not dependent on the premises CCTV system.
- 3. When the premises is open to the public there will always be a member of staff on site who is trained in the operation of the CCTV system and is able to provide recordings in a viewable format to any authorised authority on request.
- 4. There will be signage in the premises, clearly visible to members of the public, which states that CCTV is in operation.
- 5. The Premises will have a zero tolerance to drugs policy. The Licence Holder shall display notices at the entrances to the premises advising attendees that the police will be informed if anyone is found in possession of controlled substances.
- 6. Drugs found will be placed in a suitable locked receptacle kept for that purpose. Means for securing and unlocking the receptacle will be held by the Premises Licence Holder or a nominated responsible person. A record shall be made of the date and time of the find, the person who made the find and the person who secured the found item(s). This record will be made available to any authorised authority on request.
- 7. The Premises Licence Holder shall make suitable arrangements with the police for the collection of any found items as soon as possible after they are found.
- 8. There will be a duty of care policy formulated towards persons who are refused admission or who are ejected from the premises.
- 9. Incidents of crime and / or disorder will be recorded and reported to police as soon as practicable. Copies of these records will be provided to any authorised authority on request. The record will contain full details of persons reporting and any victims along with times and circumstances of the incident.
- 10. A log shall be kept detailing all refused alcohol sales.
- 11. Vertical Drinking of alcohol shall not be permitted.

#### 8.2 Public Health stated and agreed:

I understand that times have been reduced by environmental health, and in view of the location of the proposal, I would be supportive of this measure. Similarly as a means of minimising any disruption and any risk in relation to the health and wellbeing of hospital patients, I would agree with conditions whereby there would be a closed door, no-walk-ins, pre-book policy in relation to this application.

#### Public Safety

1. Details of local taxi firms to be displayed to customers within the main retail area of the premises.

## 8.3 Environmental Protection stated and agreed:

Acting as the Responsible Authority of the Licensing Objective the Prevention of Public Nuisance I have considered the application in some detail taking into account the fabric of the building and its proximity to the hospital. I am of the opinion that the application undermines the aforementioned objective and therefore have to formally object to a Premises Licence being granted. I would however withdraw my objection with immediate effect if the flowing changes / condition were agreed to be added to the operating schedule.

#### Prevention of Public Nuisance

Changes to Applied for Times:

Closing time to be reduced from 23:30 Hours to 22:30 Hours.

Supply of Alcohol (on-sales) reduced from 12:00 - 23:00 to 12:00 - 21:00

Supply of Alcohol (off-sales) reduced from to 12:00 – 23:00 to 12:00 - 17:30

#### Additional Conditions:

- 1. Customers will not be permitted to remove from the premises any drinks supplied by the premises (alcoholic or otherwise) in open containers or drinking vessels.
- 2. Consumption of alcohol shall be confined to the area of the building that is Licenced.
- 3. Entry to members of the public after 18:00 shall be restricted to individuals with pre-booked tickets / places and entry to individuals who turn up without a prior booking will be refused.
- All windows and doors facing towards the hospital site (i.e. those windows and doors that face East) shall be kept closed except for immediate ingress and egress.
- 5. No waste or refuse shall be placed into external waste bins after 20:00.
- 6. Heavy duty curtains to be drawn across all windows and glazed doors in any room where Films are being shown.
- 7. Clear and legible notices will be prominently displayed by exits to remind customers to leave quietly and have regard to our neighbours.
- 8. No events involving amplified sound shall take place until secondary glazing has been added to all windows and glazed doors in the Licensed area that face towards the hospital site (i.e. face East). For clarification the use of small portable devises such as a radio, phone or laptop which may provide low level background sound for personal enjoyment as opposed to providing entertainment as part of an event would be permitted without the need to enhance the sound insulation characteristics of the glazing.

### 8.4 Trading Standards agreed:

#### Protection of Children from Harm

- 1. A Challenge 25 Policy will be implemented with appropriate signage displayed at points of sale.
- 2. A challenge log for Challenge 25 and refusals will be maintained and made available to any authorised authority on request. The challenge log can be kept either electronically or in a hard backed/bound book.
- 3. Training on Challenge 25 procedures, proxy sales and individuals' responsibilities under the Licensing Act 2003 will be held for all persons involved in the supply of alcohol, prior to engaging in the serving of alcohol and within 14 days of them commencing this role.
- 4. Refresher training on Challenge 25, proxy sales and their responsibilities under the licensing act 2003 to be provided no less than annually. Training records retained and available at the premises to any authorised authority on request.

#### 8.5 Planning stated:

In commenting on the above mentioned licensing application as a responsible authority I can advise that planning do not object to a licence for the sale of alcohol being issued.

With that being said the Planning Permission in relation to the 'Change of use of Unit 2 from Class E to a mixed use of Class E and Class F and erection of a flue' under planning application 23/05098/COU, has not yet been determined and therefore the applicants are reminded that should planning permission be granted with conditions, this could impact what they have applied for within this application and any planning conditions must be adhered to regardless of what has been granted as part of the Licensing application.

# 9. Representations received (Other Persons)

- 9.1 18 representations were received against the application, one has since withdrawn and another withdrawn their concerns in relation to the on sales aspect of the application. Representations have concerns in respect of the four licensing objectives. The representation map displays the location of representations in relation to the premises. (A copy of the 'other persons' against location map can be found at **Appendix F**).
- 9.2 Principally in relation to the four licensing objectives these relate to the potential noise nuisance, proximity to the hospital and concerns of anti- social behaviour that could be caused from the venue having a premises licence. (Representations can be found at **Appendix G** 1 to 17).

- 9.3 12 supporting representations have also been received, who believe the application is positive for community. (Representations in support can be found at **Appendix H** 1 to 12).
- 9.4 All aspects of representations have been accepted, for consideration, giving the benefit of the doubt to the person/s making the representation to allow them to amplify at the hearing.
- 9.5 The applicant contacted all 'other persons' in an attempt to clarify the application. (Applicants supporting information can be found at **Appendix I**).

## 10. Options for Consideration

- 10.1 The options available to the Licensing Sub-Committee having considered all the relevant information are as follows:
  - To refuse to grant the licence
  - To grant the licence with conditions
  - To grant the licence but restrict the licensable activities
  - To grant the licence with restricted times
- 10.2 If the application is to be granted in line with the submitted operating schedule then conditions detailed in paragraph 7 and subsequent amendments/ additions in paragraph 8 of this report would need to be included in the licence, if deemed necessary and appropriate, with a justified decision.
- 10.3 Additional conditions or restrictions to licensable activities and/or times should only be imposed if considered appropriate for the promotion of the licensing objectives. If other law already places certain statutory responsibilities on a premises, it would not be appropriate to impose similar duties.
- 10.4 Members of the Sub-Committee should be advised that the applicant or any other person who made relevant representations in relation to the application may appeal against the decision made to the Magistrates' Court within 21 days of the date on which they were notified.

# 11. Standard of Decision Making

- 11.1 In accordance with the provisions of the Licensing Act 2003 and the Council's scheme of delegation, all applications where a relevant representation has been made need to be determined by this Sub-Committee.
- 11.2 When determining the application, the Sub-Committee should only consider issues, which relate to the four licensing objectives. The licensing objectives are:
  - The prevention of Crime and Disorder
  - Public Safety
  - The prevention of a Public Nuisance
  - The protection of Children from Harm

- 11.3 Members of the Sub-Committee must have regard to the statutory guidance issued under section 182 of the Licensing Act 2003 and the Council's Statement of Licensing Policy. Members of the Sub-Committee may deviate from the statutory guidance and licensing policy only if they deem that there is good reason to do so.
- 11.4 Members of the Sub-Committee should not allow themselves to predetermine the application or to be prejudiced in favour or opposed to the licence and shall only determine the application having had an opportunity to consider all relevant facts.

It is hard to imagine a less suitable combination. It is inevitable that there will be noise associated with the consumption of alcohol creating disturbance for patients and staff in the hospital. In addition, our back door lies about 30 metres from the hospital site, and it is impossible to believe that we will not be affected negatively by noise associated with events at the venue. Furthermore, there is a convenience store selling alcohol about 90 metres away so there are already options locally for the purchase of alcohol.

I am contacting yourselves in relation to the current licence application from Art-Iculate (Shropshire) Ltd. Ref: 23/03757/LPREM.

I am writing on behalf of a group of staff members from Dinham ward, Ludlow Hospital.

We are based in the property less than 20 feet away from the proposed licenced premises.

We are a ward with 24 inpatient beds. 4 of those beds are in side rooms which we use for end-of-life care.

When the building next door was sold, we as staff had initial concerns as to what the building would be used for. Once we found out it would be used for very small businesses, we felt reassured, but still concerned with parking problems. However, small businesses would probably be open Monday to Friday 9-5 roughly and then either closed over the weekend or working 9-5 Saturday and 10-4 on Sunday.

Since then, we have discovered a new plan for the building with a subsequent license to sell alcohol now being submitted. The application dated the 13th December, was then attached to the builder's fence on December 22nd.

As stated earlier in my email, we are a community hospital with some very poorly patients. Some patients and their relatives actually request to come to Ludlow for end-of-life care. So they can be closer to family and have a more peaceful and quiet final few days/hours.

During the summer months we obviously have the windows open and patients that are able to go outside have use of our patio area with views over Ludlow.

With the property next door at Unit 2 SY8 studios now putting in for an application to sell alcohol how is this going to affect the sick patients that we care for?

The application is to be able to serve alcohol up until 23:00. Can you imagine being seriously ill, with the windows open to allow for a cool breeze, only to hear a group of people outside drinking and smoking? If your relative was in the last few hours of life, how would you feel if you had people stood 20 feet from the room laughing and joking, drinking and smoking? How would you feel if you've been struggling with an alcohol addiction, you have gone through cold turkey in the acute hospital and you come to Ludlow hospital to regain your confidence and build your strength up, only for people to be stood by the window clinking glasses and chatting about how nice their cocktails taste? How would you feel if you've taken your relative outside in a wheelchair to see the beautiful views and spend some quality time with them only to have a group of up to 50 people stood 20 feet from you all drinking, smoking and talking loudly over one another?

Last summer we had some concerts take place at the castle. We actually had a patient call the police. Due to his dementia, he thought he had been locked in a pub and couldn't understand why the music was so loud. This was a one-off incident; however, can you imagine how this is going to impact the patients with dementia when there are up to 50 people stood around outside in in such close proximity in the summer months.

This leads me on to the issue of parking. Unit 2 has 12 parking spaces. If we have 50 people attending a gathering at any one time, where will everyone park? Please don't insult us by saying if the patrons cannot park in unit 2 car park, they will park in the roads around the hospital, no, they will see an empty space meant for hospital staff/visitors/patients and park there.

We now have 12 less parking spaces at the hospital and many staff who start for a late shift struggle to get parked. The extra 50 people attending unit 2 will only make parking harder.

If 50 people and even just 12 cars all start to leave unit 2 at 23:00-23:30 how do you think the noise will impact our poorly patients? Most of whom are elderly and some with a diagnosis of dementia will not understand why it is so noisy when it's a hospital and it's meant to be a place for rest and convalescing.

We are asking you to seriously take our concerns as staff into consideration before making any decisions on an alcohol license on a hospital property.

Drinking alcohol, whether during the day or at night frequently leads to noisy, anti-social/disruptive behavior which will be intimidating for vulnerable patients being nursed very near to the venue, (several of whom are receiving end of life care) to staff leaving or coming on shift, and for local residents and passers-by.

Drinking has no place in a hospital setting, and is not only inappropriate for the reasons detailed above but the resultant noisy, disruptive and/or aggressive behaviour linked to alcohol consumption would be completely disrespectful to those patients receiving care, their families and the staff looking after them.

#### **PUBLIC SAFETY**

As above. Patients being treated in the hospital for alcohol addiction/misuse are also likely to be negatively impacted by the presence of alcohol sales/consumption on the very same site where they are receiving care.

#### THE PREVENTION OF PUBLIC NUISANCE

With large groups of people attending events and drinking alcohol, and arriving at/leaving the venue at different times of the day and night, there is likely to be noisy and disruptive behaviour, which will be disturbing for patients receiving care, trying to sleep, the staff looking after them and visiting families, especially in the summer when windows are open. There are end-of-life patients being nursed just a few feet away from the venue.

Noise nuisance linked to drinking alcohol will particularly affect residents of Belle Vue Terrace which runs adjacent to the site.

Residents in other streets nearby will also be affected by the negative behaviour linked to alcohol consumption, as those attending the venue will likely leave noisily in pairs and groups, and as most will have arrived by car (as there are no public transport options after 6 pm) they will be walking up the residential streets collecting their cars after 11 pm, and causing disturbance to adults and children trying to sleep.

I withdraw completely my objection to "on site" sales associated with events constrained within SY8 units 1&2 within the reduced hours and modified conditions outlined by the applicant. I further withdraw my objection to "off sales" where alcohol is an integral component of a 100 House Coffee product. My objection now is solely against the off sales of third party alcohol based products.

I hope this is comprehensible to you and the sub-committee and makes life simpler for the sub-committee to reach a conclusion.

The application for off sales covers 2 scenarios.

The first is for sale of coffee based products containing a degree of alcohol which are produced by the business resident on the site (I.e. Hundred House Coffee). I have no objection to this type of off-sale transaction.

The second is for the site to operate as a distribution/pick up point for alcohol based products not produced on site but by third party businesses. This will result in additional traffic to/from the site by both those delivering the products and those collecting them. The additional traffic movements would cause both public nuisance and potentially increase risk to public safety.

I therefore am willing to support the application for off sales BUT ONLY for the first scenario.

#### THE PREVENTION OF HARM TO CHILDREN

This is a complex area, and one where perhaps a public health or specialist clinical opinion should be sought. The old maternity building was sold for private development in 2022, with a small parcel of land: entry and 12 car parking spaces to the front, and a small garden to the rear. The former maternity building is now known as 'SY8 Studios'. Ludlow Hospital's inpatient area is in an immediately adjacent building. The buildings share an access road/walkway and people entering the hospital building will pass very close to the entrance to SY8 Studios. This is probably a unique situation nationally.

Maternity services are now on the 1<sup>st</sup> floor of the hospital building. Pregnant women are obviously very regular visitors. The licence sought by the applicant currently makes provision for alcohol to be sold for consumption on and off the premises between 12 noon and 11 pm (10 pm on Sundays). NHS advice now is that there is no safe level of alcohol consumption for pregnant women. Alcohol intake during pregnancy increases the risk of miscarriage, premature birth, and a baby having low birthweight. It can also be associated with FASD, foetal alcohol spectrum disorder, with a range of lifelong consequences.

Shropshire for the last couple of years has had an above average incidence of female hospital admissions (STW Drug & Alcohol Strategy <a href="https://www.shropshire.gov.uk/media/21854/drug-and-alcohol-strategy-draft.pdf">https://www.shropshire.gov.uk/media/21854/drug-and-alcohol-strategy-draft.pdf</a>). The same document notes 2018 findings that in the West Midlands, 10% of women aged 16 years or older drink more than 14 units and up to 35 units a week, while 3% are classified as higher risk drinkers (i.e. those who drink more than 35 units per week). A proportion of pregnant women who attend Ludlow's maternity services will of course be alcohol users. A small number will have a history of significant alcohol misuse. These women will have received clinical advice to stop drinking. They may be stressed, they may be struggling.

The applicant seeks a licence to sell alcohol from 12 noon to 11 pm daily (10 pm on Sundays). Of course pregnant women walk past pubs and bars and alcohol outlets routinely – but probably not usually with an alcohol outlet very literally on the doorstep of their maternity unit. (Should SY8 Studios visitors be smoking tobacco in front of the building or in the vicinity of the building, this might also be an issue.)

I would be grateful if the Council could seek appropriate specialist advice on this. If the risk is considered to be a significant one, perhaps the Council might recommend appropriate conditions to mitigate potential harm to unborn children.

#### TO PREVENT PUBLIC NUISANCE

This is at the core of my concerns. Again, this reflects the probably unique situation of having a private venue seeking to sell alcohol and organise public events as a little 'island' on the site of an operational hospital offering clinical care.

The hospital building which has maternity services on its first floor **also** houses the hospital's 24-bed inpatient beds on its ground floor. Additionally, the ground floor has the hospital's four end-of-life care rooms. This building is immediately adjacent to SY8 Studios. At the closest point, the two buildings are 10 feet apart.

This premises licence application is related to planning application 23/05098/COU in which a change of use is requested.

The application notes that pre-application advice includes, 'Lastly, with reference to the events space which you indicated would include children's workshops for school holiday periods, a film club, listening events (live or recorded music but to a small group of 50, reading groups, writer's workshops, craft classes at weekends). This would not fall within Class E and is more likely to fall under Use Class F1\* or F2\*. Therefore a formal Change of Use would be required from Class E to Class F1/F2.'

Discussion on social media suggests that the intention is for the space to be used primarily for co-working, probably with some workshops and meetings, during the day. In the evening and at weekends, the space will be used for a range of public events – including film showings and live music events. An area of strong concern for me is the suggestion that an attendance of 50 people is regarded as a small group.

Evening events are intended to terminate no later than 10 pm. Alcohol will be sold until 11 pm. The premises can remain open until 11.30 pm. With these timings, there will of course be social drinking taking place in the late evening. An open-ended licence is being sought, with no constraints on numbers. The indicative number of 50 people has been discussed. This could potentially be exceeded as the applicant will have control of 250 square metres of internal space, and in practice will be the main user of the building. The premises have an open area to the front and a garden to the rear.

If people drink, smoke or chat outside the building, the chances of this causing a noise nuisance are high. People will be leaving the site on foot, as there are very few parking spaces. A group of people leaving at 11 pm or 11.30 pm who have been drinking socially, perhaps for several hours, will of course make a noise. There is no suggestion from me of irresponsible drinking. It is simply that social drinking promotes disinhibition — and noise.

In other locations, a sign on the door and a reminder to customers might well suffice. Here, the sale and consumption of alcohol will take place very close to a clinical area where sick people are being cared for and others are dying. As people leave, sound will of course carry. This is almost without question a unique situation. NHS premises and alcohol don't go together. They just don't. In NHS terms – and I spent much of my working life as an NHS clinician – this is an absolute.

There will inevitably be a public nuisance – to sick people, dying people, and their families. A peaceful and dignified death – in my view – must take priority over potential economic development. The NHS increasingly understands that there is one chance to get death right.

Particularly because of the impact on people in their final days or hours, I am opposed to this licence being granted.

TO PREVENT PUBLIC NUISANCE (continued)
A lesser but nevertheless very real public nuisance is around traffic management and the additional pressure on car parking. There are only 12 designated car parking spaces for SY8 Studios. Hopes have been expressed in the past that people will travel to the site by public transport. In Ludlow, the relevant bus routes are the 701 and 722 town buses. Neither runs in the evening or on Sundays. Ludlow people of course will not be attending by train. The reality is that most people visiting SY8 Studios will drive to the venue and will then seek parking in neighbouring streets.
It's a part of town I know, as I have friends who live in the immediate area. Parking is already difficult for people living in the narrow residential streets around the hospital. If events of any significant size take place, and if these take place with any regularity, there will of course be a nuisance caused to local residents.

TO PREVENT CRIME AND DISORDER
A quick thought, and I defer to the Council on the relevance of this. The same concern could obviously apply to any out-of-town pub, and this point may therefore be of no significance.
This is a venue which is slightly out of town. It is not an area that town centre residents or people from other parts of Ludlow would typically walk to or stroll around. People visiting SY8 Studios will tend to drive here, particularly in the evening – and the risk is that some of them will also drink and then find themselves over the limit on their drive home.

PUBLIC SAFETY
Arguably the distress that is likely to be caused to sick and dying people is a public safety issue.
Another concern, and one mentioned to me by a doctor friend, is this. The hospital of course sometimes treats people with a history of alcohol dependence. A proportion of hospital inpatients will have medical problems associated with alcohol misuse, and may be receiving support around managing their alcohol consumption.
For these people to be in the immediate vicinity of alcohol being sold and consumed is at best insensitive. There are also greater risks. Where patients have alcohol dependence, there may a temptation – if alcohol is on sale a minute's walk away – to buy alcohol themselves or to ask a visitor to buy alcohol for them. A very immediate availability of alcohol risks compromising treatment and support around management of addiction.
In this scenario, patients are members of the public. Their safety may be compromised.
In this scenario, patients are members of the public. Their safety may be compromised.  Smoking and alcohol consumption tend to go hand in hand. The NHS in recent years has recognised the need to play a more active role in tackling tobacco use, and as part of this, most trusts now have anti-smoking policies. Shropshire Community Trust has a policy that seeks to stop patients, visitors and staff from smoking in or near NHS premises. That will effectively be unenforceable at Ludlow Hospital if SY8 Studio staff or visitors are smoking a few feet away.

So many of these concerns arise from the entirely novel circumstances in which we find ourselves. I have worked in many, many NHS buildings. I have never worked in an NHS building where the site is shared with premises that sell alcohol. What is being proposed here in Shropshire is genuinely remarkable. I very much hope that Shropshire Council will seek public health and appropriate clinical guidance in this immensely unusual situation.

I note that Ludlow Hospital League of Friends, following meetings with hospital management, will be opposing both the licence to sell alcohol and the planning application. I know first hand of the strong concerns from hospital staff.

For some of the concerns I've raised, there might be mitigations.

There is something really fundamental here though. This is a hospital – an operational hospital that cares for sick people and dying people. If the license is granted, it is a virtual certainty that patient care will be compromised and that distress will be caused to sick and dying patients, to their family members, and to hospital staff. It is also entirely possible that the long-term future of the hospital would be jeopardised.

This would be the wrong outcome.

I object to the licensing of this property because of noise and public nuisance so close to the hospital. As a resident close to the Ludlow Brewery we are inconvenienced late at night by people trailing home from the brewery site.

We also find empty glasses and bottles left on window cills. I cannot imagine that this licensing supports those with alcohol problems attending the hospital or indeed the traffic both vehicular and pedestrian around a hospital that is supporting of sick patients.

#### **PUBLIC SAFETY**

In terms of safety the roundabout corner is often clogged by traffic and people. Any additional traffic leaving the hospital site due to the license premises will further congest this roundabout and also probably give more traffic to the road leading down to the town centre. This road has congestion and requires cars using the road to wait for oncoming traffic.

First Responder Vehicles need access urgently and those that attend the hospital usually cannot move quickly enough for the supposed revellers in SY8 studios licences premises. Lorry delivery of alcohol will also overwhelm the street.and drivers who think its OK to park in the hospital parking could obstruct the route of ambulances

The venue is situated on Ludlow Hospital grounds, which means there are over 20 in-patient beds and 4 end-of-life care beds in very close proximity to the venue. Permitting alcohol on the premises increases the likelihood of anti-social behavior, which would be unacceptable in such a sensitive environment.

### **PUBLIC SAFETY**

The venue is situated on Ludlow Hospital grounds and has only 12 parking spaces. The rest of the car park is for the use of the hospital. The venue is aiming to attract audiences / participants in excess of the limited on-site parking. The surrounding area is residential with a significant lack of onstreet parking.

Whilst there is no A&E facility at Ludlow hospital, there is an in-patient ward and a minor injuries unit, which both create a higher-than-average need for ambulance access to assist patients, or the seriously injured, whose condition may deteriorate beyond the scope of the care available at Ludlow hospital.

The availability of alcohol on a hospital site in a direct contravention of the NHS aims to create a safe environment for recovering alcoholics and addicts.

There would be nuisance caused to those convalescing on the ward, their visitors and family, and the end of life patients and their families would also experience unacceptable nuisance because of their proximity to the venue.

I was drawn to this wonderful project when I saw it in the advertiser the other week and thought it was great to see in Ludlow, a town that has reinvented itself to everyone's benefit through art, food and culture over the years, once the high brow Festival imploded possibly as it didn't really appeal to the breadth of audience that this project will

So what a brilliant project to have in Ludlow and next to a hospital as it is academically proven that art and creativity have incredible powers to help us stay and get well and lead happy, healthy lives - it's officially called 'social prescripting' - it may be that being next to the hospital may open a few eyes

In the same way one objection says alcohol (rightly) shouldn't be offered in a hospital, also like smoking it is permissible and acceptable outside and there are no planning laws governing this anyway so these really shouldn't be seen as valid objections.

Fundamental change of use for this building was granted a while back, after I believe a similar struggle so that ship has sailed.

The planning use is in place for most of what they want to do other than offer a drink with a film, workshop or meeting

They aren't proposing a bar as such or nightclub contrary to the worst fears of many, understandably as they have to consider the needs of vulnerable people in their care.

From what I have read about this project I think people have got the wrong end of the stick here, seen alcohol mentioned and seen red.

Parking may be an issue but it looks as if they are aware of and discussing that with the NHS

Before the planning department make a decision and respond to the tide of negativity that the Friends of the Hospital's press release will surely cause, I hope they will visit the site and see if this use REALLY is likely to cause the disturbance feared by the friends

Why do I care?

I was born in that hospital and my mother passed away two years ago so I am very aware of concerns and sensitivities around end of life, but also not to dwell onit but look for positivity, hope and tomorrow's generations.

She and my father ran a community arts/play scheme for young people for many years in Ludlow and my own work in this area is part of their legacy so I feel duty bound to support this application

I know nothing would have warmed my mothers heart at the end of her life more than knowing, even hearing that people are enjoying theirs

Nothing I have read in the application indicates that the proposed use will do anything other than improve the quality of life of people across Ludlow

# Representation on Gather application from Councillors Andy Boddington and Tracey Huffer (23/03757/LPREM)

### **Preamble**

Gather is hosted in SY8 Studios, which is the first major investment in East Hamlet, Ludlow for decades. It has brought a near derelict former NHS building back into use without public funds. The concept of SY8 Studios is to create a space for artists and the community in the most socially deprived area in Ludlow.

Gather is an unusual concept. The core business is Hundred House Coffee, grinding and selling specialist coffee. This will partly subsidise the Gather activities; arts and writing spaces, workshops and family events. Films will be shown. Not films that would be shown at the Ludlow Assembly Rooms which needs a bigger audience but films by local filmmakers. We have a lot of filmmakers in the Marches. They will have the opportunity to show their films and then talk about them.

The alcohol licence allows people attending events such as films to have a drink, just like Ludlow Assembly Rooms. It will also provide an extra income and that is needed to support the non-profit activities.

Despite the social media storm, we are excited by this project. It is balanced approach that has the potential to not only support the local community but also the broader arts community in the Marches.

Conditions have been proposed by Public Protection and Licencing. We support those.

A number of objections relate to parking. Applications are currently in the planning system to restrict parking with an ANPR and registration system, which will also apply to SY8 Studios.

We are concerned that planning issues have become confused with licencing issues. Planning will be decided independently of this licencing application.

We fully support this project which is bringing much needed financial and social investment to East Hamlet which has very different demographics from the town centre. The alcohol licence will help Gather balance the books and create an ambience for some of the events and activities.

### The prevention of crime and disorder

Shropshire Council and the applicant have agreed the following condition for the licence: "Entry to members of the public after 18:00 shall be restricted to individuals with pre-booked tickets / places and entry to individuals who turn up without a prior booking will be refused." We support this. The studios will not be a boozer (which would require a change of use class to sui generis). The layout of the building means it will not be a party venue. We have no concerns about crime and disorder.

### **Public safety**

We have no concerns about public safety. The serving of alcohol is strictly controlled by licencing and would not be available to patients or drop-in customers.

### The prevention of public nuisance

The contention here has been the impact on the hospital wards. SY8 Studios is designed so that social activities are furthest from the hospital wards. Amplified sound is banned by conditions unless there is secondary double glazing on east facing windows. Parking will be restricted by ANPR control. Notices will ask customers and visitors to leave quietly with respect for neighbours. We are confident there will no impact on the wards.



From my personal experience, the problem of suitable working space for freelance people in Ludlow and the surrounding area is very real and the introduction of Gather will be of enormous help to those who run their own businesses and seek a space to work from, not only to get physical space to do so but also to build an important community network within our town.

Further to plans for a co-working space, the application for an alcohol license is, to my understanding, part of the hopes to widen the appeal of the community space by offering members and users of the co-work space to attend small (max 20 people) gatherings for a film club among other low key ideas.

The ideas Annabelle and Matt are offering Ludlow are really exciting. Their plans will not involve causing harm to anyone and their intentions are to bring activities and events that will support local people of all ages. They have been subject to a barrage of really unpleasant hate on social media for their plans and as a planned user of the space, I feel driven to support their application. This is something that I think Ludlow could really do with to help creative people working in a rural area and to save the difficulties associated with trying to travel to and connect with support in the nearest cities of Manchester and Birmingham. The educational and community spaces intended with these plans seem such a positive idea to me and something I know that I and other local people would find very useful.

I am also in support of a license to aid music events to be held there. Having followed the progress of the plans for Gather and spoken to those responsible I believe they are being sensitive to the community's needs and that this sort of space is something missing, not only in Ludlow but in the wider area. I think this building is about as well situated for this purpose than most buildings in Ludlow, ie surrounded by open space on three sides and easily accessible by road.

We are Licensing Consultants who have been engaged by the applicant in this matter.

We write to thank you for contribution regarding the application process through your submission of a Representation in accordance with the Licensing Act 2003. This application will go to a Hearing before the Licensing Sub Committee at the Shirehall in SHREWSBURY at 10:00hrs on Monday 5<sup>th</sup> February 2024 where the issues raised will be discussed fully and then the matter will be decided.

We also write to inform you that, since the application was initially filed, liaison has been conducted between the applicant and the Responsible Authorities for Licensing in the County. As part of that process, the applicant has accepted the advice and guidance of the Authorities and the application has been amended considerably to reflect that advice. Overleaf are the Conditions proposed by the Authorities, which have been accepted by the applicant and will now form part of any new Licence which might be granted.

As a result of these further conditions, none of the Responsible Authorities now object to the grant of this Premises Licence.

For complete clarity, we now list the additional Conditions which have been agreed, along with the identity of the Responsible Authority which requested them:

# **Environmental Protection Department:**

Changes to Applied for Hours wherein Licensable Activities may be conducted:

Closing Time to be reduced from 23:30hrs to 22:30hrs.

Supply of Alcohol (ON-Sales) reduced from 12:00 - 23:00hrs to 12:00 - 21:00hrs

Supply of Alcohol (OFF-Sales) reduced from 12:00 - 23:00hrs to 12:00 - 17:30hrs

## Additional Conditions:

- Customers will not be permitted to remove from the premises any drinks supplied by the premises (alcoholic or otherwise) in open containers or drinking vessels.
- Consumption of alcohol shall be confined to the area of the building that is licensed.
- Entry to members of the public after 18:00hrs shall be restricted to individuals with pre-booked tickets / places and entry to individuals who turn up without a prior booking will be refused.
- All windows and doors facing towards the hospital site (i.e. those windows and doors that face East) shall be kept closed except for immediate ingress and egress.
- No waste or refuse shall be placed into external waste bins after 20:00hrs.
- Heavy duty curtains to be drawn across all windows and glazed doors in any room where Films are being shown.
- Clear and legible notices will be prominently displayed by exits to remind customers to leave quietly and have regard to our neighbours.
- No events involving amplified sound shall take place until secondary glazing has been added to all windows and glazed doors in the licensed area that face towards the hospital site (i.e. face East).

NB: For clarification the use of small portable devises such as a radio, phone or laptop which may provide low level background sound for personal enjoyment as opposed to providing entertainment as part of an event would be permitted without the need to enhance the sound insulation characteristics of the glazing.

#### Police:

- 1. Colour digital CCTV, with a picture quality capable of being used for evidence will be installed to cover point(s) of sale, entrances / exits and any external areas used for licensable activities or where outside seating is provided. The CCTV will be always operational the premises is open to the public.
- 2. CCTV recordings will be retained for a minimum of 30 days and made available in a viewable format to any authorised authority on request. On request means at the time of the request, in a format which is viewable remotely and not dependent on the premises CCTV system.
- 3. When the premises is open to the public there will always be a member of staff on site who is trained in the operation of the CCTV system and is able to provide recordings in a viewable format to any authorised authority on request.

- 4. There will be signage in the premises, clearly visible to members of the public, which states that CCTV is in operation.
- 5. The Premises will have a zero tolerance to drugs policy. The Licence Holder shall display notices at the entrances to the premises advising attendees that the police will be informed if anyone is found in possession of controlled substances.
- 6. Drugs found will be placed in a suitable locked receptacle kept for that purpose. Means for securing and unlocking the receptacle will be held by the Premises Licence Holder or a nominated responsible person. A record shall be made of the date and time of the find, the person who made the find and the person who secured the found item(s). This record will be made available to any authorised authority on request.
- 7. The Premises Licence Holder shall make suitable arrangements with the police for the collection of any found items as soon as possible after they are found.
- 8. There will be a duty of care policy formulated towards persons who are refused admission or who are ejected from the premises.
- 9. Incidents of crime and / or disorder will be recorded and reported to police as soon as practicable. Copies of these records will be provided to any authorised authority on request. The record will contain full details of persons reporting and any victims along with times and circumstances of the incident.
- 10. A log shall be kept detailing all refused alcohol sales.
- 11. Vertical Drinking of alcohol shall not be permitted.

# **Trading Standards:**

- A Challenge 25 Policy will be implemented with appropriate signage displayed at points of sale.
- A challenge log for Challenge 25 and refusals will be maintained and made available to any authorised authority on request. The challenge log can be kept either electronically or in a hard backed/bound book.
- Training on Challenge 25 procedures, proxy sales and individuals' responsibilities under the Licensing Act 2003 will be held for all persons involved in the supply of alcohol, prior to engaging in the serving of alcohol and within 14 days of them commencing this role.
- Refresher training on Challenge 25, proxy sales and their responsibilities under the licensing act 2003 to be provided no less than annually. Training records retained and available at the premises to any authorised authority on request.

#### **Public Health**

 Details of local taxi firms to be displayed to customers within the main retail area of the premises.

#### Overview:

There now exists a comprehensive raft of Licence Conditions, agreed with the Responsible Authorities, which will design out the issues which you fear and speculate might come were this Licence to be granted. We therefore respectfully request that you reconsider your Representation in the light of the above agreed amendments.

In essence, this application relates to a shared working space for local businesses. As an adjunct to that principal purpose, a Premises Licence is sought regarding:

- (a) a small events room where talks, slide shows and films might be delivered to small audiences of no more than 30 persons at a time. The applicant simply seeks to be able to provide alcoholic refreshment by way of ON Sales in modest quantities to the attendees at such community or business events, and
- (b) the applicant would like to be able to retail locally-sourced, ethically-produced and responsibly-packaged quality and artisan alcoholic products for consumption OFF the premises between 12 and 17:30hrs. No doubt the majority of these sales will be made online and will be for home delivery via courier.

Such a prospect has attracted much support in the area and indeed there are almost as many Representations received which support the venture as oppose it.

We must also take this opportunity to address you on several areas of misunderstanding that have been arrived at perhaps through misleading assumptions or misinformation being circulated widely, and especially through Facebook. In some circumstances these public postings might constitute online bullying and copies have therefore been retained for the information of the Authority.

# The **Key Points of Misinformation** appear to be that:

- 50 persons will attend the premises to socialize and drink at any one time. In reality, the lawful capacity for numbers is set at 30 to each room, when furnished. Incidentally, only one room will be in operation at any given time.
- It has been claimed that the square footage of the premises is 250 square metres. It is actually 90 square metres.
- It is not acceptable to conduct licensable activities within 10 feet of acutely ill
  persons within the wards of the Hospital. In fact the nearest point to any Ward is
  104 feet, and we have no intention of disturbing the peace of any service user of
  or to the Hospital.
- It is planned to hold parties at the premises. The applicant has no such plans as there is no regulated entertainment entailed in the application, and, the 'events' contemplated are artist's talks, small film screenings, book clubs and the like. Indeed, you will note that the applicant has accepted that no vertical drinking will be permitted on the premises.
- Lastly, car parking may be an issue. Although not a Licensing Objective, the applicant is keen to point out that designated parking bays form part of their

property, and in any event they will encourage attendees to walk, cycle or visit the premises for such cultural events using the local park and ride, taxis and public transport provision.

# Conclusion:

In light of all the above further conditions and explanations as to the true nature of the application to be placed before the Licensing Sub Committee at the forthcoming Hearing, we respectfully invite you to take a view as to whether your initial concerns have been adequately addressed in this letter.

In the event that your concerns have been addressed, your fears have been allayed and your expectations have been met, we invite you to withdraw your Representation by contacting the Licensing officer in the case – Mr Ross O'NEIL – who can be emailed at


