THE PREVENTION OF HARM TO CHILDREN

We and many other residents in the immediate area have school age children. We feel that extending the 'licensable activities' in particular 'live and recorded music' up to the boundary of the premises (i.e. outdoors) to 23:00 Monday to Thursday and 24:00 on a Sunday will potentially affect their sleep and preparation for learning.

We have an infant child and a child in primary school who's sleep is already impacted by the noise of the venue.

TO PREVENT PUBLIC NUISANCE

We believe that extending the licensable activities for these hours is not appropriate for the middle of a residential area. Theis increase will likely cause increases public nuisance for the many dwellings and residents of the local area, including our own. This license will significantly impact our wellbeing to enjoy time outdoors and inside our home. The amplified music already played from the venue is clearly audible within our house and impacts out children's sleep. At times we are unable to sit in our garden or socialize with friends without the unwanted intrusion of continuous music from the football club. The potential of this becoming a daily/nightly event is unacceptable. Already there is anti-social behavior from people leaving the venue late at night. Increased disturbance and anti-social behavior is more likely to occur if the hours are extended.

TO PREVENT CRIME & DISORDER Our property line backs onto the Crown Meadow, which is used as playing fields and a children's play park. The addition of 'off sales' would increase the likelihood of people drinking in the park. Frequently, bottles, cans and other litter is thrown over the fence into our garden. This is also likely to increases due to the addition of off sales.
In addition, the potential for disturbance and anti-social behavior in the park would also increase due to adding 'off sales'.
PUBLIC SAFETY

Our objection is not related to the activity of football or local businesses. We are supportive of enterprises in Bridgnorth. Our main issue is the disruption to our children's sleep. We also wish to support local bands in Bridgnorth.

Perhaps, live music extended to the boundary could be reserved for match days (Wednesday and Saturday) at reasonable hours.

We recognize that COVID has affected businesses locally and we wish to support them where possible. Is there potential for a temporary license while the business gets back on its feet?

Generally if there is to be a hearing to determine the premises licence application, the sub-committee will only be able to consider matters that have been previously disclosed. No new evidence can be introduced at the hearing. It is therefore imperative that you detail all matters that you wish to be considered on this initial representation. Please attach additional sheets if necessary.

If you do make a representation you will be expected to attend the Licensing Sub Committee and any subsequent appeal process. All representations in their entirety, including your name and address, will be disclosed to the applicant for the premises licence and any other interested parties. If all parties agree, the application can be dealt with without holding a hearing.
