

REPRESENTATIONS PROCEDURE NOTES

- A representation can be made against an application for a premises to carry on a licensable activity within the 28 day consultation period. Representations can also be made against applications to make variations to an existing licence.
- Representations may be made by:
 - Responsible authorities
 - Other persons
- To make a representation you much complete and send this form to licensing@shropshire.gov.uk. Representations may also be submitted by post to: Licensing Team, Business & Consumer Protection Service, Shirehall, Abbey Foregate, Shrewsbury, SY2 6ND.

<u>PLEASE NOTE:</u> The representation form must be received by the Licensing Team before the end of the consultation period stated on the site notice, newspaper notice and the Council's website, or it will not be accepted. Posted representations not received within a consultation period due to the postal system will be treated as late and not accepted.

- Where a representation is accepted as relevant, the Council will share the
 representation in its entirety with the applicant and their agent. This is to allow them
 an opportunity to consider the issues raised in the representation and discuss possible
 ways to mitigate the objector's concerns with them directly.
- Only in exceptional circumstances will personal details be redacted from representations.
 This will be when the Council considers that there is a genuine risk of intimidation / violence to the persons making representation. Persons making representations who consider this to be a risk should make it clear on their representation and they will be contacted to discuss further.
- At the end of the consultation period, if any representations remain, the name and address
 of persons making representations will be published on the report to the LicensingSub
 Committee, which will be publicly available.

I object to this variation, on the grounds that if the current restrictions are lifted, it would have an adverse effect on the immediate neighborhood, causing a greater public nuisance than that we currently have.

The bar is poorly sighted in the hub of a residential area, affecting a growing number of residents. Experience to date demonstrates a lack of adherence to current restrictions of the license and a lack of respect for neighbors. Indeed, there has been scant regard for neighbors and a somewhat arrogant response to our requests for greater control of patrons; particularly when leaving the premises often at or after 22:30hrs. which means that people are frequently lingering in the vicinity for a further 30 minutes or so. A situation which is always worse following "events", such as parties etc.

We have been reasonable in our requests to deal with this nuisance; first meeting with the Licensee to outline our concerns and then following up with letters (copies attached), which have largely been ignored. Examples of public nuisance and anti-social behavior experienced under the current arrangements, include shouting, obscene language, banging car doors, vehicle headlights, loud voices from groups of people awaiting transport and people smoking outside the premises and by the access gate to our property.

Even during this process Nomad at No 63 are still advertising "walk-ins", against their current permitted activities (see attached). Experience has shown that the licensee has a flagrant disregard for the conditions of their current license and any variation or extension of the existing facility is only likely to exacerbate the situation. Indeed, there is no reason to believe that a variation would be adhered to or make any difference to the way in which this business operates, except to make conditions worse by those most affected.

To be acceptable to the neighborhood, a responsible condition to the License should be that of the current license: A restriction to click and collect and retail sales only and I suggest a small number of events (such as wine tasting) which must be limited; I suggest one per month and specifically to exclude events or functions such as Hen Parties, Birthday Parties and Wedding Showers etc.

- Generally, if there is to be a hearing to determine the premises licence application, the Licensing Sub
 Committee will only be able to consider matters that have been previously disclosed. No new evidence
 can be introduced at the hearing. It is therefore imperative that you detail all matters that you wish to be
 considered on this initial representation. Please attach additional sheet if necessary.
- If you make a representation, you will be expected to attend the Licensing Sub Committee hearing
 and any subsequent appeal process. All representations in their entirety, including your name, address and contact details will be disclosed to the applicant for the premises licence and their
 agent.
- If limited or withheld personal details are redacted from representations, where notice of a hearing is

given to an applicant, the licensing authority is required under the Licensing Act 2003 (Hearings) Regulations 2005 to provide the applicant with copies of the relevant representations that have been made.

I/We fully understand that this representation will be made available to the applicant and included in the Sub Committee's Hearing papers which are publicly accessible documents, and any subsequent appeal court proceedings.

Whilst we offer you our support and wish you well with your business, we feel that we have no option, but to raise this matter again; highlighting that particularly on a warm and pleasant summer evening, when your customers are drawn outside to smoke and drink, we too wish to enjoy our gardens and the outdoors. This we feel is reasonable.


We have agreed with you the limits of what is and is not acceptable at our meeting; when you also agreed to inform us if you were to have a party or larger groups of customers. To date we have had no such notice! Please note however, that any notice does not excuse unacceptable behaviour.

The noisy and boisterous behaviour on Saturday (16 July 21:45 - 22:30), appeared to go unchecked, and the gathering of people awaiting transport immediately outside of the gates (approx. 23:00) was also disturbing.

This immature, selfish and inconsiderate behaviour is completely unacceptable, and we now insist that you take immediate and appropriate steps to ensure that it does not happen again. I also point out the objectives of the Licencing system:

- The prevention of crime and disorder
- Public safety
- The prevention of <u>public nuisance</u>
- The protection of children from harm
