Over the last quarter we made voting recommendations at 2,125 meetings (29,198 resolutions). At 1,475 meetings we recommended opposing one or more resolutions. We recommended voting with management by exception at 93 meetings and abstaining at two meetings. We supported management on all resolutions at the remaining 555 meetings.




