The Inspector wrote to SC on 17 February 2025 to set out concerns about the soundness of the plan. SC issued a letter on 13 March 2025, setting out their intention to withdraw the Plan from Examination. On 17 July 2025 SC’s Full Council made the decision to withdraw the Plan and it was formally withdrawn from examination on 25 July 2025. On 12 February 2025 SC’s cabinet agreed that the evidence base supporting the now withdrawn emerging Plan forms a material consideration in decision making on relevant planning applications, to support the implementation of the presumption in favour of sustainable development. This includes planning applications for new development on sites proposed to be allocated in the now withdrawn Plan.”	<p>Y</p>

Factual errors amended:

- Amended various references from 'Gaskell Road Corner'/'Gaskell Corner' to '**Gaskell Arms junction**' for consistency. All relate to the junction of the A4169 and A458.

- Policy MW21 B(1) – corrected the spelling of Pavillion to '**Pavilion**'.
