A total distance of approximately 89 metres **onto a line** leaving the main road at point C on the Order Map (SJ 3812 1958) running in a general WSW direction on a natural surface to a gate then in a general SSE direction on a natural surface to re join the Definitive line of FP 11 at point B on the Order Map at SJ 3804 1982; a total distance of approximately 105 metres with a width of 2 metres throughout.
