

**NOTICE OF PUBLIC PATH DIVERSION AND DEFINITIVE MAP  
AND STATEMENT MODIFICATION ORDER**

**TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257  
WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53(A)(2)**

**THE SHROPSHIRE COUNCIL (FOOTPATH 11 (PART) PARISH OF GREAT  
NESS) PUBLIC PATH DIVERSION ORDER 2018.**

The above order was made on 17th May 2018. The effect of the order will be to

**divert** the full width of that part of Footpath 11 from point A on the Order Map (SJ 3812 1956) running in a general WSW direction on a natural surface to a stile at point B on the Order Map (SJ 3804 1982). A total distance of approximately 89 metres **onto a line** leaving the main road at point C on the Order Map (SJ 3812 1958) running in a general WSW direction on a natural surface to a gate then in a general SSE direction on a natural surface to re join the Definitive line of FP 11 at point B on the Order Map at SJ 3804 1982; a total distance of approximately 105 metres with a width of 2 metres throughout.

If the order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations or objections which have not been withdrawn will be sent with the order.
