## THE SHROPSHIRE COUNCIL (FOOTPATH 16 (PART), PARISH OF BERRINGTON) PUBLIC PATH DIVERSION ORDER 2018

The above named order made on 6<sup>th</sup> September 2018 by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980, will **divert** 

the full width of that part of Footpath 16, Berrington, from point A on the order map (SJ 5297 0684) where it leaves the County Road, running in a general south westerly direction between the eastern boundary of the site of a new dwelling and a dried up pond then continuing through a small copse to the south western corner of a field at point B (SJ 5291 6676) on the order map at its junction with the remainder of Footpath 16; a total distance of approximately 110 metres; **onto a line** from point C (SJ 5290 0686) on the order map where it leaves the County Road via a pedestrian gate, running in a general southerly followed by south-south-easterly direction following a field edge path on a natural surface to point B (SJ 5291 6676) on the order map at its junction with the remainder of Footpath 16; a total distance of approximately 112 metres with a width of 2 metres throughout.
