Admission to School

When can my child start school?

Our school caters for children between the ages of 3 and 11 (N to Y6). Children may enroll at the school at any time during these years in accordance with the admissions policy.

We have 48 part time places in our Early Years Learning Environment. The Early Years is overseen by the Early Years Teachers. Children can enter the Early Years Learning Environment in the term of their third birthday. If there are more children requiring places than are available, then the criteria as outlined below are applied. It is possible that Government or Local policies may have the effect of reducing this number or altering the age range we can take. You will be given ample warning if this is the case. (See the Early Years prospectus for further details).

Children in England are now entitled to start school in the September following their fourth birthday and must start their education by the beginning of the term after their fifth birthday. Many parents will be happy for their child to start school in the autumn term, but a small number of parents may have concerns that their child might be too young for mainstream school.

Parents of a four-year old child can request that the date their child is admitted to school is deferred until later in the school year or until the child reaches compulsory school age. In order to assist school in making the necessary staffing arrangements, parents wishing to defer their child's entry to school are asked to inform the school as soon as they have been allocated a place. Parents can also request that their child attends school part-time until the child reaches compulsory school age, and/or choose a place at a nursery or other early learning setting if they would prefer. Any parent considering part-time attendance for their child is advised to discuss this with the headteacher as soon as a school place has been allocated. If parents wish to defer for a whole academic year, they should contact Shropshire Council without delay and before 15 January in the natural application year.



Although the Governing Body has responsibility for our admissions we follow the Local Authority admission procedures. A letter from the Local Authority is sent to all parents in the autumn term the year before your child is due to start school with details about the admissions process.

All applications received by 15 January will be considered. Parents will be informed by letter posted on allocation day 16 April if they have been allocated a place for their child. Late applications will also be considered if there are exceptional circumstances, such as a house move or serious illness/bereavement in the family, or if there are still places after all other applications have been considered. Otherwise late applications will be placed on a waiting list and considered at a Review stage after the allocations stage. However, it is in parents' best interests to apply by the closing date.

All schools have an admission limit for each year group based on an admission number. Our present admissions number is 30. Children with a statement of special educational needs which names the school will be offered a place. Where applications exceed the admission limit, places will be allocated according to the following criteria in order of priority:

- Looked after children who are in public care and children who were looked after but ceased to be so because they were adopted as defined in the School Admissions Code.
- 2. Children living in the designated catchment area and who have an older brother or sister at the school on the date they are due to start.
- Other children living inside the designated catchment area and whose homes are nearest to the school. Measured as a straight line in on the map between home and school.
- 4. Children living outside the catchment area and who have an older sibling at the school on the day they are due to start and whose homes are nearest to the school.
- 5. Other children living outside the catchment area and whose homes are nearest to the school. Measured as a straight line in on the map between home and school.
- Children with medical or special circumstances. This will only be considered if parents can provide written medical evidence that Greenacres Primary School is relevant to the medical well-being of their child. In such cases priority may be given above those children who qualify under priorities 2 - 5.

Please note:

A sibling connection is defined as a brother or sister, step-brother or step-sister, half-brother or half-sister, living at the same address as part of the same family unit of compulsory school age (i.e. 5-16 years). Fostered and adopted siblings are also included. Older siblings must be attending the school on the date the younger sibling is due to start there. However, cousins or other relatives who take up residence in a home in order to establish an "in catchment area" address will not be given priority under the sibling criterion.

For admissions purposes all distances are measured as a straight line distance on a computerised mapping system between the home address and the nearest entrance gate of the relevant school by pinpointing their eastings and northings. The shortest distance being given highest priority. Where two addresses are within the same block of flats, the lowest number of flat nearest to the ground floor will be deemed to be the nearest in distance.

In the case of twins or triplets from the same address the school will endeavour to admit both or all siblings.

In the event that two applications are exactly the same after all other criteria have been taken into account a tie breaker will be used. This will be by random allocation and overseen by an independent party not connected with the admissions process.

There is no cost associated with the admissions process to any Shropshire LA maintained schools.

Children offered a place at Greenacres Primary School may start at the time advised by the school according to their date of birth.

Parents will be notified of the decision on the allocation of places by Shropshire Council on behalf of the Chairman of Governors. Should the admission be refused, parents may ask for a review, by writing to the Chairman of Governors at the school, who will refer the request to the Governors Admissions Committee/Review Committee. This Committee will not include the Head teacher and Chairman.

APPEALS:

If the application is still unsuccessful, parents will have the right to pursue their case through an Independent Appeals Panel which will be arranged by Shropshire Council. This procedure has been agreed with the Shropshire Local Authority, and is in accordance with the DfE Code of Practice on School Admissions Appeals. The form required for an Appeal can be obtained via the school. If the appeal for a Reception place is unsuccessful the applicant's name will be kept on a waiting list until the end of the first term of the new academic year. If a vacancy then occurs but there are more than one applicant the place will be allocated in accordance with the admission criteria listed above.

Where parents wish to apply for a school place at a time other than prior to the child starting in Reception, please arrange to visit the school. You will be informed if there are any places available in the child's year group. If there are then arrangements will be made for your child to start. If not then parents should follow the procedure set out in the above paragraph.

If the application is still unsuccessful, parents will have the right to pursue their case through an Independent Appeals Panel which will be arranged by Shropshire Council. This procedure has been agreed with the Shropshire Local Authority, and is in accordance with the DfE Code of Practice on School Admissions Appeals. The form required for an Appeal can be obtained via the school.

We recommend that you read Shropshire LA's publication "Parents' Guide to Education in Shropshire" available from the website www.shropshire.gov.uk/schooladmissions. Hard copies are also available in school and in libraries. Please read this carefully as it contains important information about making a preference for primary schools and the need to consider making more than one preference, in case we cannot meet your preference for this school.

For your information, we liaise closely with Shropshire LA, over the admissions process. Parents are very welcome to view the school prior to their child's admission.
