Shropshire Local Plan Review 'Preferred Sites': Consultation Plan

Overview

The consultation on the 'Preferred Sites' document has been informed by the Council's Statement of Community Involvement (SCI).

The consultation on 'Preferred Sites' is the third significant stage for public and stakeholder involvement in the Local Plan Review. The main objectives of this stage of consultation is to obtain feedback concerning:

- a. A housing policy direction to improve the delivery of local housing needs
- b. Development guidelines and development boundaries for Shrewsbury, Principal and Key Centres and each proposed Community Hub;
- c. The preferred sites to deliver the preferred scale and distribution of housing and employment growth, across the settlement hierarchy, during the period to 2036;

The consultation forms part of the pre-submission stage which is intended to provide an opportunity to comment on the emerging plan in an informal manner. Later stages are more formal and focus on the 'soundness of the Plan.

The SCI identifies the preparation of Preferred Options documents as an optional stage as part of the pre-submission process. The Council are therefore meeting the requirements of the SCI through the preparation of 'Preferred Sites' document.

Consultation Period

The Consultation will run for nine weeks between **Thursday 29th November 2018 and Thursday 31st January 2019.**

Notification

The Council will notify all those currently on the consultee database by e-mail. This represents approximately 4,000 contacts made up of local and national organisations, individuals, parish and town councils, adjoining authorities (including adjoining parish and town councils), statutory bodies (such as the Environment Agency), agents and developers, interest groups, and anyone else who has asked to be included on this list.

The Council will inform Shropshire's Parish and Town Councils via the Association for Local Councils (ALC);

The Council will issue a Press Release shortly before the start of the consultation providing an overview of the consultation and how to get involved. There may be a further opportunity to issue a subsequent press release towards the end of the consultation period to ensure people are aware of the end date.

Viewing the Documents

In line with the SCI and previous successful consultations, this will primarily be a web-based consultation with all consultation material available via the 'Get Involved' section <u>www.shropshire.gov.uk/local-plan-consultation</u> with a link to the consultation documents from the Planning Policy pages.

However, there will also be paper copies of the consultation material and summaries of the supporting documents available to view at the following Council offices during normal office hours:

- Shrewsbury: Shirehall Abbey Foregate;
- Wem: Edinburgh House
- Oswestry: Castle View
- Craven Arms: the Gateway

These documents will also be available to view at all libraries during their normal library opening times.
