

**NOTICE OF CONFIRMATION AND COMING INTO OPERATION OF PUBLIC PATH
ORDER AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER**

**HIGHWAYS ACT 1980
WILDLIFE AND COUNTRYSIDE ACT 1981
THE SHROPSHIRE COUNCIL (FOOTPATH 9 (PART), TOWN OF WEM)
PUBLIC PATH DIVERSION ORDER 2019**

On 23rd May 2019, The Shropshire Council (the "Council") confirmed the above named order made under section 119 of the Highways Act 1980 and section 53A(2) of the Wildlife and Countryside Act 1981. The effect of the order as confirmed is to **divert**

the full width of that part of Footpath 9, Town of Wem, from point A on the Order Map (SJ 5080 2881) where it leaves Bankhouse Lane, running in a general south easterly direction for approximately 94 metres to meet an existing gate at point B on the Order Map (SJ 5072 2877); **onto a line** to be created from a pedestrian gate at point C on the Order Map (SJ 5080 2879) where it leaves Bankhouse Lane, running in a general south-south-westerly direction on a natural surface and alongside a pasture field boundary for approximately 59 metres. From here it turns to continue along the field boundary in a general north westerly direction for approximately 56 metres to meet an existing pedestrian gate at point B on the Order Map (SJ 5072 2877); a total distance of approximately 115 metres with a width of 2 metres throughout.

A copy of the order as confirmed and the order map have been placed and may be seen free of charge at The Shirehall, Abbey Foregate, Shrewsbury during normal office hours or via the Council's website at <https://shropshire.gov.uk/outdoor-partnerships/countryside-access-and-public-rights-of-way/current-public-path-orders/>. Copies of the order and map may be bought from the Council at the above address at the price of £6.50.

Shropshire Council certify that the order becomes operative on 23rd May 2019; but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 23rd May 2019 make an application to the High Court.
