Our staff are our most asset and we want to ensure that all staff feel engaged and motivated so that they can deliver the best possible services to the residents of Shropshire.

It is imperative that staff feel they have a voice and can contribute to improving the way we do things – most often it is the staff on the frontline who know their services and customers the best and how things can be done better to improve the lives of others.

The Council is going through significant transformation changes and an expectation is that our staff will facilitate and engage with the changes. It is recognised that for some individuals this will place an increased perception of pressure. The key for the provider of the Counselling Services is to support employees to move into new ways of working to achieve change and help the employees to find achievable solutions.

The provider will be expected to understand organisational cultures and workplace factors that might impact on their work with us.

The Council wishes to provide employees with short-term counselling when appropriate and to keep employees at work or bring them back to work in a timely and reasonable timescale.
