A total distance of approximately 186 metres <u>onto a line</u> leaving point A on the Order Map (SJ 2732 2109) running in a general ENE, NNE then ENE on a 2 metre wide natural surface path with a central strip laid to stone to point B on the Order Map (SJ 2746 2119). A total distance of approximately 187 metres.
