NOTICE OF PUBLIC PATH ORDER AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER

HIGHWAYS ACT 1980 WILDLIFE AND COUNTRYSIDE ACT 1981

THE SHROPSHIRE COUNCIL (FOOTPATH 79Y, PARISH OF WORTHEN WITH SHELVE AND FOOTPATH 36 (PART) PARISH OF MINSTERLEY) PUBLIC PATH DIVERSION ORDER 2019

The above named order made on 5th September 2019 by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980, will **divert**:

the full width of Footpath 79Y Worthen with Shelve, where it leaves the County Road at point A on the order map (SJ 3448 0621), running in a general south-south-easterly direction along a surfaced driveway passing poultry buildings and then following a field edge path along the eastern boundary of two arable fields in a general south easterly direction and then continues as a cross field path in a general south easterly direction to cross the Rea Brook on the Parish boundary, a distance of approximately 1365 metres. From here the path becomes Footpath 36 Minsterley, and continues for a further 40 metres approximately in a general east-south-easterly direction through a field to point B on the order map (SJ 5580 1250); a total distance of approximately 1405 metres: onto a line to be created where Footpath 79Y Worthen with Shelve leaves the County Road at point A on the order map (SJ 3448 0621), passing through a pedestrian gate into an arable field, running in a general south-south-easterly direction following the western edge of the field along a grassed margin to pass to the north eastern side of poultry sheds following the field edge and south of the buildings the path continues in a general south easterly direction along a farm track passing through a field gate (SJ 3481 0580) and continuing until the path becomes a field edge path in a general easterly followed by south easterly direction to a footbridge across the Rea Brook on the Parish boundary, a distance of approximately 1430 metres. From here the path to be created becomes Footpath 36 Minsterley, and continues for a further 35 metres approximately in a general south-south-easterly direction through a field to point B on the order map (SJ 5580 1250); a total distance of approximately 1465 metres with a width of 2 metres throughout.

If the order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the order.
