## NOTICE OF MODIFICATION ORDER

## WILDLIFE AND COUNTRYSIDE ACT 1981 DEFINITIVE MAP AND STATEMENT OF RIGHTS OF WAY FOR SHROPSHIRE

## THE SHROPSHIRE COUNCIL (FOOTPATH 6 (PART) DELETION AND ADDITION, PARISH OF SELATTYN AND GOBOWEN) MODIFICATION ORDER 2019

The above named Order made on 12<sup>th</sup> September 2019 by The Shropshire Council ("the Council") if confirmed as made, will modify the Definitive Map and Statement for the area by:-

**deleting** that part of Footpath 6 Selattyn and Gobowen from point A on the Order Map (SJ 2880 3335) where it leaves the County Road and runs in a general north-north-westerly direction along a driveway towards The Pines with a hedge to the west. The path diverges from the track and passes through a hedgerow into a field shortly before reaching point B on the Order Map (SJ 2873 3348); a total distance of approximately 144 metres; and

adding that part of Footpath 6 Selattyn and Gobowen from point C on the Order Map (SJ 2879 3335) where it leaves the County Road and runs in a general north- north- westerly direction along the access drive to Laurel House with a hedge to the east, with a width of 1.5 metres. It continues in the same direction between a garage and a hedge where it has a width of 1.5 metres which narrows to 1.2 metres at the northern end of a wood store. The path then continues to follow the hedge boundary through the garden with a width of 1.5 metres. It then passes through a boundary gate (SJ 2876 3343) and runs as a field edge path with a width of 1.8 metres to point B on the Order Map (SJ 2873 3348); a total distance of approximately 144 metres.

A copy of the Order and the Order map may be seen free of charge at the Council offices at The Shirehall, Abbey Foregate, Shrewsbury during normal office hours. Copies of the Order and map may also be bought from the Shropshire Council at the above address at a price of £6.50.

Any representation or objection relating to the Order must be sent in writing to Rights of Way Mapping and Enforcement Manager, Shropshire Outdoor Partnerships, The Shirehall, Abbey Foregate, Shrewsbury, SY2 6ND or by email to <a href="mailto:outdoor.recreation@shropshire.gov.uk">outdoor.recreation@shropshire.gov.uk</a> not later than 25<sup>th</sup> October 2019 and you are requested to state the grounds on which it is made.

If no representations or objections are duly made to the Order, or to any part of it, or if any so made are withdrawn, the Council, instead of submitting the Order to the Secretary of State (or part of it if the Council has by notice to Secretary of State so elected under paragraph 5 of Schedule 15 to the Wildlife and Countryside Act 1981) may itself confirm the Order (or that part of the Order). If the Order is submitted to the Secretary of State for the Environment, Food and Rural Affairs in whole or in part, any representations and objections which have been duly made and not withdrawn will be sent with it.
