

# Privacy notice – Risk & Insurance

## Who we are?

Shropshire Council is the local government authority for Shropshire. Our address is: Shropshire Council, Shirehall, Abbey Foregate, Shrewsbury, SY2 6ND. ## How do we collect information from you?

We collect information from you when you visit the Shropshire Council website also when you contact us in writing, speak to us on the phone, by email or any other type of electronic communication, or talk to us face to face.

## What types of information do we collect from you?

We collect different categories of information about you, depending on the service you want from us and/or the reason why we need to process information relating to you. This could be personal information (for example your name and address), or other more sensitive data that we would only collect and use in very particular circumstances that are set out in law.

## Details of information obtained from third parties?

- If your claim involves an injury, we will require information from your Doctor and specialists to investigate your claim fully.
- If your claim involves a council contractor then we will require sight of any information that they may hold on you in order that the claim can be investigated fully.

## How is your information used?

We may use your information to:

- assess your entitlement for any claim you have submitted,
- process payments or charges,
- carry out our obligations arising from any contracts entered into by you and us,
- notify you of changes to our services,
- send you communications which you have requested and that may be of interest,
- fulfil our legal obligations under Common Law to process liability claims fairly which will include our obligation to process personal data,
- investigate possibly fraudulent claims.

## Research and statistics

Anonymised and pseudonymised data may be used for research & statistical purposes. Any data collected may be used for research and statistical purposes that are relevant and compatible with the purpose that the data was collected for.

## Who has access to your information?

We may share your information with the following third parties for the reasons detailed;

- Insurance Claims Handlers – Within the terms of the council's insurance policy liability claims are to be handled by insurer's appointed claims handlers. Information is shared with them in order that they can fully investigate the claim and come to a decision regarding liability.
- Insurance Company – the council's insurers will have sight of the information in order that their Underwriters can come to a decision on liability when required.
- Solicitors – when a claim is litigated the Council will appoint a firm of solicitors and they will require sight of all documentation in order for them to represent the council appropriately.
- Internally with Service Areas for whom the claim is against in order that they can provide supporting documentation to allow full consideration of the claim. This may include payroll, HR and occupational health dependent on the type of claim.
- Statutory agencies, such as the Police, National Fraud Authority – We may share your information with statutory agencies in line with our legal obligations and/or in completion of our public tasks.
- Other Insurers where we have a duty to protect the public purse from fraudulent claims.

We will not sell or rent your information to third parties. We will not share your information with third parties for marketing purposes.

## What are your rights in relation the personal data we process?

**Access** – you can request copies of any of your personal information that is held by the Council.

**Rectification** – you can ask us to correct any incorrect information.

**Deletion** – you can ask us to delete your personal information. The Council can refuse to delete information if we have a lawful reason to keep this.

**Portability** – you can ask us to transfer your personal data to different services or to you in some circumstances.

**Right to object or restrict processing** – you have the right to object to how your data is being used and how it is going to be used in the future.

**Right to prevent automatic decisions** – you have the right to challenge a decision that affects you that has been made automatically without human intervention, for example an online form with an instant decision.

## How long will we keep your information for?

We keep and dispose of all records in line with our corporate retention schedule. We will comply with Data Protection legislation in regards to how long we keep your data.

## **What security precautions in place to protect the loss, misuse or alteration of your information?**

We are strongly committed to data security and will take reasonable and appropriate steps to protect your personal information from unauthorised access, loss, misuse, alteration or corruption. We have put in place physical, electronic, and managerial procedures to safeguard the information you provide to us. However, we cannot guarantee the security of any information you transmit to us. We recommend that you take every precaution to protect your personal information.

## **Keeping your data up to date**

We want to ensure any information we hold is accurate. You can help us by promptly informing us of any changes to the information we hold about you.
