



Dangerous Wild Animal Procedure Notes

- Fill the application form in and send to the Licensing Team (office address detailed below).
- Enclose the fee (see the website www.shropshire.gov.uk) (this does not include the Veterinary Surgeon's fee for the required inspection).
- An acknowledgement letter and receipt of payment will be issued.
- You will be contacted by a Veterinary Surgeon to arrange the necessary inspection.
- Once the Council have received the report and invoice from the Veterinary Surgeon, you will then be sent a letter requesting the outstanding vet's fee.
- On receipt of this fee, and providing everything is satisfactory, the licence will then be issued.
