

# Privacy notice – Joint Training

## Who we are?

Joint Training is the adult social care and health training team within Shropshire Council. Shropshire Council is the local government authority for Shropshire. ## How do we collect information from you?

We collect information from you when you visit the Shropshire Council website, also when you complete a Joint Training application form, contact us in writing, speak to us on the phone, by email or any other type of electronic communication, or talk to us face to face.

## What types of information do we collect from you?

We collect different categories of information about you, depending on the service you want from us and/or the reason why we need to process information relating to you. This could be personal information (for example your name and address), or other more sensitive data that we would only collect and use in very particular circumstances that are set out in law.

## Details of information obtained from third parties?

We may receive information about you from your employer in order to book you onto one of our training courses. This would be your first name, last name, job role, place of employment.

## How is your information used?

We may use your information to:

- Provide a training service to you
- process payments or charges,
- carry out our obligations arising from any contracts entered into by you and us;
- notify you of changes to our services
- send you communications which you have requested and that may be of interest

## Research and statistics

Anonymised and pseudonymised data may be used for research & statistical purposes. Any data collected may be used for research and statistical purposes that are relevant and compatible with the purpose that the data was collected for.

## Who has access to your information?

We may share your information with the following third parties for the reasons detailed;

Provide details of any third parties that you share data with

- Your employer to provide them with details of training attendance and non-attendance for employment purposes.
- An external trainer to enable them to provide training on our behalf and to make any required adjustments to enable your access to training
- Crisis Prevention Institute for purposes of certification of MAPA® training courses and registration of MAPA® certified instructors
- Mental Health First Aid England for purposes of evaluation and certification of Mental Health First Aid England training courses
- Talking Mats Ltd for the purpose of registering the delegate as a registered Talking Mats user
- Herefordshire and Ludlow College for purposes of registration and assessment for the End of Life Care Awards
- Internally with other Shropshire Council departments to enable them to provide training on our behalf and to make any reasonable adjustments to enable your access to training.

We will not sell or rent your information to third parties. We will not share your information with third parties for marketing purposes.

### **What are your rights in relation the personal data we process?**

**Access** – you can request copies of any of your personal information that is held by the Council.

**Rectification** – you can ask us to correct any incorrect information.

**Deletion** – you can ask us to delete your personal information. The Council can refuse to delete information if we have a lawful reason to keep this.

**Portability** – you can ask us to transfer your personal data to different services or to you in some circumstances.

**Right to object or restrict processing** – you have the right to object to how your data is being used and how it is going to be used in the future.

**Right to prevent automatic decisions** – you have the right to challenge a decision that affects you that has been made automatically without human intervention, for example an online form with an instant decision.

### **How long will we keep your information for?**

We keep and dispose of all records in line with our corporate retention schedule. We will comply with Data Protection legislation with regards to how long we keep your data.

### **What security precautions in place to protect the loss, misuse or alteration of your information?**

We are strongly committed to data security and will take reasonable and appropriate steps to protect your personal information from unauthorised access, loss, misuse, alteration or corruption. We have put in place physical, electronic, and managerial procedures to safeguard the information you provide to us. However, we cannot

guarantee the security of any information you transmit to us. We recommend that you take every precaution to protect your personal information.

### **Keeping your data up to date**

We want to ensure any information we hold is accurate. You can help us by promptly informing us of any changes to the information we hold about you.

There are no automated decision processes in Joint Training.
