

**NOTICE OF PUBLIC PATH DIVERSION AND  
DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER**

**HIGHWAYS ACT 1980  
WILDLIFE AND COUNTRYSIDE ACT 1981**

**THE SHROPSHIRE COUNCIL (BRIDLEWAY UN1 (PART), PARISH OF  
CHESWARDINE)  
PUBLIC PATH DIVERSION ORDER 2020**

The above named order made on 5<sup>th</sup> November 2020, by the Shropshire Council (“the Council”) under section 119 of the Highways Act 1980 and section 53A(2) of the Wildlife and Countryside Act 1981, will **divert** part of BW UN1 from Point A (SJ 7448 3180) on the order map running in an easterly direction along the access to Lipleigh Heath Farm continuing to run through the yard, through some gates to point B (SJ 7458 3181) on the order map. A total distance of approximately 98 metres. **Onto a line** Point C on the order map (SJ 7448 3182) from the County Road at a bridleway gate and passing into a pasture field and running in an easterly direction, south easterly then easterly direction across the field to point B (SJ 7458 3181) on the order map at a bridleway gate. A total distance of approximately 105 metres, with a width of 3 metres throughout.

If the order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the order.
