RE CLIVE VILLAGE - Plan is unsound because:
Outdated historical information has been used by Shropshire Council to determine that Clive meets the criteria for Community Hub designation. The current and actual level of facilities now fall below the criteria. We do not want further large scale development in Clive.
The village infrastructure cannot cope with increased traffic flow proposed new development plans will bring a significant increase in traffic flow over roads unsuitable for current levels of traffic.
Not only do 3 of the access roads to the village regularly flood, leaving only one narrow steep single file lane passable (Mine Bank!), all access roads are too narrow in several places for 2 vehicles to pass, requiring much reversing of vehicles. I can provide a film of a recent incident near the Preston Brockhurst junction involving the village bus.
If 60 extra cars (2 for each proposed home) are regularly using the village roads, this will cause gridlock in the village at commuting times and could result in queues of traffic backing up at the various pinch points, including the steep and sharp bends near the Preston Brockhurst junction with the A49, on a regular basis. Also, many cars are frequently parked in the village so that walkers can access Grinshill, further adding to the congestion.
