Also, I am concerned that this document was drawn up pre- Covid-19 with all its implications regarding changes in the economy, changes in commercial building use (so much of it could be converted into housing!) and changes in local transport needs. And there is little regard to the commitment to carbon reduction.										
I think we need a pause. We need at least a year before any hard and fast decisions are made so that the repercussions of this last year are more clear. Please do not be hasty.
