**The Town Council is disappointed that its request submitted in response to the regulation 18 consultation for the development boundary on Mill Street to be amended has been ignored and would request again that this amendment is included in the Local Plan.**

**Regulation 18 response ref Development boundary – Mill Street**

in light of the latest refusal of a planning application by the Planning Inspector to develop land near the Mill on Mill Street the Town Council consider that the development boundary should be amended to run parallel with Mill Street from Roden Weir alongside the western edge of the pavement on Mill Street to the Mill House.
