The village shop/convenience store was marketed, without success, for several years before the recent tenant took it on. They decided not to continue after less than 12 months. The owner of the property has reasonably concluded that it is not a 'going concern' and is not remarketing the property.

Neither of these events is Covid related and neither appears likely to change its status in the near future.
