The proposal to release green belt land adjacent to the Cleckars to provide for 35 new dwellings is unsound and fails to comply with the duty to co-operate. In the Parish Council's response to the Regulation 18 Pre-submission draft of the Local Plan it was clearly stated

"The Parish Council would prefer this site (ALV009) to be retained within the green belt; there are ecological and hydrological issues with the site which Councillors feel have not adequately been taken into account".

The Parish Council's view on this proposal has hardened as a result of the recent plan to construct up to 100 park homes on the Butts Caravan site in Alveley. Although this may not be legally relevant in planning terms, it will create additional problems for local services and argues against proposed housing developments elsewhere in the Village, especially on green belt land at the Cleckars site.

SHROPSHIRE LOCAL PLAN - REGULATION 19, PRE-SUBMISSION DRAFT

I am writing to inform you of the Parish Council response to the Regulation 19, presubmission draft of the Local Plan. I attach the representation forms which you provided. The purpose of this letter is to articulate the view of the Parish Council in a manner which your forms do not allow. In view of recent developments in Alveley, Councillors are very confident that the comments set out below are representative of local opinion, and expect Shropshire Council to value them accordingly.

Councillors and residents accept the designation of Alveley as a 'community hub'. However, they consider that this commits Shropshire Council to work with the Parish Council and local residents to achieve much needed improvements in infrastructure. It is also essential to recognise that Alveley remains a **rural** community, and that it will only prosper if existing facilities and services, such as the public bus service, are retained and, where possible, improved.

The Parish Council considers that the amount of green belt land which is identified for development during the Local Plan period is excessive. The recent Housing Needs Survey confirms that this is the view of local residents. The Parish Council is disappointed that the initial proposal to build 35 dwellings in the Green Belt at the Cleckars has not been removed. Our opposition to this proposal has hardened as a result of the recent plan to construct up to 100 park homes on the Butts Caravan site in Alveley. Although this may not be legally relevant in planning terms, it will create additional demands on local facilities, and argues against proposed housing developments elsewhere in the Village, especially on green belt land such as the Cleckars site. The Parish Council would prefer this site to be retained within the green belt; there are ecological and hydrological issues with the site which Councillors feel have not adequately been taken into account.

For the same reasons, the Parish Council can no longer support the proposal to safeguard an area of green belt land north of the Alveley development boundary to meet

future development need. Finally, we reiterate that Shropshire Council must recognise the importance of infrastructure improvements to accompany any future housing development and to justify Alveley's proposed status as a community hub.
