There were 2 parish councillors on the working group that developed this plan and I am concerned that the Parish Council are aiready taking as read that this Communlty Hub is a given - they should not be taking this opinion.
Moving onto the way in which Cross Houses has been selected for Community Hub status I would make the following points The proposed Hub status is based on a points system and there are several areas of contention in the scoring of services, faclitites and employment for Cross Houses.

1. Cross Houses had points awarded for having a Library - in the context of the scoring system, called the Hierarchy of Settlements Assessment Document, Hbrary refers to a statle permanent fixture as are all other facilities mentioned.
A mobile Ilbrary which visits twice a month for 25 minutes each time does not constltute having a library which people could, if required, visit daily for leisure or research purposes. A static library is not mentloned in the Herarchy of Settiements Assessment Document and appears to have been added speclifically to qualify.
2. Childiren's Playground - single provision only not muliple as stated
3. Amenity Green Space - single provision only not multiple as stated
4. Outdoor sports facility - which I presume ls a playing fleld - which is not owned by the Parish and which is Just really a fleld and which has over the last 3 months November 2020 - January 2021 been regularly flooded.

I would request that the Inspector at the forthcoming Public Inquiry comes and inspects these facilites to determine If this polnts scoring assessment by Shropshire Councll is approprlate.
Should tt be found that a deduction of points is required to be made I belleve that Cross Houses would then remain as Open Countryside status which 1 assume will last for at least 20 years and wil mean that no further large scale housing developments will occur within or around the village.

[^0]:    I am concerned about the signlficant level of housebuilding that has recently taken place in Cross Houses. Whilst the Locat Plan currently does not allocate any significant new housing settlements to Cross Houses it none the less still deffines it as a Communlty Hub, thus aflowing the possibility of future development in the next fow years when a 'refresh' to the Local Plan takes place.
    I want Cross Houses to remain as Open Countryside and not be designated a Community Hub so ensuring that no slgnificant housing development will be allowed to take place for the life span of thls Local Plan.
    The residents of Cross Houses have had to put up with large housebullding sites for severat years with all the problems this entalis such as Increased traffic, particulariy construction traffic noise and housing being bulft on previously arable countryside. I belleve that the majority of resldents in Cross Houses do not want any more large scale development of their viltage.
    A full scaie needs survey needs to be undertaken of our village so that the community can understand just exactily what it is that that the viliage wants. Untll this is done lam not sure how Shropshire Council Planning Department can understand what is right for our viltage. Recently the Partsh Councll sent out a Community Led Plan questionnaire. Nowhere on this consultation document did it state that Cross Houses is stlli classifted as Open Countryside and It did not ask a fundamental question of the reciplents as to whether they would prefer to rematn Open Countryside and hence have the option of not having to accept any further large scale developments. Not only this neither did this questlonnaire ask a more basic question of whether or not residents wanted any more housing In thelr vilfage.
    I would ask that the Inspector at the Public Inquiry specifically looks Into this issue and asks the Parish Councli why they chose not Inform the communty of this fact and why spectfic questlons regarding housing were omitted from thls survey.
