This status would enable developers to move in and desimate our lovely countryside with the building of housing estates, causing major disruption in the process, resulting in it no longer being classified as a small village – this is in line with section DP24 of the Regulation 19 document.

The amenities are in keeping for the current population of Cressage, but would nore be adequate for future developments.

For these reasons I oppose Cressage becoming a community hub.
