My wife and I moved to Cressage a number of years ago with the sole purpose of being in the countryside with limited dwellings surrounding the village.

I am not against appropriately sized developments in Cressage, however the proposed size of development in the local plan, will not only change the landscape of the village but have a negative impact on our fragile infrastructure (the school, the medical practice and the roads) and I strongly feel that this has not been fully considered.

In addition to this, I feel that the planning process in particular has not been complied with, for the following reasons:

The allocation of points for specific services within Cressage, such as the library, pharmacy, church, etc. have been grossely biased towards increasing the points in favour of the planners rather than the village.

Lack of feedback on the consultation, so we are still unaware of the facts as to why certain decisions have been made.

We understand that there has not been a full count of the consultation responses due to lack of resources at Shropshire Council.

In view of the above, I strongly feel that cresasage should remain as open countryside.

We ask the Independent inspector to review Shropshire Councils consultation process during Covid-19 and the obvious impacts that has had on preventing people from replying.
