Alveley has accepted levels of appropriate development over recent years. The Parish Plan Group undertook a local housing needs survey which highlighted affordable housing and bungalows with some open market housing as the priorities for the Parish.

Shropshire Council has SPDs and planning policy which would allow for the known needs of the settlement to be delivered within the current framework. Alveley has one development where open market housing sold at below market price has been used by the developer to subsidise affordable rented properties on site. There is a further site which is in the Green Belt which has now been granted permission for affordable housing including bungalows on the same principle under Shropshire Council's current planning policy, which has worked well.

A residential caravan/park homes site for potentially over 100 units is currently being developed just outside the development boundary of Alveley.

I would welcome the removal of the above allocation and further adjustments of housing numbers to reflect an understanding of the increased developments which have taken place since this plan started its journey.

The village has also lost a full time Post Office and has limited Post Office provision in the community. The Post Office continues to support an outreach service, which is valued by our community.

There is no weighting adjustment for changes in local business/services such as the Post Office or the increased pressures on infrastructure due to significant development in the Parish.
