Clive is listed as having 54 points by Shropshire Council. However, there is sadly no longer a convenience store (4 points) or outdoor sports facility (3 points) within the village. Consequently, Clive's points score is 47. Although The Village Store has only closed recently (October 2020) there has been no outdoor facility since Sept/Oct 2018 when the Village lost its Bowling Green at Clive Hall due to change of ownership. By Shropshire Council's own criteria Clive does not meet the points score to be a Community Hub (48 points). It cannot be justified to class Clive as a Community Hub when Clive falls below the threshold for Community Hub designation.
