My concerns are specifically concerning SHR173. The information on page 22 of Appendix Q is incorrect - specifically the "within 500 metres Special Area of Conservation" criteria. The North East segment of SHR173 is within a few metres of the SSSI.

I sincerely hope the SSSI (Site of Special Scientific Interest) not being treated as as a special area of conservation is a genuine mistake (the clue is in the title). Building additional houses in this area is clearly going to have a huge impact on the wildlife & conservation requirements.

If housing was to go ahead, it would need to be focused on the central southern areas of SHR173. 450 houses seems excessive when considering the impact on local environment & CO2 emissions from those additional families
