I think Cressage should remain Open Countryside and should not be considered a Community Hub. The residents have voiced their concerns about this many times and have been ignored by the Parish Council. This consultation process has been riddled with problems from the beginning and has been exacerbated by Covid 19. No public consultation events have been held. This would have helped Cressage residents to form an opinion and gather all the facts.

At no point have residents been given a proposed layout for the sites to be developed. One of Shropshire Council's objectives is to provide affordable housing. By becoming a Community Hub, Cressage would be exposed to large scale housing developments and no specific requirements to meet the needs of local people or affordable housing. As a young person in the village, I am concerned about the lack of affordable housing in the area.

There has been a lack of communication throughout this process and it is very concerning as it has a direct impact on my future in the area. Considering the impact COVID 19 has had on

so many other processes, I think Shropshire Council should delay a decision and open the consultation up to the public for a fair and democratic process.

I ask that the Independent inspector reviews the Countryside Charitys objections and responses and considers them in depth.

I ask the Independent inspector to review Shropshire Councils consultation process during Covid19 and the obvious impacts that has had on preventing people from replying.
