Unsound – Both these sites WHT037 and WHT044 were not included in the original Local plan which was not signed off within the original time frame. Therefore why have the areas, which were originally deemed too wet and prone to flooding, now been considered for development. Shropshire Council do not appear to insist that Developers in Whitchuch build sufficient and robust infrastructure to mitigate the risk of flooding in areas where development occurs. There have been serious sewage issues at The Brambles and The Mount estate off the Tarporley Road. Development should not be allowed to take place when it causes increased run off and flooding of existing properties, as has occurred on Chester Road, as a consequence of Oak Tree Way and The Beeches being built. By the time these issues occur, the developers have moved on and no one appears to be held to account. If Shropshire Council insisted on sufficient infrastructure being built to deal with the excess water, the developers may consider the project uneconomically viable.
