The Apley Estate is supportive of the aim of the policy and fully endorses the benefits a Council endorsed Whole Estate Plan can have for the future of those living and working within the rural areas of Shropshire.

However, the Apley Estate has some concern over how the requirement for public consultation is addressed within the policy and explatory test. It should be noted that the Apley Estate supports the need for public consultation on Whole Estate Plans, without which, the degree of weight they could attract in the planning process would be limited.

It is considered that as it stands, criterion c) of Policy SP15 is open to interpretion as to what "meaningful public consultation means" and no guidance is provided within the explanatory text.

The policy should recognise that not all Whole Estate Plans will be equal in terms of scope, detail and nature of the strategy proposed. For example, some Plans may put forward aspirations for new, large residential developments whereas others may focus more upon sustainable management of the existing built environment and countryside. The Apley Estate consider that the level of public consultation any Whole Estate Plan should go through, should reflect and be proportionate to the nature of the plan and the level of detail contained therein. Whilst consultation with the residents on reside on land owned by the Estate is reasonable it is not considered wider public consultation would be reasonable or appropriate. As such, the policy should be amended and further guidance provided within the explanatory text.

To provide clarity, we consider the policy explanation should be updated to reflect this change:

With regard to public consultation, it is recognised that not all plans will contain equivalent levels of detail and may focus upon different aspects of setting out and delivering their long-term vision. As such, the nature and scope of any public consultation should be tailored to reflect the nature of the Whole Estate Plan. This should be agreed with the Local Planning Authority prior to the consultation taking place.
