RE: Shropshire Council Local Plan - Regulation 19: pre-submission draft of the Shropshire Local Plan Consultation – CRA015. North of Clun Road, Craven Arms.

I am writing in response to the consultation for the Shropshire Strategic Land Availability Assessment, with regards to land adjoining Watling Street, Craven Arms belonging to our clients Nick Challenor, Catherine Evans and Elizabeth Williams. This site is currently an agricultural field located to the north of Clun Road, Craven Arms, ref. CRA015.

We are pleased to note this site has been identified as a 'Long Term Potential SLAA Residential Site' within the consultation. This finds the site to have no significant constraints but has future potential. I am writing as we believe this land can be considered for short term potential due to the following:

Availability

Nick Challenor, Catherine Evans and Elizabeth Williams have the benefit of full title to the land and are willing to make it immediately available for development. The adjoining land to the northern boundary has recently been developed for residential use and this site (CRA015) has received interest from developers.

Deliverability

We can confirm this is a fully deliverable site with an area of 0.87 ha. We believe this site is suitably placed to provide development in the Key Centre of Craven Arms to contribute towards the target of 500 dwellings by 2038, being situated with good access to Watling Street and situated between recently developed land to the north and established developed land to the south creating a natural infill site. The land has the benefit of being fairly flat and not situated within a flood zone, unlike much of the flat land surrounding Craven Arms which has a high flood risk.

We believe the development boundary for Craven Arms should include this site as well as the recently developed land to the north as recently developed by the South Shropshire Housing Association. Within a scheme, a wooded landscape would be planted to emphasize the boundary for residential development in Craven Arms.
