<p>The settlement boundary of the town has been amended to accommodate the allocations WHT037 and WHT044 along Chester Road which form a logical extension to the settlement.</p> <p>The site lies off the B5395 which was formerly a A41 trunk road linking Whitchurch to Chester. The highway network is capable of accommodating the development</p> <p>However the position of the site access should not prejudice the longer term development of site WHT043 on the opposite side of the B5395. Ideally the 2 sites would be accessed from a roundabout which would also provide traffic calming on the B5395 leading towards the town centre.</p> <p>It is requested that the Development Guidelines be amended to ensure the land to the west is not sterilized.</p>
