

I object to the smaller field directly behind the rear gardens of 1-14 Moors Bank being included in the plans. This is due to residents using this field for recreational walking to access the right of way paths, to walk to the canal, for many years. Access is also needed to our rear gardens, for purposes such as large machinery, due to narrow access at the front. If this field is developed for residential housing, it will have a detrimental impact on our quality of life, as we as a family spend large amounts of time in our garden. Our garden is a safe place for our children to play and enjoy the outdoors, especially during the Covid-19 Pandemic, where our gardens and fields are the only means to exercise and ensure wellbeing of mental health. This would no longer be the case, if this field is included as a site for residential development, as we'd be living next to a building site, and then being overlooked by housing, with no access to the right of way paths to the canal, and no access to our rear garden.
