Relaxing the requirement for Hubs to have both 'significant employment' and 'peak time public transport' makes the Hierarchy of settlements unsound. This is also contrary to the proposed Climate Change and Sustainability Objectives SO5, SO6 and SO12 which seek to reduce carbon emissions by reducing travel by private vehicles making it unsound.					
The adding of the vague and undefined phrase 'a larger range' of services and facilities to compensate for the lack of these facilities is subjective. This is contrary to the Hierarchy of Settlements attempt at objective compasison between settlements.					
The scoring system used in Table 10 is flawed and inaccurate making the threshold dubious. It is not an appropriate or robust assessment which makes it unsound. As the SP2 Strategic Approach para 6 relies on this it is therefore also unsound.
