Divert the full width of that part of Footpath 9 leaving Mickley Lane at point A on the Order Map at GR SJ 6237 3198 running in a general southerly direction over two grass paddocks to point B on the Order Map at GR SJ 6235 3188. A total distance of approximately 106 metres **onto a line** running from Mickley Lane at a stile at point C on the Order Map at GR SJ 6236 3200 running in a general southerly direction on a natural surface to a stile then continuing along a stoned track to a further stile then south easterly direction on a natural surface to re-join the Definitive line of FP 9 at point B on the Order Map at GR SJ 6235 3188. A total distance of approximately 122 metres with a width of 2 metres throughout its length.
