

**NOTICE OF PUBLIC PATH DIVERSION AND DEFINITIVE MAP
AND STATEMENT MODIFICATION ORDER**

**TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257
WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53(A)(2)**

**THE SHROPSHIRE COUNCIL (FOOTPATH 39 (PART) PARISH OF CONDOVER)
PUBLIC PATH DIVERSION ORDER 2021.**

The above order was made on 19th November 2021. The effect of the order will be to

Divert the full width of that part of Footpath 39 leaving a pedestrian gate at point A on the Order Map GR SO 4775 0283 running in a general south westerly direction on a natural surface to point B on the Order Map GR SO 4772 0274. A total distance of approximately 96 metres **onto a line** from a pedestrian gate at point A on the Order Map GR SO 4775 0283 running in a general south then south westerly direction on a natural surface then crossing the access drive and continuing in a general south west then southerly direction alongside the access on a tarmac surface. The footpath then continues in a general south westerly then SSE direction on a natural surface to point B on the Order Map. A total distance of approximately 121 metres with a width of 1.8 metres throughout
